

PANGS' Interview in SCMP Shares Ambitious "Belt & Road" Strategic Development Plan

The Accomplishments of AAI's Development in 2017





集團採取多元化的業務發展策略,2017年業務上更有突破發展,而中期業績整體亦表現穩建,截至2017年9月30日止之總營業額為38.5億港元,純利為7,130萬港元,上升61.2%。現在重溫過去一年的大事回顧:

- 2016年12月: 彭氏家族以每股HK\$1.08回購集團股份,重新成為控股股東;
- 2016年12月:集團成功以合營形式投得土木工程拓展署一份為安達臣道石礦場用地發展進行土地平整及基礎建設工程的工程合約,價值約26億港元;
- 2017年4月:新業務英倫皇家保管箱有限公司於上環的服務中心正式開幕,提供全天候高端保管箱租賃服務;
- **2017年7月**:集團與中國葛洲壩集團股份有限公司的 附屬公司訂立一份戰略合作協議,合作開發與建設 「一帶一路」沿線國家大型基建工程項目;
- 2017年7月:集團與獨立第三方訂立協議,出售住宅項目「菁雋」的權益;
- 2017年8月:集團推出為期十年之受限制股份獎勵計劃,授出共30,896,000股受限制股份授予符合相關條

- 2017年8月:集團首次進軍菲律賓市場‧與馬尼拉水 務公司簽訂合同‧為諾瓦利切斯Balara四號輸水隧道 提供設計及建造工程‧合約為期四年‧總值約8億港 元‧奠下成功受惠於一帶一路倡議的重要一步;
- 2017年9月:新業務俊穎通有限公司營運的全港首個網上建材採購平台投入運作,以最優惠價格提供 24 小時簡易網上採購建築材料服務;
- 2017年10月: 併購吳淦記建築有限公司部分股權並作 為其戰略股東·透過吳淦記的網絡及平台開拓澳門市 場。

Diversification is the aim of the Group's business strategy and, remaining steadfast to it, the Group achieved significant breakthroughs in 2017. It's interim results for the six month ended 30 September 2017, reporting overall steady performance with total revenue reaching HK\$3.85 billion and net profit up by 61.2% to HK\$71.3 million. Some of the major accomplishments are:

- **Dec 2016:** PANGS bought back shares of the Company at HK\$1.08 each, becoming the controlling shareholder;
- Dec 2016: The Group won an approximately HK\$26 billion worth site formation and infrastructure works contract for the Anderson Road Quarry Site Development Project;
- Apr 2017: The new business Royal England Safe Deposit Box Ltd opened its service centre in Sheung Wan to provide all-year-round premium quality services to customers;
- Jul 2017: The Group signed a strategic cooperation agreement with China Gezhouba Group International Engineering Co., Ltd to conducting joint project development and construction of large infrastructure projects in the countries along the "Belt and Road";
- **Jul 2017:** The Group reached agreement with an independent third party to dispose the residential project "T-Plus";
- Aug 2017: The Group launched a 10-year restricted share award scheme, granting a total of 30,896,000 shares of the Company to eligible staff members;
- Aug 2017: The Group made the first mark in Philippines and signed an approximately HK\$800 million 4-year contract with Manila Water Company for "Design and Construction of the Novaliches-Balara Aqueduct" in the Philippines, which is an important step towards benefiting from 'Belt and Road';
- **Sep 2017:** The Group's new business Joy Smart Commerce Ltd started operating Hong Kong's first online construction materials purchasing platform, providing 24-hour one-stop construction materials purchasing service at the most competitive prices;
- Oct 2017: Acquired equity interest in Ng Kam Kee Construction Co., Ltd in Macau and became its strategic shareholder, securing leverage from Ng Kam Kee's network and platform to develop the Macau market.
