集團於去年成立的俊和巴士服務有限公司(俊和巴士),於今年4月1日正式投入服務。俊和巴士以經營本地路線為主,提供多項非專營巴士服務,包括學童巴士、居民巴士、穿梭巴士及場地接送等服務。另外,隨著兩大跨境基礎設施建設,包括港珠澳大橋和高鐵竣工,往來香港旅遊的需求不斷增長。集團會把握此機遇,未來將致力拓展巴士服務至中港跨境路線,以進一步多元化集團的收入來源及業務組合。



CW Bus focuses on local routes, providing a number of the non-franchised bus services, including school bus, resident bus, shuttle bus, and venue transfer services, etc. In addition, after the completion of two major cross-border infrastructure projects, namely the Hong Kong-Zhuhai-Macao Bridge as well as the High Speed Rail, there is an increasing traveling demand to and from Hong Kong. The Group will



seize this opportunity and strive to expand the cross-border routes between China and Hong Kong in the future to accommodate market needs, and further diversifying the Group's revenue stream and business portfolio.
