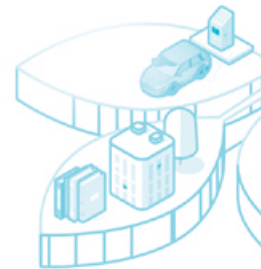
Lifewire 10th Anniversary Gala Dinner

The Gold Award goes to PolyU’s project “Renewable Material Coagulant” leverages industrial by-products to produce a low-carbon solidifying agent as a replacement for traditional cement in ground

stabilisation. The project achieves more than 80% carbon emission reduction and offers a revolutionary alternative for green construction and land rehabilitation. Chun Wo will continue to inspire creativity and provide young engineers with opportunities to innovate and bring their ideas to life.

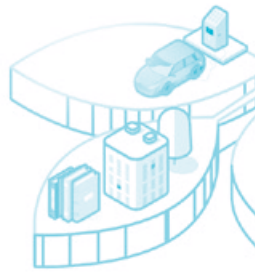
Chun Wo Tunnel Assumes Operation of Central Kowloon Bypass (Yau Ma Tei Section Tunnel)

Chun Wo Tunnel Management Limited assumes responsibility for the management, operation, and maintenance of the Central Kowloon Bypass (Yau Ma Tei Section Tunnel) for a four-year term. This tunnel is one of three under the Route 6 tunnel management contract awarded by the Transport Department.

The Yau Ma Tei Section of the Central Kowloon Route spans 4.7 km and features a dual three-lane configuration, reducing travel time between West Kowloon and Kowloon Bay from approximately 30 minutes to just 5 minutes, marking a significant breakthrough in Hong Kong's transport network. The Chun Wo Tunnel team is committed to professionalism and dedicated to enhancing the efficiency of the road network, ensuring a smoother and safer travel experience for the public.

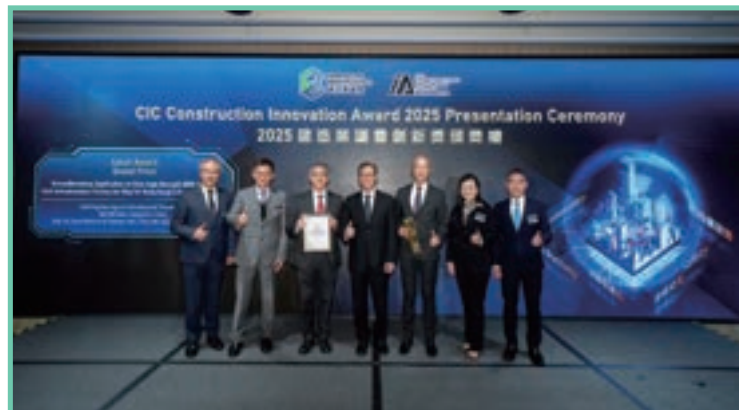

CHAIRMAN'S STATEMENT

REVIEW – THE MACROECONOMY

On behalf of the Board of Directors, I am pleased to present the Group's results for the Year. During the Year, the global economy continued to undergo structural adjustments amid a gradual easing of high interest rates and evolving geopolitical dynamics. Multiple regional conflicts emerged, with heightened tensions in the Middle East and further instability arising from interventions by certain countries in the Americas. These events caused temporary disruptions in commodity supplies, leading to fluctuations in oil, metal, and energy prices. Nevertheless, these developments also accelerated global supply chain diversification and regional cooperation, creating new market opportunities and collaboration prospects for companies with strong adaptability.

The Hong Kong economy demonstrated remarkable resilience. While businesses continued to face cost pressures and talent competition, the deepening integration of the Greater Bay Area brought significant benefits to Hong Kong, including substantial increases in cross-border flows of people, logistics, and capital. This has stimulated tourism, consumption, and sports-related economic activities, enhanced regional connectivity, and opened broader industrial collaboration opportunities for local enterprises. For the Group, this integration has directly driven higher demand for infrastructure engineering projects, growth in transportation and cross-border services, expansion of professional facility management contracts, and new regional collaboration opportunities in medical and healthcare services, providing strong support for the Group's steady development.

Facing a rapidly changing environment, the Group has adhered to a prudent and pragmatic approach, actively advancing business optimisation and transformation while leveraging regional advantages and technological trends to manage macroeconomic fluctuations effectively.

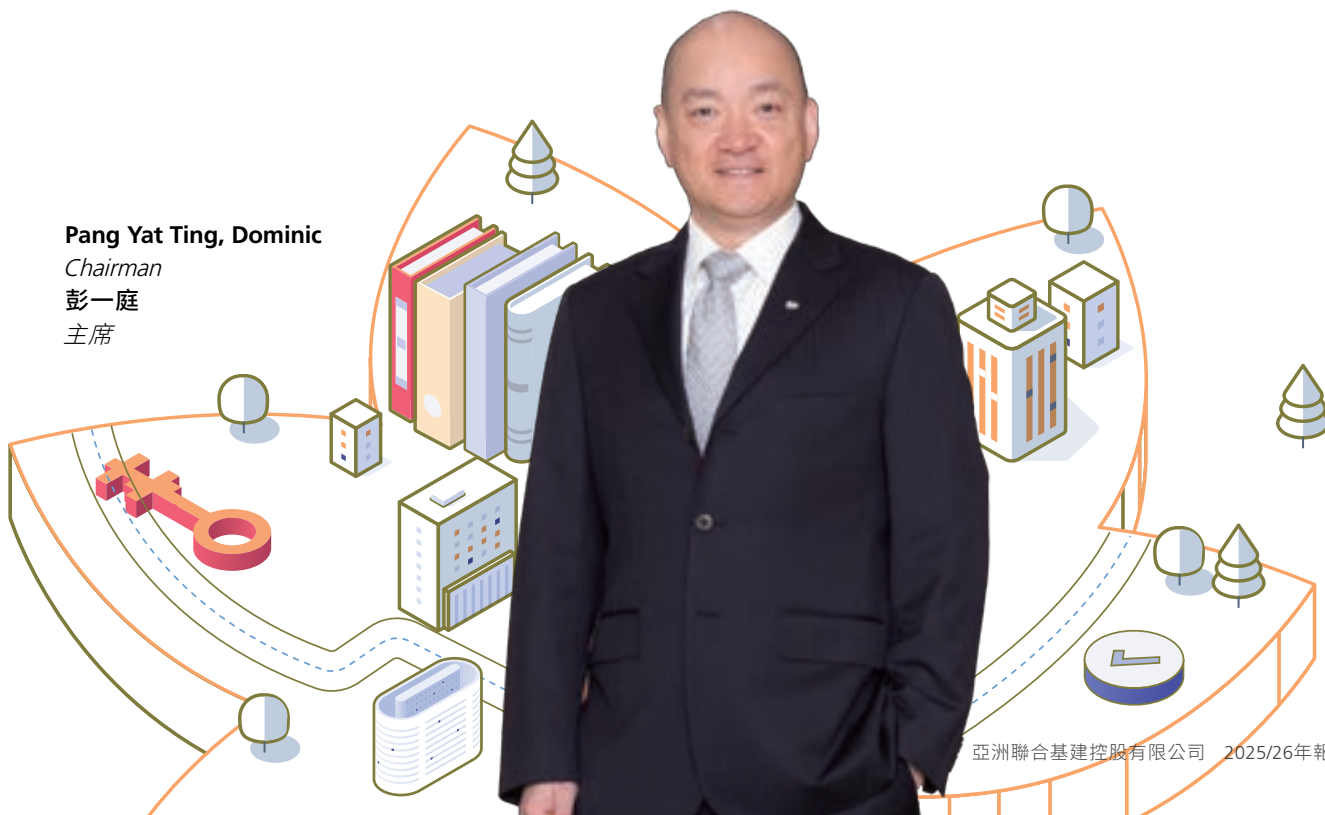
回顧－宏觀經濟

本人謹代表董事局呈報本集團本年度的全年業績。年內，全球經濟在高息環境逐步緩和的同時，繼續經歷結構性調整與地緣政治動態演進。期間多地衝突頻發，中東局勢最為緊張，以及美洲國家的介入進一步加劇不穩形勢。這些事件令大宗商品供應出現短期中斷，導致油價、金屬及能源價格呈現波動。然而，這些發展亦加速了全球供應鏈多元化與區域合作，為具備強大適應能力的企業創造新的市場空間與合作機遇。

香港經濟展現強勁韌性。企業雖面對成本壓力及人才競爭等挑戰，但大灣區融合深化為香港帶來顯著益處，包括跨境人流、物流及資金流大幅增加，刺激旅遊、消費及體育經濟發展；促進區域的互聯互通，並為本地企業開拓更廣闊的產業協作機遇。對本集團而言，此融合直接帶動基建工程項目需求上升、運輸及跨境服務業務增長、專業設施管理合約擴展，以及醫療健康服務的區域協作機會，為本集團的穩定發展提供強而有力的支持。

面對瞬息萬變的新格局，本集團以審慎務實為原則，積極推進業務優化與轉型發展，善用區域優勢及科技浪潮，有效應對宏觀經濟波動帶來的調整。

Against the backdrop of accelerating regional integration and a stable operating environment, the Group maintained steady operations. We prioritised rigorous cash flow management as a core strategy, ensuring service quality and operational stability while enhancing overall financial flexibility. We also optimised our technological capabilities and service models, actively embracing artificial intelligence ("AI") and digital transformation to strengthen our long-term competitiveness and market position.

In the Construction segment, the Group remained focused on high-tech and high-quality projects. Through ongoing optimisation of operational efficiency, we maintained a healthy level of contracts on hand. Leveraging our accumulated professional expertise over the years, the Group has sustained a strong reputation in the market. Despite the challenges posed by supply chain adjustments, we successfully delivered multiple significant and critical projects, fully demonstrating strong execution capability and adaptability.

In the Property Development and Assets Leasing segment, the Group continued its prudent strategy of focusing on the management of existing assets and timely capital allocation optimisation to align with overall funding needs and risk management objectives, while capitalising on positive opportunities arising from urban development to effectively address cost pressures.

The Professional Services segment (including security, tunnel management, public and private property, and facility management services) continued to deliver strong synergies. Management scale expanded steadily, generating more stable recurring revenue and playing a vital supporting role in the regional integration process.

The Non-franchised Bus Services segment achieved solid performance through enhanced operational efficiency and the expansion and optimisation of its service network.

The Medical Technology and Healthcare segment benefited from demographic changes and rising market demand, coupled with growing health awareness. The Group actively expanded capacity and strengthened its nuclear medicine industry chain capabilities, laying a solid foundation for sustainable future development.

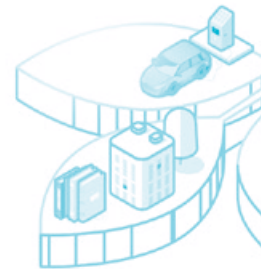

Guided by its medium- to long-term development strategy, the Group will continue to pragmatically optimise its asset and business structure, enhance financial management, further strengthen risk resilience, and capture diversified opportunities arising from market adjustments. At the same time, accelerating the adoption of technology, particularly in AI and digital operations, will enhance intelligent management and service precision while improving operational efficiency, safety standards, and cost-effectiveness.

BUSINESS REVIEW

During the past year, the Hong Kong economy continued to demonstrate resilience amid macroeconomic and industry challenges. The Group delivered steady operating growth, with total revenue reaching approximately HK\$9.92 billion (2025: HK\$9.06 billion), representing an approximate year-on-year increase of 9.5%. The Group recorded a profit attributable to shareholders of approximately HK\$131.4 million (2025: a loss attributable to shareholders of approximately HK\$274.0 million). Cash balances at period-end rose by approximately 10.3% compared with the previous year, while net debt decreased by approximately 48.8%. These improvements have maintained the Group's healthy financial position, providing solid support for sustained business development.

Hong Kong continued to benefit from accelerating integration with the Greater Bay Area and the Government's efforts to advance the Northern Metropolis development. Both the Policy Address and the Budget emphasised accelerated infrastructure investment, smoother cross-border flows of people, goods and capital, and the promotion of smart city and sustainable development initiatives. Public infrastructure investment remained active, and the construction industry as a whole is exhibiting favourable momentum in making steady progress. Against the backdrop of ongoing structural adjustments in the industry, the Group has long adopted a prudent approach, reducing reliance on private projects and concentrating resources on public infrastructure works. This strategy has not only contributed to Hong Kong's urban development but has also enhanced the reliability of receivables and cash flow efficiency.

The Group has been actively implementing several core strategies, which include: (i) maintaining a sound financial position; (ii) enhancing technological capabilities and service quality, while nurturing talent; and (iii) reinforcing market position and brand value. At the same time, the Group has vigorously promoted the application of intelligent technologies across business segments, intending to significantly improve operational efficiency, strengthen safety standards and service precision, thereby creating more possibilities for the Group.

Brand Image

The Group has long been committed to technological innovation, service excellence, and talent development. The Group also actively shares the latest technological application outcomes with government departments and industry partners. Over the years, the Group has maintained an excellent safety record in the construction industry, with a relatively low accident rate. In public infrastructure projects, the Group consistently delivers stable contract performance and has established long-term, close cooperative relationships with its joint venture partners. Project progress and cash flow have remained smooth, fostering a high level of mutual trust and seamless collaboration among all stakeholders and employees throughout the service chain.

過去一年，香港在整體宏觀經濟環境及行業的各種挑戰中持續展現韌性。本集團整體營運保持穩健增長，總營業額約達9,920,000,000港元（2025年：9,060,000,000港元），同比增長約9.5%。本年度錄得股東應佔純利約為131,400,000港元（2025年：股東應佔虧損約為274,000,000港元）。期末現金較去年同期增加約10.3%，而債務淨額減少約48.8%。本集團的財務狀況保持健康水平，為業務持續發展提供有力的支持。

香港持續受益於大灣區的加速融合及政府推動的北部都會區發展。施政報告及財政預算案均強調加快基礎設施建設、促進跨境人流、物流及資金流通，以及推動智慧城市與可持續發展。公共基建投資保持積極，建造業界整體呈現穩中求進的良好勢態。在行業整體結構調整下，本集團自早年已採取審慎策略，減少對私營項目的依賴，轉而聚焦公營基礎建設項目為主。此舉不僅為香港城市發展作出貢獻，更有效提升應收賬款的可靠性及資金周轉效率。

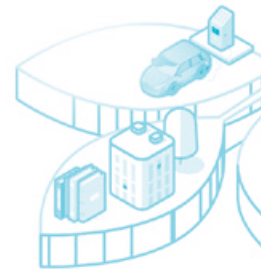

Looking ahead to the wave of innovative technology and smart city development, the Group is actively introducing solutions across various areas, including financial management, project design and planning, construction quality control, and facility operations. These initiatives have not only optimised the Group's own operations and enhanced competitiveness, but also aligned with the Government's sustainable development objectives, thereby contributing to the long-term urban development of Hong Kong and the Greater Bay Area.

Construction

The Construction segment delivered a stable performance during the Year. Revenue amounted to approximately HK\$8.61 billion (2025: HK\$7.88 billion), while segment profit was approximately HK\$364.6 million (2025: HK\$52.4 million), representing a significant increase. In terms of contract backlog, the Group continued to demonstrate strong competitiveness. As at the end of the Year, the aggregate contract sum reached approximately HK\$39.31 billion (2025: HK\$35.46 billion), of which around HK\$21.24 billion (2025: HK\$20.40 billion) represented the outstanding ongoing contracts. This healthy order book provides solid support for the Group's future revenue stream.

The Group secured 12 new projects, with a total contract value of HK\$6.1 billion during the Year, including Ngau Tam Mei Water Treatment Works Extension – Extension of Ngau Tam Mei Fresh Water Primary Service Reservoir, Modification of Raw Water Tunnel Junction (Chamber G) and Associated Mainlaying; two Term Contracts for the Alterations, Additions, Maintenance and Repair of Aided Schools, Buildings and Lands and Other Properties for which the Education Bureau is Responsible (Designated Contract Area: Wong Tai Sin, Kwun Tong and Sai Kung) and (Designated Contract Area: Sham Shui Po, Tsuen Wan and Kwai Tsing); and the Construction of UPS Express Air Cargo Services Hub at the Hong Kong International Airport at Chek Lap Kok.

There were a total of 29 projects in progress as at 31 March 2026, five of which were major Government infrastructure contracts linked to the development of the Northern Metropolis. These ongoing projects include Demolition, Foundation, Superstructure and Associated Works Contract for Redevelopment of Kwong Wah Hospital (Phase 2); In-situ Reprovisioning of Sha Tin Water Treatment Works (South Works) – Water Treatment Works and Ancillary Facilities; Fanling North New Development Area, Phase 1: Fanling Bypass Eastern Section (Shek Wu San Tsuen North to Lung Yeuk Tau); Kwu Tung North New Development Area, Remaining Phase: Improvement Works of Tai Tau Leng Roundabout and Po Shek Wu Road and Associated Works; and Drainage Improvement Works in Kowloon City.

展望創新科技與智慧城市發展浪潮，本集團積極引入及推動涵蓋財務管理、項目設計規劃、施工質量控制及設施營運等不同領域與範疇的解決方案。這些措施不僅優化本集團的營運及提升競爭力，更配合政府提倡的可持續發展目標，為香港及大灣區的長遠城市建設作出貢獻。

建築

建築分部於本年度表現穩定。營業額錄得約8,610,000,000港元（2025年：7,880,000,000港元），分部溢利顯著上升，約為364,600,000港元（2025年：52,400,000港元）。工程儲備方面，本集團持續展現強大的競爭力，截至本年度末，合約總額高達約39,310,000,000港元（2025年：35,460,000,000港元），當中未完成合約額約為21,240,000,000港元（2025年：20,400,000,000港元），為未來收入提供充足支撐。

於本年度，本集團成功取得12個新項目，總合約價值6,100,000,000港元，其中包括牛潭尾濾水廠擴建工程—牛潭尾食水主配水庫擴建，原水隧道交匯處（G室）改建及相關水管敷設工程；合約指定區（黃大仙、觀塘及西貢）及合約指定區（深水埗、荃灣及葵青）內由教育局負責的津貼學校、建築物、土地及其他物業進行改建、加建、保養及維修工程的兩份定期合約；以及赤鱸角香港國際機場UPS快遞航空貨運服務樞紐。

截至2026年3月31日，本集團共有29個進行中的項目，其中5項為與「北部都會區」相關的大型政府工程合約。進行中的項目包括廣華醫院重建計劃（第二期）的拆除、地基、上蓋建築及相關工程合約；沙田濾水廠原地重置工程（南廠）—濾水廠及附屬設施；粉嶺北新發展區第一階段：粉嶺繞道東段（石湖新村北至龍躍頭）；古洞北新發展區餘下階段—大頭嶺迴旋處及寶石湖路改善工程及相關工程；及九龍城雨水排放系統改善工程合約。

The Group completed 24 projects during the Year, including Construction of Lung Tsun Stone Bridge Preservation Corridor at Kai Tak; Main Contract Works for 250-Place Student Hostel at United Campus for The Chinese University of Hong Kong; and Retrofitting of Noise Barriers on Po Lam Road North and Po Ning Road.

The Singapore subsidiary under this segment, R.J. Crocker Consultants Pte. Ltd., delivered a satisfactory performance. During the Year, it successfully secured the contract for Changi Airport Terminal 5, which, together with its ongoing contracts with the Singapore Land Transport Authority, contributed to solid revenue. Across both local and overseas operations, the Group consistently upholds its operating principle of focusing on public-sector construction contracts, thereby effectively enhancing project stability and capital turnover efficiency. With the continued expansion of its Hong Kong operations, management has increased the number of civil engineering construction business units under the segment to four, which effectively strengthens project execution capabilities and resource allocation.

The achievements of the segment continue to receive wide recognition from various sectors, earning numerous accolades. Notably, the Fanling Bypass project has been honoured with several major awards in Hong Kong's construction industry, including the Local Grand Prize, the highest distinction at the CIC Construction Innovation Award 2025, the Industrial, System and Innovation Category – Grand Prize at the Hong Kong Institution of Highways and Transportation ("HKIHT") Award 2025, and the Excellence in Innovation & Technology Adoption at the Outstanding NEC Team Performance Awards 2025. In addition, the Development of Anderson Road Quarry Site received the Institution of Civil Engineers Award 2026 – Edmund Hambly Medal, in recognition of the project's creative design and the team's outstanding contributions to advancing sustainability and climate adaptation. These exceptional results fully demonstrate the Group's unwavering commitment to pursuing high standards.

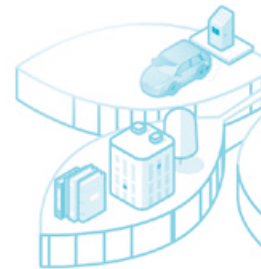

本分部旗下的新加坡附屬公司—冠格顧問有限公司表現理想，本年度成功取得新加坡樟宜機場第五航廈的工程合約，連同手頭上的新加坡陸路交通管理局合約，共同帶來穩健收益。無論是本港還是海外業務，本集團始終秉持以承接公營建築合約為主的營運方針，有效提升項目穩定性及資金周轉效率。隨著香港業務持續擴展，管理層已將本分部旗下的土木工程建築業務單位增至四個，有效強化工程項目的執行能力與資源調配。

本分部的工程成果持續備受各界認可，屢獲殊榮。其中，粉嶺繞道項目榮獲多項香港建造業重要獎項，包括「2025建造業議會創新獎」中最高殊榮的「本地創新大獎」、「香港公路學會大獎2025」中的「工業、系統及創新範疇—最高榮譽大獎」，以及「優秀新工程合約團隊表現獎2025」中的「卓越創新科技應用獎」。此外，安達臣道石礦場用地發展項目亦榮獲英國土木工程師學會2026年度獎「Edmund Hambly Medal」，以表彰該項目在創意設計及工程團隊推動可持續發展與氣候調適方面的卓越貢獻。以上佳績充分體現了本集團對高水平追求的不懈實踐。

Property Development and Assets Leasing

This segment maintained a solid performance during the Year. In the 2025-26 fiscal year, the Government rolled out various measures to support the private residential property market, including raising the stamp duty exemption threshold for lower-value properties, increasing land supply for private housing, and considering the conversion of certain commercial sites for residential use. These initiatives have provided the market with clearer development visibility. In the face of adjustments in the external operating environment, the Group adopted a pragmatic operating approach, concentrating on high-quality projects with stable cash flows and continuing to utilise the joint venture model. This approach has further strengthened risk management, consolidated its financial foundation, and ensured smooth cash flow for business partners.

Key Project Performance

- **128 Waterloo** – A premium residential development located in a well-established luxury residential enclave in Ho Man Tin. Approximately 90% of the units have been successfully sold, reflecting continued strong demand for prime residential locations. Towards the end of the financial year, three special adjoining units were sold in a series of transactions at an aggregate consideration of approximately HK\$82.19 million, demonstrating the market's strong recognition of high-quality offerings.
- **SOYO** – A boutique residential development situated in the heart of Mong Kok. Located within the core urban area of Kowloon and benefiting from comprehensive and convenient lifestyle amenities, the project has recorded encouraging sales performance since its launch, with approximately 99% of the units sold.
- **Soyo Square** – A desirable residential development set in the vibrant and highly convenient neighbourhood of Cheung Sha Wan. The project was successfully completed in the third quarter of 2025 and launched for sale in the fourth quarter. As at the end of the financial year, over 70% of the units had been sold, generating positive cash flow contributions to the Group.

All of the above projects were developed under joint venture structures, effectively diversifying investment risk while maintaining a sound and resilient financial structure.

物業發展及資產租賃

本分部於本年度維持良好表現。政府在2025-26財政年度推出多項措施支持私營住宅市場，包括提高低價值物業印花稅豁免門檻、增加私營房屋土地供應，以及考慮將部分商業用地轉作住宅用途等，為市場提供更清晰的發展預期。面對外部環境的調整，本集團採取務實經營策略，專注現金流穩定的優質項目及合營模式，以進一步優化風險管理並鞏固財務基礎以確保合作夥伴資金流轉順暢。

重點項目表現

- **128 Waterloo** 一位於何文田傳統豪宅地段的高端住宅項目，已成功售出約90%的單位，反映市場對豪宅地段的需求依然殷切。於本財政年度末，更接連錄得3宗特色相連單位售出，總成交價約8,219萬港元，顯示市場對優質產品的高度認可。
- **雋薈** 一位於旺角的精品住宅項目，坐落於九龍區市中心核心地段，憑藉多元便捷的生活配套，自推出以來銷售成績理想，已成功售出約99%的單位。
- **幸薈** 一位於長沙灣活力充沛且便利地段的優質住宅項目，順利於2025年第三季完工並於第四季推出發售。截至本財政年度末，此項目累積售出逾70%的單位，為本集團帶來正面現金流貢獻。

上述所有項目均透過合營模式開發，有效分散投資風險及維持財務結構穩健且具韌性。

Professional Services

The segment encompasses security and management services for both public and private properties, tunnel management, clubhouse and other facility management services. It is operated through two subsidiaries under the Group: City Services Group Limited ("City Services") and Modern Living Investments Holdings Limited ("Modern Living"). During the Year, the two companies leveraged their complementary strengths, achieving a combined revenue of approximately HK\$1.26 billion (2025: HK\$1.13 billion), representing a year-on-year increase of approximately 11.3%. Segment profit amounted to approximately HK\$61.9 million (2025: HK\$15.6 million). Overall business performance recorded a significant increase.

Guided by a customer-centric and continuous improvement strategy, the segment achieved notable breakthroughs in both public and private markets:

- **Modern Living:** Primarily engaged in the provision of security and property management services for public housing estates. Its service portfolio covers 15 public rental housing estates owned by the Hong Kong Housing Authority ("HKHA") and 15 Home Ownership Scheme ("HOS") courts awarded by the HKHA. The contract portfolio maintained a stable duration cycle, providing a solid foundation for continued business development. In order to improve service levels, in addition to developing intelligent property management platforms with digital twin technology, during the Year, it further seized the opportunity presented by the rapid advancement of robotics and intelligent technologies by integrating these innovations into daily operations. This included deploying unmanned aerial vehicles ("UAV") for building facade inspections and jointly developing a "water tank cleaning robot", providing practical, replicable examples for the intelligent upgrading of Hong Kong's property management industry.
- **City Services:** Principally provides security and management services for both public and private properties, tunnel management services, as well as clubhouse and other facilities management services. The security and property management business continues to maintain a diversified and high-quality client base, including The Hong Kong University of Science and Technology, The Hong Kong Jockey Club, and MTR Corporation Limited (covering The Harbourside, Sorrento, The Arch and The Cullinan), together with a consistently stable and satisfactory contract renewal rate. By seizing market opportunities and delivering exceptional services, we have driven substantial annual growth. As regards tunnel management, the four-year management contract for Route 6 commenced operations towards the end of 2025, underscoring City Services' long-standing and solid partnership with its clients, as well as its competitive and industry-leading service standards.

專業服務

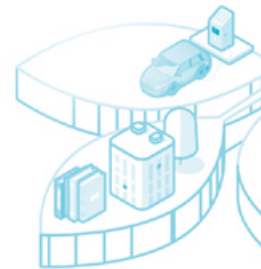
本分部的業務範圍包括公私營物業的保安及管理服務、隧道管理、會所及其他設施管理服務。由本集團旗下的兩間附屬公司，城市服務集團有限公司（「城市服務」）及雅居投資控股有限公司（「雅居」）組成。本年度兩間公司發揮互補優勢，總營業額達到約1,260,000,000港元（2025年：1,130,000,000港元），同比增長約11.3%，分部溢利約為61,900,000港元（2025年：15,600,000港元），整體業務表現錄得大幅攀升。

憑藉以客為本及持續進步的策略，本分部在公私營市場均取得突破：

- **雅居：**主要從事公營物業的保安及管理服務，服務範圍涵蓋由香港房屋委員會（「房委會」）擁有的15個公共屋邨，以及房委會轄下居者有其屋計劃（「居屋」）的15個屋苑。在手合約的合約年期結構維持穩定，為業務持續發展奠定堅實基礎。為提升服務水平，除了研發應用數碼分身技術的智能物業管理平台，雅居於本年度進一步把握機械人及智能科技快速發展的契機，並將相關技術融入日常營運，包括利用無人航空載具（「無人機」）進行大廈外牆檢測及合作研發「清洗水缸機械人」等，為香港物業管理行業智能化升級提供了可供借鑒的實踐範例。
- **城市服務：**主要提供公私營物業的保安及管理服務、隧道管理、會所及其他設施管理服務。保安及物業管理業務持續維持多元而優質的客戶基礎，包括香港科技大學、香港賽馬會及香港鐵路有限公司（涵蓋君臨天下、擎天半島、凱旋門及天璽），並一直保持穩定而理想的續約率，加上能夠把握市場機遇，結合優質服務表現，年度增長大幅提升。隧道管理業務方面，為期四年的六號幹線隧道管理工作已於2025年年末正式展開，充分體現城市服務與客戶之間長期穩固的合作關係，以及其具競爭力及領先的服務水平。

Professional Services (Continued)

The above achievements demonstrate that the combination of the strengths and expertise of both companies has effectively enhanced synergistic benefits, strengthened the Group's overall market position, and delivered strategic success.

Non-Franchised Bus Services

The segment is operated by Chun Wo Bus Services Limited ("Chun Wo Bus"). For the Year, it recorded a profit of approximately HK\$6.5 million (2025: HK\$6.7 million). The business maintained a steady, recurring profit.

Chun Wo Bus has cultivated a strong client base comprising reputable institutions, schools, and property management companies, while actively responding to smart and green transportation trends to continuously provide reliable transportation support to the community. In response to the Government's Transport Strategy Blueprint announced in 2026, which emphasises smart and green mobility, coupled with the recovery in inbound tourism, demand for quality tourist coach services has increased. Leveraging its long-established reputation for service excellence, Chun Wo Bus has proactively aligned with these policies to meet market demand.

Medical Technology and Healthcare

This segment is operated by the Group's wholly-owned subsidiary, Hong Kong Cyclotron Laboratories Limited ("HKCL"), which specialises in the production of positron emission tomography ("PET") radiopharmaceuticals and operates one of the largest distribution networks in Hong Kong. During the Year, the segment's revenue grew by approximately 15.8%, reaching approximately HK\$53.2 million (2025: HK\$45.9 million), with a profit of approximately HK\$16.3 million (2025: HK\$11.6 million). The growth was primarily driven by increasing demand from the Hospital Authority, The Chinese University of Hong Kong Medical Centre and various medical imaging centres for radiopharmaceuticals such as fluorodeoxyglucose ("FDG") and prostate-specific membrane antigen ("PSMA"). Market demand remained strong, sustaining healthy growth.

The segment has been actively enhancing its nuclear medicine industry chain. During the Year, HKCL signed a Memorandum of Understanding with radiation protection specialist Cnrayshield and was appointed as its exclusive distributor in Hong Kong, extending the service scope to professional protective equipment, including lead shielding and L-shaped shielding blocks. This move complements HKCL's core business, particularly as the Company steadily advances its local production cooperation with GE HealthCare for the 18F-Flutemetamol patented radiopharmaceutical used in Alzheimer's disease detection. With the parallel development of patented radiopharmaceuticals and protective equipment lines, the Group not only maintains its leading position in advanced PET radiopharmaceutical development but also expands its customer base through a more diversified product portfolio, injecting strong momentum into profit growth.

專業服務 (續)

上述表現顯示結合兩者的優勢和專長，更能體現協同效應，提升本集團綜合的市場地位，並取得策略性的成功。

非專營巴士服務

本分部由俊和巴士服務有限公司（「俊和巴士」）經營。本年度錄得溢利約6,500,000港元（2025年：6,700,000港元），業務維持穩健的經常性溢利。

俊和巴士深耕知名機構、學校及物業管理公司客戶群，並積極響應智慧與綠色交通趨勢，持續為社區提供可靠交通支援。政府於2026年公佈《運輸策略藍圖》，強調智慧及綠色交通發展，加上受訪港旅客回升帶動了對優質旅遊巴士服務的需求。俊和巴士憑藉累積多年的服務口碑，積極配合相關政策，回應市場需要。

醫療科技與健康

本分部由本集團的全資附屬公司Hong Kong Cyclotron Laboratories Limited（「HKCL」）營運，專門從事正電子發射斷層掃描（「正電子掃描」）放射性藥物的生產，並經營香港最大的分銷網絡之一。本年度分部營業額增長約15.8%，達到約53,200,000港元（2025年：45,900,000港元），溢利約為16,300,000港元（2025年：11,600,000港元）。增長主要受香港醫院管理局、香港中文大學醫院及多間醫療影像中心對氟化脫氧葡萄糖（「FDG」）及前列腺特异性膜抗原（「PSMA」）等放射性藥物的上升需求帶動。市場需求依然強勁，保持健康增長。

本分部積極完善核醫學產業鏈，HKCL於本年度與輻射防護專家Cnrayshield簽署諒解備忘錄，正式獲任為其香港獨家分銷商，將服務範疇延伸至鉛屏蔽及L型屏蔽塊等專業防護設備。此舉與HKCL的核心業務相輔相成，特別是公司正穩步推進與GE HealthCare就阿茲海默症檢測專利放射性藥物18F-Flutemetamol的本地生產合作。隨著該專利放射性藥物與防護設備線的雙軌並進，本集團不僅穩居先進正電子掃描放射性藥物的研發前沿，更透過多元化的產品組合擴大客戶群，為盈利增長注入強勁動力。

Other Business

Mattex Asia Development Limited (“Mattex”) continued to advance the digital transformation of conventional construction procurement practices. Through its proprietary online procurement and management platform, the Group further embedded data-driven decision-making into core construction operations. Enhancements implemented over the period strengthened supply chain pricing analytics, enabling contractors to better mitigate cost volatility amid fluctuating material prices. In response to on-site management challenges, the Group has deeply integrated Internet of Things (“IoT”) and digital monitoring technologies to develop a comprehensive smart site supervision system. This system provides real-time safety alerts and construction quality tracking, significantly reducing potential risks arising from human error and ensuring projects are delivered on time and to high standards.

Concurrently, the Group enhanced its industry footprint through the strategic integration of Manbond Supply Chain (HK) Company Limited (“Manbond”). Leveraging Manbond’s established construction materials trading capabilities in conjunction with Mattex’s digital platform, the Group put in place an integrated service model encompassing online procurement coordination, project management support and supply chain delivery assurance, further strengthening its differentiated market positioning.

LIQUIDITY AND FINANCIAL RESOURCES

The financial position of the Group remained stable during the Year. The Group operates a centralised treasury function to monitor its cash position, cash flow and funding requirements, that mainly relies upon internally generated funds as well as bank borrowings to finance its operations and expansion, which is supplemented by equity funding when it is required.

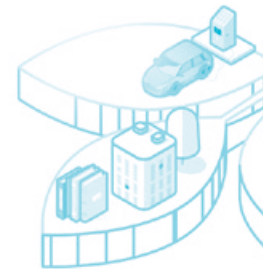
其他業務

材迅亞洲發展集團有限公司(「材迅」)持續推動建築採購流程的數碼化轉型，透過自主研發的網上採購及管理平台，成功將數據驅動決策深度融入核心建築營運中。經優化的平台進一步提升供應鏈價格分析的準確性，使承建商能夠在材料價格浮動下更好地緩解成本波動。本集團亦針對工地管理的挑戰，整合物聯網(「IoT」)及數碼監控技術，建立智慧工地監督系統，提供即時安全預警及施工品質追蹤，從而顯著降低營運風險並確保項目按時高質素完成。

此外，本集團透過戰略整合萬邦供應鏈(香港)有限公司(「萬邦」)，進一步完善產業佈局。萬邦於建築材料貿易方面的穩固基礎，與材迅的網上平台形成協同效應，構建涵蓋網上採購、工程管理及供應鏈交付的一體化服務模式，鞏固其市場差異化競爭優勢。

流動資金及財政資源

於本年度本集團的財務狀況保持平穩。本集團實行集中資金管理以監控其現金狀況、現金流量和資金需求，其業務營運及擴展所需資金主要來自內部資金及銀行借款，在有需要時再輔以發行股份集資。

The Group has continued to implement a prudent financial management policy, at 31 March 2026, the gearing ratio of the Group, being the proportion of net interest bearing debts to equity attributable to Shareholders, was 0.45 (2025: 0.94).

To minimise exposure on foreign exchange fluctuations, the Group's bank borrowings and cash balances are primarily denominated in Hong Kong dollars or Renminbi which are the same as the functional currency of the relevant group entities. The Group has no significant exposure to foreign exchange rate fluctuations and shall use derivative contracts to hedge against its exposure to currency risk only when it is required. Furthermore, the Group's bank borrowings have not been hedged by any interest rate financial instruments.

EMPLOYEE AND REMUNERATION POLICIES

The Group had approximately 8,265 employees as at 31 March 2026. Total remuneration of employees for the Year amounted to approximately HK\$1,966.6 million. Employees are remunerated according to their nature of work and the market trend, with merit-based components incorporated in the annual increment review to reward and motivate individual performance. Employee bonus is distributable based on the performance of the respective segments and the employees concerned. Moreover, the Group also provides in-house training program and sponsorship for external training courses which are complementary to their job functions.

To provide incentive for employees to achieve performance goals, the Company adopted the restricted share award scheme (the "Share Award Scheme") on 1 August 2017, pursuant to which the Company may grant to eligible participants restricted shares of the Company, which will align the interests of employees directly to the Shareholders through ownership of shares of the Company. Such grant shares are acquired by the scheme trustee on the market of the Stock Exchange and held upon trust for the benefit of the grantees and shall become vested in the grantees upon satisfaction of specified vesting criteria.

In addition, the Company had also adopted a share option scheme (the "Share Option Scheme"), under which the Directors are authorised to grant share options to the eligible participants to subscribe for shares of the Company for the purpose of, among other things, providing incentives and rewards to, and recognising the contributions of, the eligible participants. The Share Option Scheme is valid and effective for a period of 10 years commencing on 3 September 2012 and expired on 2 September 2022, after which no further share options shall be offered or granted but the share options granted prior to the expiry date shall continue to be valid and exercisable in accordance with the provisions of the Share Option Scheme.

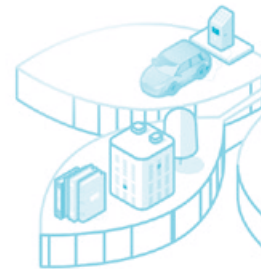

僱員及薪酬政策

於2026年3月31日，本集團約有8,265名僱員。本年度之僱員薪酬總額約為1,966,600,000港元。僱員薪酬按其工作性質及市場趨勢釐定，並根據考勤評核按表現釐定每年之增薪金額，以獎勵及激勵個別員工之表現。僱員之花紅乃按個別分部及有關僱員之表現而發放。此外，本集團亦因僱員之工作職務而提供內部培訓計劃及就外間培訓課程提供資助。

為激勵僱員實現績效，本公司於2017年8月1日採納了受限制股份獎勵計劃（「該股份獎勵計劃」），據此本公司可向合資格參與者授出本公司之受限制股份，讓員工持有本公司股份使員工的利益直接與股東的利益保持一致。該等授出股份乃由計劃受託人於聯交所之市場上購買及為承授人的利益以信託方式持有，並於特定歸屬條件達成後歸屬承授人。

此外，本公司亦已採納購股權計劃（「該購股權計劃」），據此，董事獲授權向合資格參與者授出購股權以認購本公司股份，旨在（其中包括）向合資格參與者提供激勵及獎賞，並肯定其所作之貢獻。該購股權計劃由2012年9月3日起計10年內有效及生效，已於2022年9月2日失效，其後不得進一步要約或授出購股權，惟於失效日期前已授出的購股權將根據該購股權計劃的條文繼續有效及可予行使。

Construction

Looking ahead, the Group will further strengthen its talent pool by actively recruiting professionals with advanced skills. This will enhance its project execution capabilities and overall competitiveness. It will also streamline internal workflows, maintain an efficient and flexible organisational structure, and reinforce cost control to improve project returns. Throughout, it will uphold high standards of project quality and safety.

In active response to Government policies promoting construction innovation, the Group encourages project teams to propose solutions that integrate green design and low-carbon construction. Moving forward, the Group will deeply embed artificial intelligence and robotics into day-to-day construction processes. Through the comprehensive deployment of intelligent monitoring control systems and automated robots, the Group will target improvements in on-site safety, reductions in material wastage, and greater engineering precision. This series of technology upgrades is designed to directly drive operational efficiency at the execution level. At the same time, the Group will continue to identify further resource-saving and carbon-reduction measures, with the goal of delivering a dual improvement in both project profitability and environmental performance for each individual project.

1. Potential Benefits of the Northern Metropolis Project

The development of the Northern Metropolis represents one of Hong Kong's most important and strategic growth initiatives over the next two decades and will have a profound and positive impact on the Group's construction business. The Government has established the Northern Metropolis Development Committee chaired by the Chief Executive and plans to introduce dedicated legislation to speed up approvals and relax restrictions. Substantial funding from the Exchange Fund, together with the establishment of a dedicated development company and the use of public-private partnership models, will be utilised to accelerate key projects such as the San Tin Technopole, Hung Shui Kiu Industry Park and the Northern Metropolis University Town. By taking an "industry-driven, infrastructure-led" approach, these initiatives are expected to generate a large volume of infrastructure, public housing, and supporting engineering projects, providing the construction industry with strong and sustained long-term momentum.

展望未來，本集團將繼續強化人才團隊建設，積極吸納具備先進技能的專業人士，以提升項目執行能力及整體競爭優勢。本集團亦會優化內部工作流程，維持高效靈活的組織架構，並持續加強成本監控，在確保工程品質及安全的前提下提升項目回報。

本集團積極響應政府推動建築創新的政策，鼓勵項目團隊提出融入綠色設計及低碳施工的方案。未來，本集團將把人工智能及機械人技術深度融入日常建築流程。透過全面部署智能管控系統及自動化機械人，本集團將致力於提升施工現場的安全、減少材料損耗並提高工程精準度。此技術升級將全面釋放營運效益。同時本集團將持續發掘更多資源節約與減碳措施，務求在各項目的執行上實現利潤與環境表現的雙重提升。

1. 北部都會區項目潛在效益

北部都會區發展是香港未來二十年重點且最具戰略意義的增長引擎，對本集團建築業務將產生深遠而正面的影響。政府已成立由行政長官親自領導的北部都會區發展委員會，計劃推出專屬法例以加速審批程序及放寬限制。同時透過外匯基金的巨額注資，並設立專屬發展公司及採用公私營合作模式，加速推動如新田科技城、洪水橋產業園及北都大學教育城等核心項目落地。透過「產業帶動、基建先行」策略，該等舉措預計將帶來大量基礎設施、公營房屋及配套工程項目，為建造業提供長遠穩定的增長動能。

1. Potential Benefits of the Northern Metropolis Project

(Continued)

In light of this, the segment has been actively participating in public works related to the Northern Metropolis and has successfully secured multiple new contracts. These projects not only showcase the Group's strong execution capability in large-scale infrastructure but also mark a strategically important milestone for "Chun Wo".

2. Technology Collaboration and Support

For the Fanling Bypass project, the Group assembled an elite team comprising international design consultants, The Hong Kong Polytechnic University, Tsinghua University, and leading mainland steel structure manufacturers. Working in partnership, the team successfully designed, fabricated, transported, and installed the world's first pedestrian bridge built with ultra-high-strength S960 steel. Compared with applying conventional steel, this innovative design not only significantly improves strength but also, through its lightweight properties, substantially reduces foundation requirements. This innovation effectively mitigates underground environmental risks, cuts carbon emissions by approximately 65%, and delivers cost savings of nearly 30%, setting a new benchmark for sustainable construction. The groundbreaking project has earned multiple industry awards, underscoring broad recognition of its innovative approach.

Alongside this, the Group will broaden and deepen its technology collaborations, working hand-in-hand with academic institutions and technology partners to advance the integrated application of Modular Integrated Construction ("MiC"), smart site management systems, and green low-carbon technologies. By introducing cutting-edge solutions such as artificial intelligence, digital twin technology, and construction robotics, the Group aims not only to significantly enhance construction efficiency and safety standards, but also to align these innovations fully with the sustainable development needs of large-scale infrastructure projects such as the Northern Metropolis. This represents more than an iterative breakthrough in building technology; it is a concrete commitment by the Group to fulfilling its ESG responsibilities and leading Hong Kong's construction industry into a greener, smarter future.

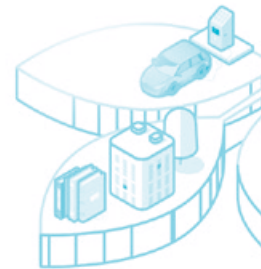
2. 技術合作與支持

本集團在粉嶺繞道項目中，匯聚國際頂尖設計顧問、香港理工大學、清華大學及內地領先鋼結構製造商等專家團隊，成功共同設計、製造、運輸及安裝全球首座採用S960超高強度鋼材的行人天橋。相較應用傳統鋼材，此創新設計不僅強度大幅提升，更因輕量化特性顯著減少地基工程需求。此項創新有效減輕地下環境風險、減少約65%的碳排放，以及降低近30%的施工成本，開創業界可持續建造的新標桿。該項目獲得了多項由業界組織頒發的殊榮，顯示業界對創新建築技術的高度認可。

與此同時，本集團將進一步拓展技術合作的廣度與深度，與學術機構及技術合作夥伴攜手合作推動組裝合成建築法（「組裝合成建築法」）、智能工地管理系統及綠色低碳技術的疊加應用。透過引入人工智能、數位分身技術及建築機械人等前沿方案，本集團不僅旨在大幅提升施工效率與安全水平，更會將這些創新成果全面對接北部都會區等大型基建的可持續發展需求。這不僅是建造技術的迭代突破，更是本集團履行環境、社會及管治責任、帶動香港建造業向綠色智能時代邁進的具體承諾。

Property Development and Asset Leasing

The segment will continue to drive the sales of key projects, including 128 Waterloo, SOYO and Soyo Square, while optimising risk management and cash repatriation efficiency through the joint venture model. Capitalising on the market momentum generated by the Government's increased supply of private residential land and stamp duty optimisation measures, the Group is fully prepared to seize emerging opportunities. Strategic focus is placed on high-quality assets that deliver stable cash flows, with sustainable development principles actively incorporated into projects. These efforts aim to fortify the existing portfolio while raising the environmental and social value of the projects.

Professional Services

The segment remains committed to leveraging the complementary strengths of City Services and Modern Living to deepen the integration of public and private property management, tunnel management, and facility management services. City Services and Modern Living will seize opportunities across various fields to enhance management, particularly through advanced technologies such as robotics. As a result, their market shares are expected to expand further, and the development outlook remains positive, responding to the positive momentum already observed in these two business areas. At the same time, in alignment with Government policies aimed at enhancing building management and advancing smart city development, there will be an increased deployment of smart estate and intelligent management control systems, thereby delivering higher-quality services to clients.

The Group will actively advance ESG initiatives, including staff training and development, and the adoption of green facility management standards. Concurrently, the segment will continue to apply innovative technologies in public property management. Over the coming year, the application of these innovations will be extended to private property management, tunnel management, and facility management services to achieve intelligent upgrades in services. This transition aims to optimise security efficiency, energy management precision, and overall service standards. By establishing this robust technological and sustainable framework, the Group is well-positioned for business expansion, contributing significantly to the sustainable urban development of Hong Kong and the Greater Bay Area.

物業發展及資產租賃

本分部將繼續推進128 Waterloo、雋薈及幸薈等重點項目的銷售，並透過合營模式優化風險管理及資金回籠效率。憑藉政府增加私人住宅用地供應和優化印花稅措施所帶來的市場成長勢頭，本集團已做好充分準備，把握新興機會。本集團的策略聚焦於現金流穩健的優質資產，並於項目中積極融入可持續發展原則。這些措施旨在鞏固現有投資組合，同時提升項目的環境及社會價值。

專業服務

本分部將繼續發揮城市服務及雅居的互補優勢，深化公私營物業管理、隧道及設施管理服務的整合。城市服務與雅居分別將於各領域把握機會，優化管理，特別是透過機械人等先進技術。因此，預計它們的市場份額將進一步擴大，且發展前景保持樂觀，這與上述兩個業務領域中已呈現的良好增長勢頭互相呼應。同時，配合政府改善樓宇管理及推動智慧城市發展的政策，未來會加強智慧屋苑及智能管控系統的應用，為客戶提供更高質素的服務。

Non-franchised Bus Services

The segment will focus on enhancing both service quality and operational efficiency. Through an advanced intelligent scheduling platform, the segment will precisely address the needs of diverse customer segments, optimise resource allocation, and improve overall flexibility. Market trends and customer feedback are closely monitored to facilitate timely adjustments to the service mix, thereby strengthening the existing business base while exploring further potential service areas.

In alignment with the Government's Transport Strategy Blueprint, the application feasibility of intelligent monitoring systems and automated scheduling technologies will be explored. These efforts aim to meet the recovering demand from inbound tourists and local community travel needs, fostering a more environmentally friendly and efficient transportation network for Hong Kong. Such initiatives will actively support the city's low-carbon transport transformation and sustainable urban development.

Medical Technology and Healthcare

With Hong Kong's ageing population and rising demand for precision medicine, the Government's Policy Address has highlighted the importance of strengthening cancer prevention, screening, diagnosis, and treatment, while promoting the development of the life and health technology industry. These initiatives create favourable conditions for the PET radiopharmaceutical market. The segment maintains an optimistic outlook on its future growth prospects.

As a leading player in PET radiopharmaceuticals market in Hong Kong, HKCL will continue to support Government policies. Through technology upgrades, capacity expansion, and professional team training, the segment aims to further consolidate its market leadership position.

Building upon the strategic cooperation agreement signed with GE HealthCare for the local production of the 18F-Flutemetamol patented radiopharmaceutical for Alzheimer's disease detection, HKCL has signed a Memorandum of Understanding with radiation protection specialist Cnrayshield and has been appointed as its exclusive distributor in Hong Kong. This collaboration appropriately extends the service scope and further strengthens the completeness of the nuclear medicine industry chain. It also supports the Government's direction in medical safety and innovation development.

醫療科技與健康

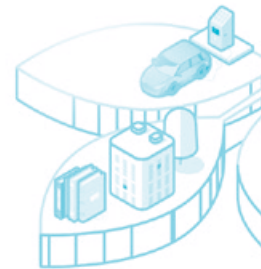

The second laboratory is scheduled to commence operations in the third quarter of 2026. This will significantly increase production capacity and enrich the product portfolio to cover a broader range of disease-related radiopharmaceuticals. Plans are also in place to develop special isotope applications, such as carbon-11 (C11) and gallium-68 (Ga68), to address market demand. While deepening its presence in the local market, HKCL will continue to explore expansion opportunities to achieve long-term stable growth.

Other Businesses

The Group will continue to explore potential business opportunities and seek strategic investment and partnership opportunities, with a particular focus on capturing growth trends within innovative technologies and green industries, injecting new momentum into our overall growth.

Conclusion

The Group will remain closely aligned with the National 15th Five-Year Plan, fully capitalising on its role as a “super connector” to integrate more deeply into the country’s broader development framework. The long-term objective is to establish the Group as a leading infrastructure and professional services provider in Asia. Active contributions will be made to the Northern Metropolis development and Greater Bay Area collaboration, while further expanding development opportunities across Hong Kong, Chinese Mainland, and Asian markets.

In alignment with the direction of the Government’s fiscal budget, which has substantially increased funding for innovative technology in the construction sector – including a HK\$1 billion injection into the Construction Innovation and Technology Fund and HK\$100 million allocated to the Hong Kong Institute of Construction Technology for research on building standards and AI applications – the Group will seize these policy initiatives and resources to accelerate technological adoption and industrial upgrading.

本集團將繼續發掘有潛力的業務機遇，尋求具戰略價值的投資及合作機會，重點把握創新科技及綠色產業的增長趨勢，為整體增長注入新動力。

總結

本集團將緊扣國家「十五五」規劃，以其「超級聯繫人」的角色更深度融入國家發展大局，並以成為亞洲具領導地位的基建及專業服務集團為長遠目標，積極參與北部都會區建設及大灣區協作，進一步開拓香港、中國內地及亞洲市場的發展空間。

配合政府財政預算方向，加大對建造業創新科技的支持，包括向「建造業創新及科技基金」注資10億港元，以及預留1億港元推動香港建築科技研究院就建築標準檢視及人工智能應用等方面的研究，本集團將把握有關政策方向及資源支持，加快推動科技應用與產業升級。

Innovative Technology Applications

The Group plans to establish an Innovation and Development Department, which will serve as a bridge between “innovation” and “implementation”. This department will be responsible for researching, designing, and deploying artificial intelligence and robotics applications, as well as coordinating cross-departmental efforts. All business segments will accelerate the exploration and adoption of innovative technologies at full speed, driving business diversification and digital transformation. Through the continuous development of new technologies and the expansion of technology application scenarios, the Group will further enhance overall operational precision and market competitiveness.

Sustainable Development

The Group remains committed to the firm implementation of sustainable development strategies and principles. In the Construction segment, the active promotion of green low-carbon building materials, sustainable design solutions, and MiC aims to reduce carbon emissions and enhance resource efficiency. Within the Professional Services segment, more efficient operating solutions will be introduced. In the Medical Technology and Healthcare segment, continued emphasis will be placed on radiation safety management, while the Non-franchised Bus Services segment will develop in line with low-carbon transportation initiatives. These measures not only echo the Government’s green development policies but also serve to establish long-term competitive advantages for the Group and create sustainable social value.

Drawing on its extensive industry experience, dedicated professional team, and well-defined strategic direction, the Group will drive progress with innovative technologies as a key enabler and sustainable development as a core foundation. The Group will continue to broaden its business scope, enhance its core competencies, and deliver superior long-term value to shareholders. At the same time, the Group is dedicated to supporting Hong Kong’s ambition to become an international innovation and technology hub and a liveable smart city, fostering mutual growth and shared prosperity between the Group and society.

INTRODUCTION

The Group is dedicated to maintaining a high standard of CSR. Employees, suppliers, clients, the natural environment and the general community are all our stakeholders influenced by the ways in which the Group transacts the business.

BOARD STATEMENT

The Group conducts a top-down management approach regarding its CSR issues. The Board takes overall responsibility for ESG matters, with reference to the United Nations' Sustainable Development Goals ("SDGs"), integrating the objectives, strategies, priorities and goals into the Company's operation. To support the Board's oversight and systematic management of the ESG issues including climate-related risks and opportunities, the ESG committee has been formed for identifying and assessing ESG related risks and opportunities and implement strategies, thereby improving ESG working mechanism. The ESG committee shall review and evaluate the adequacy and effectiveness of the management framework for ESG matters and provide ESG updates to the Board at least once a year.

Through the materiality assessment, we have addressed and prioritised ESG issues and potential climate physical and transitional risks that are both financially material to the Company and stakeholders. With our objectives of ensuring the Company's sustainability and introducing strategic decision making, the Board committed to develop an effective reporting framework to connect with the public, the Company prepared a CSR report and an ESG report annually.

As a responsible corporation, we recognise that compliance, health and safety, quality of work and climate change pose significant risks to our business, reputation and financial performance. Our working group is aware of the existing opportunities for innovation and thereby we drive the implementation of sustainability strategy and a wide range of measures including investment in renewable energy and safety innovation and implementation of our roadmap to green and low carbon construction. Our VMV (Vision, Mission & Core Values) clearly reflects the Group's corporate culture in the implementation of sustainable development.

To strengthen the credibility of the data of this report, we have engaged Accredited Certification International Limited as independent carbon verifier and conducted the verification with regard to the data of emissions and use of resources. This verification included evidence-based verification and comprehensive review on reported data, ensuring accuracy, consistency and reliability.

We also implemented different kinds of management systems and have arranged training courses on various international standards, e.g. ISO 14001:2015 Environmental Management System, ISO 45001:2018 Occupational Health and Safety Management System and ISO 50001:2018 Energy Management System to enhance sustainability performance.

Internally, we have always been committed to organising activities to promote ESG behaviours, for example, recycling workshops, "Green" public activities and becoming a "Green" volunteer, etc. We designated coloured recycling bins for different wastes and make them accessible to all employees. We also encouraged employees to share testimonials about resources conservation. In our construction sites, we developed advance technology and material to optimise construction process and safety working environment, and also encouraged our staff to rush to "Green" opportunities such as reusing or recycling of waste and waste management in order to achieve our environmental management practices and subject to continuous improvement.

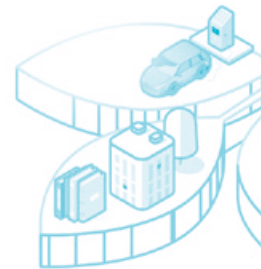

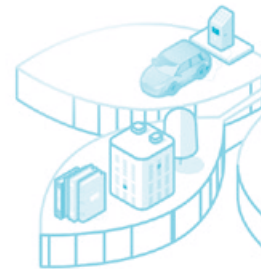

Our People

As at 31 March 2026, the Group had an estimated 8,265 employees, with the majority located in Hong Kong. In order to enhance the overall effectiveness of corporate governance, the Company has implemented a diversity policy aiming at promoting a diverse workforce, including management positions. The Company believes that diversity encompasses aspects, such as professional experiences, business perspectives, skills, knowledge, gender, age, cultural and educational background and ethnicity. The selection of employees is based on merit and the attributes that the shortlisted candidates can bring to the Group, in order to complement and expand the competencies, experience and perspectives, while considering the Group's vision, mission and core values.

In order to advance gender equality in the workplace and empower female employees to take on more significant roles within the Company, two distinct initiatives were launched: WomenLeaders@CW and Dream Girls. These programs aim to elevate the professional standing of women in the construction industry and enhance public perception of the field. Additionally, the establishment of the Chun Wo Ladies' Club (the "Club") serves to foster stronger connections among female employees and provide them with necessary support. Membership is opened to all female employees. The Club offers exclusive benefits, organises seminars and interest classes regularly, and provides subsidised body checks to its members. The Company is committed to increasing the representation of women in its workforce over time, ensuring a balanced gender diversity that aligns with stakeholders' expectations.

By integrating internationally-recognised ISO 9001, ISO 14001 and ISO 45001 certifications into our quality, environmental and occupational safety and health management systems respectively, the Group demonstrates our compliance with health and safety standards. The Group's "PDCA" system further ensures all individuals and teams exert themselves to meet the statutory requirements and to achieve the ultimate goal of continuous improvement.

We are aware of the significance of workplace safety. To maintain the occupational safety standards in our construction operations, we have introduced a safety audit system designed to monitor the effectiveness of our safety management system. For the year of 2025, the corporate average safety audit score — physical condition was 87.5% (2024: 86.9%), exceeding the target of 87.0%.



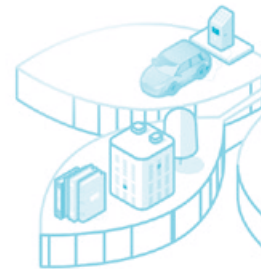
In 2025, all safety indicators were in line with our objectives. In particular, the target of the accident frequency rate of construction work within the past 5 years has been met, reflecting our dedication and achievements in construction site safety and excellent and consistent occupational safety performance.

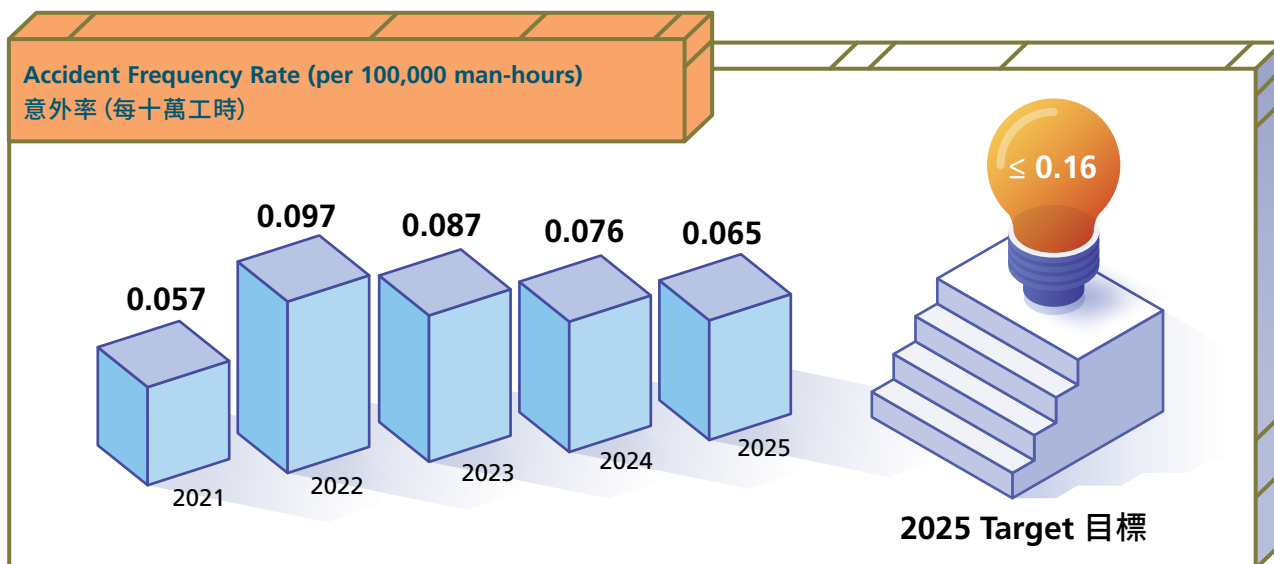

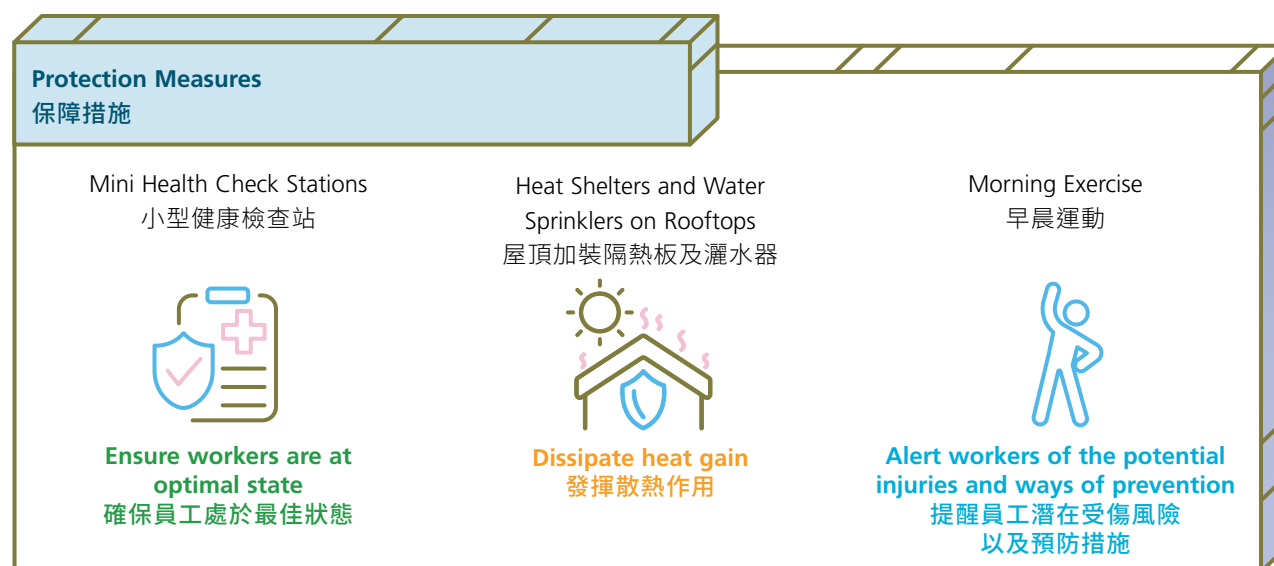

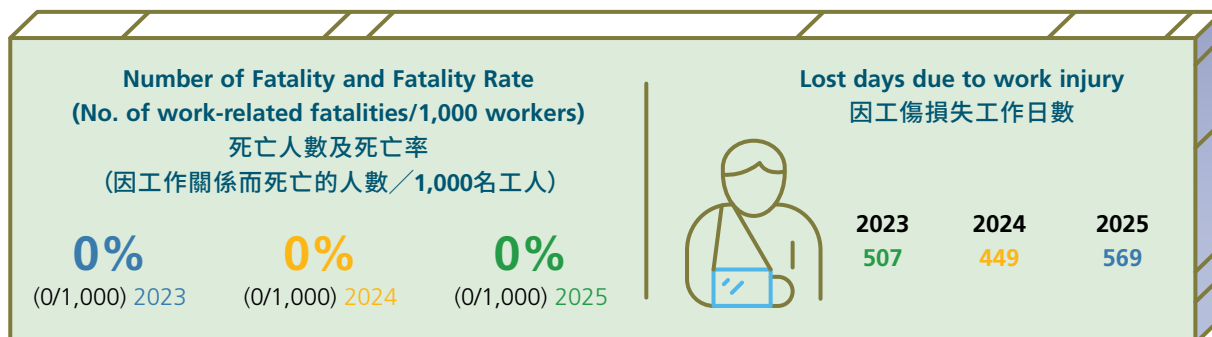

Staff's health and safety are always our top priority, therefore we applied the Zoono treatment regularly in our offices during the pandemic, which was effective against over 100 common pathogens, in order to protect our environmental safety by creating a long term sterile environment.

Health and Safety Policies

The safety and health of our employees are paramount to the Group. Our senior management team places a strong emphasis on prioritising the safety and health of our workforce. Our security and facility management divisions adhere to a well-structured management system and conduct annual audits to ensure alignment with international standards. The companies within these divisions have been accredited with ISO 45001 for their occupational health and safety management system by approved certification bodies.

Our non-franchised bus services division remains committed to complying with the Occupational Safety and Health Ordinance. In addition, we prioritise the provision of reasonable working hours for our drivers and ensure they are granted adequate rest time to maintain their positive spirits and overall welfare.

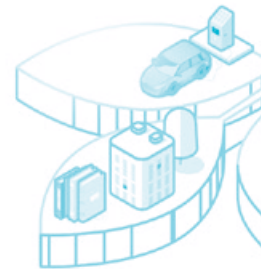

In 2025/2026, City Services Group, under the oversight of its Safety and ESG Committee, remained committed to maintaining a safe and healthy work environment. Key initiatives included the annual Health and Safety Campaign, featuring the Safety Quiz Award to enhance frontline staff engagement and awareness. To mitigate heat-related risks, particularly for outdoor and non-air-conditioned indoor workplaces, the Group adhered to the Labour Department's Guidance Notes on Prevention of Heat Stroke at Work, conducting risk assessments based on workload and environmental factors, and implementing appropriate rest breaks aligned with the Heat Stress at Work Warning levels.

The Group has implemented an effective occupational health and safety management system that complies with the Factories and Industrial Undertakings (Safety Management) Regulation and meets the requirements of ISO 45001. The safety policy of the Group outlines the related guidelines.

Our objective is to meet all applicable health, safety, and environmental protection regulations while ensuring a safe working environment for our employees. To accomplish this objective, we encourage all employees to assume responsibility and adhere to the established systems, policies, manuals, procedures, and working rules. This includes wearing personal protective equipment and promptly reporting any violations of regulatory requirements or orders.

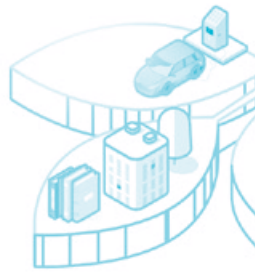

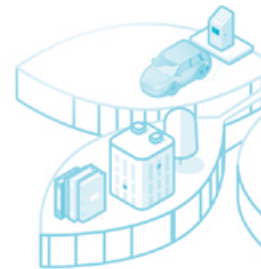

Safety Activities

To ensure the continuous improvement of occupational safety and health standards, we have developed an evaluation questionnaire to collect feedback from the participants of all meetings, seminars and forums.

The Group encourages employees to participate in occupational safety and health activities and voluntary services and share expertise and information not only with colleagues but also fellow workers in the Hong Kong construction industry. To actively promote the awareness of occupational safety throughout the Group, a range of safety activities, including safety workshops, special safety seminars and community activities, were organised during the Year.

A safety training centre called “Chun Wo Safe Zone” has been established which consists of 5 training zones to simulate the major causes of accidents at construction sites. Participants can enhance their safety awareness and improve their work safety behaviour by attending the “Behavioural Change Safety Training” (“BCST”). All Chun Wo employees and subcontractors’ workers, who work on site, must be the holder of valid certificate of BCST.

The Group has also adopted a centralised toolbox training called “Web Talk”, which is an occupational safety and health, quality and environmental training targeted for frontline workers and supervisors for duration of not more than 15 minutes on each topic related to different construction site activities, which conducted by respective staffs of head office’s Compliance Department every week via the video conferencing.

Through these activities, all participants have improved their awareness and knowledge of occupational safety and health, quality and environmental. Furthermore, they exchanged ideas and helped to promote the occupational safety and health, quality and environmental culture in the Group.

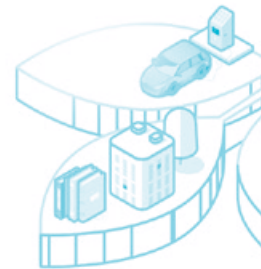
為確保持續提升職業安全及健康標準，我們已編製評價調查問卷，於每次會議、研討會及論壇中向參與者收集反饋意見。

本集團鼓勵員工參與職業安全及健康活動及志願服務，並與同事以及香港建造業界的工友分享專業知識及資訊。我們積極在本集團推動職業安全意識，於本年度舉辦了多項安全活動，包括安全工作坊、特別安全研討會及社區活動。

本集團已成立安全培訓中心「俊和安全地域」，當中包括5個培訓區，模擬建築地盤意外事故的主要成因。參與者可通過參加「安全行為改善訓練課程」（「安全行為改善訓練課程」）提高安全意識並改善工作安全行為。所有於地盤工作的俊和僱員及分判商工人均須持有有效的安全行為改善訓練課程證書。

本集團亦已採用名為「網絡講座」的中央工具箱進行培訓，其針對前線工人及主管的職業安全及健康、質量及環境培訓，每項培訓時間不超過15分鐘，主題與不同建築地盤活動有關，並由集團總部合規部門的相關人員每週通過視像會議進行。

通過上述活動，所有參與者均提升職業安全及健康、質量及環境意識以及增進相關知識。此外，他們交流意見，並協助於本集團內宣揚職業安全及健康、質量及環境文化。

Compliance with Employment Laws

We have adopted the comprehensive Employee Handbook for employees of the Group and review the policies from time to time to ensure that we comply with the Employment Ordinance in respect of employment protection and benefits for employees. Our human resource functions of different business units also observe the departmental manuals so as to ascertain that they adhere to legal and regulatory requirements throughout the recruitment process, and to avoid the employment of illegal labour or child and forced labour.

During the Year, the Group did not identify any non-compliance cases involving illegal labour or child and forced labour, and complied with all relevant laws and regulations relating to employment and labour practices.

(II) ENVIRONMENTAL PROTECTION

Environmental Stewardship

In view of the growing greenhouse effect and climate change, energy conservation, carbon reduction and minimising pollution have become global issue that could affect any one of us. As a responsible corporate citizen, the Group has established policies and measures to minimise pollution, efficiently utilise energy, reduce waste and expand recycling practices in our operation. Risk-based thinking, lifecycle perspective and mitigation have been incorporated into our management system to address the latest environmental challenges. The Group has established effective environmental management systems in compliance with internationally-recognised ISO 14001 and ISO 50001 standards. Committed to the core values of the Group, we have become the members of various environmental protection groups and actively supported these organisations.

The Company has adopted the climate change policy, which outlines the commitment of the Company to address the climate challenges by minimising pollution and protecting the environment by reducing waste generation and carbon footprint and enhancing recycling; making efficient use of resources; providing and promoting green building solutions and methodologies; and supporting the adoption of renewable energy to reduce the carbon footprint, etc.

We developed a “Chun Wo Environmental Handbook” and distributed to all project staff from management to frontline level. This handbook summarises the Group’s environmental policy, local statutory requirements and related mitigation measures which act as “one stop” guidelines to facilitate staff to deliver our services and products across a wide spectrum of compliance and risk management matters.

鑒於溫室效應及氣候變化加劇，節能、減碳及減少污染已成為與我們息息相關的全球議題。作為盡責的企業公民，本集團已制訂政策及採取措施，在營運過程中減少污染、有效使用能源、減廢及擴展回收措施。我們已於管理系統融入風險為本的思維、生命週期觀點及緩減措施，以解決最新的環境挑戰。本集團已按照國際認可的ISO 14001及ISO 50001標準，設立有效的環境管理系統。我們已加入多個環保團體成為會員並積極支持有關團體，致力實踐本集團的核心價值。

本公司已制定氣候變化政策，其載述本公司透過減少廢物產生和碳足印及提高循環再造以減少污染及保護環境；有效使用資源；提供及推廣綠色建築解決方案及方法；及支持採用可再生能源，以減少碳足印等方式以應對氣候挑戰之承諾。

我們已制定「俊和環境手冊」並派發予管理層至前線的所有項目員工。該手冊概述本集團的環境政策、本地法例要求及相關緩解措施，作為「一站式」指引，促進員工在涉及廣泛的合規及風險管理事宜的情況下提供服務及產品。

Climate change presents both physical and transition challenges that may affect the Group's operations and long-term resilience. During the Year, the Group identified and evaluated climate-related risks and opportunities that may affect its cash flows, access to financing, and cost of capital over three time horizons: short term (1–3 years), medium term (4–6 years), and long term (7 years or more). These timeframes are consistent with the Group's overall strategic planning cycles. In assessing these risks and opportunities, the Group referred to the strategy and resilience requirements under IFRS S2, taking into account the potential impacts of both climate-related physical risks and transition risks on its operations and business activities.

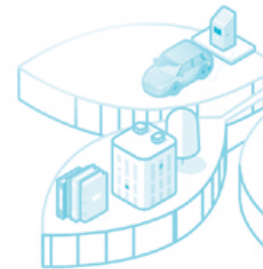

The Group incorporates climate-related risks and opportunities into its strategic and operational planning processes. Low-carbon initiatives and climate resilience considerations are currently integrated into project planning and day-to-day operations. While the Group has not yet established a formal climate transition plan, it intends to develop one in the future. Resource availability is monitored internally and is presently adequate to support both adaptation and mitigation efforts. In addition, the Group has established a Board-level ESG Committee responsible for reviewing ESG-related resources, training programmes, and staff competencies, as well as making recommendations for improvement to the Board.

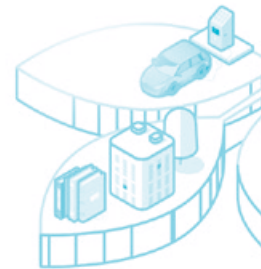
The Group acknowledges the potential current and future financial implications arising from climate-related risks and opportunities. During the Year, the Group reviewed the financial effects of the climate-related matters identified above. Measures implemented to address extreme heat—such as the provision of cooling shelters, ventilation equipment, cool drinking water, and sun protection gear (e.g. cooling vests and neck shades) for site workers—were incorporated into standard health and safety practices. These initiatives did not have a material impact on the Group's financial position, performance, or cash flows. No significant adjustments to the carrying amounts of assets or liabilities are expected in the next reporting period as a result of the identified climate-related factors. As the Group continues to enhance its capabilities in managing climate-related risks and opportunities, it plans to undertake climate-related scenario analysis to evaluate potential financial impacts across the short, medium, and long term. This will include: (i) assessing changes to the Group's financial position, taking into account future investment and disposal plans as well as anticipated funding sources; and (ii) evaluating potential effects on financial performance and cash flows. The Group will continue to monitor market developments and evolving methodologies for estimating anticipated financial impacts and aims to provide more detailed disclosures in the future. The Group also recognises the importance of assessing the resilience of its business strategy and model to climate-related changes, developments, and uncertainties, with a focus on the climate-related risks and opportunities identified above.

本集團將氣候相關風險與機遇融入其策略及營運規劃流程。低碳措施及氣候韌性考慮因素目前已納入項目規劃及日常營運之中。雖然本集團尚未制定正式的氣候轉型計劃，但擬於未來制定有關方案。內部會監察資源的可用性，而現時資源足以支持適應及緩解工作。此外，本集團已設立董事會層級的環境、社會及管治委員會，負責檢討環境、社會及管治相關資源、培訓計劃及員工能力，並向董事會提出改善建議。

本集團認知到氣候相關風險與機遇可能帶來當前及未來的財務影響。於本年度，本集團檢討了上述已識別的氣候相關事宜的財務影響。為應對極端高溫而實施的措施—例如為工地工人提供避暑場所、通風設備、清涼飲用水及防曬裝備（例如降溫背心及頸部遮陽罩）—已納入標準的健康與安全實務之中。該等措施並未對本集團的財務狀況、表現或現金流量構成重大影響。預期在下一個報告期間，不會因已識別的氣候相關因素而對資產或負債的賬面值作出重大調整。隨著本集團持續提升管理氣候相關風險與機遇的能力，本集團計劃進行氣候相關情境分析，以評估短期、中期及長期的潛在財務影響。這將包括：(i) 評估本集團財務狀況的變動，同時考慮未來的投資及處置計劃以及預期的資金來源；及(ii) 評估對財務表現及現金流量的潛在影響。本集團將繼續監察市場發展及估算預期財務影響的評估方法，並致力於未來提供更詳細的披露。本集團亦確認評估其業務策略及模式對氣候相關變化、發展及不確定因素（重點聚焦於上述已識別的氣候相關風險與機遇）的韌性的重要性。

During the Year, the Group identified climate-related transition risks, physical risks and opportunities. Based on its current risk mitigation measures and assessment outcomes, no assets or business activities were considered to be materially affected. The Group will continue to monitor these climate-related risks and opportunities and, where appropriate, provide relevant quantitative disclosures in future reports.

The greenhouse gas emissions are calculated in accordance with the Greenhouse Gas Protocol: A Corporate Accounting and Reporting Standard (2004) and the Greenhouse Gas Protocol: Corporate Value Chain (Scope 3) Accounting and Reporting Standard (2011). The Group adopted the equity-share approach in disclosing environmental data to more accurately reflect its proportionate share of the environmental impacts attributable to its associates. During the Year, the Group included Scope 3 emissions disclosures: Category 1 (Purchased goods and services) emissions amounted to 22,955 tonnes CO₂e, Category 5 (Waste Generated in Operations) emissions amounted to 11,778 tonnes CO₂e and Category 6 (Business Travel) emissions amounted to 27 tonnes CO₂e. The other categories are not included as they are irrelevant to our business or account for a small share of total emissions or data are unavailable and unreliable for quantification. We recognise that there are still data gaps within the data reported and aim to expand our data disclosure for other categories in the future.

During the Year, the Group continued to allocate resources to initiatives aimed at addressing climate-related risks and opportunities. These initiatives included investments in battery energy storage systems to replace traditional diesel generators, electrified site vehicles, and the deployment of solar photovoltaic panels at our site offices, as well as research and development relating to low-carbon construction materials and smart energy-saving IoT applications. The related capital expenditure was not significant to the Group's financial position during the Year.

The Group has not yet established a formal climate-related transition plan or set quantitative climate-related targets, nor has it conducted scenario analysis during the Year. The Group plans to incorporate scenario analysis into future assessments of climate-related risks and opportunities. The Group has not applied an internal carbon pricing mechanism or linked its remuneration policy to climate-related considerations. We will explore the adoption of these measures, as well as the establishment of quantitative climate-related targets, in the coming years.

於本年度，本集團已識別氣候相關的轉型風險、物理風險及機遇。根據現有的風險緩解措施及評估結果，並無資產或業務活動被視為受到重大影響。本集團將持續監察該等氣候相關風險及機遇，並在適當情況下，於日後報告中提供相關的量化披露。

本集團根據《溫室氣體核算體系：企業核算與報告標準（2004年）》及《溫室氣體核算體系：企業價值鏈（範圍3）核算與報告標準（2011年）》計算溫室氣體排放。本集團採用權益份額法披露環境數據，以更準確地反映其應佔聯營公司環境影響的比例份額。於本年度，本集團納入了範圍3排放的披露：類別一（購買貨品及服務）排放量為22,955噸二氧化碳當量，類別五（營運產生的廢棄物）排放量為11,778噸二氧化碳當量，類別六（商務差旅）排放量為27噸二氧化碳當量。其他類別未予納入，原因為其與我們業務無關、在總排放量中佔比較小，或缺乏可用且可靠的數據進行量化。我們認識到已報告數據中仍存在數據缺口，旨在未來擴展其他類別的數據披露。

於本年度，本集團持續分配資源至旨在應對氣候相關風險及機遇的舉措。該等舉措包括投資於電池儲能系統以取代傳統柴油發電機、工地電動車輛，以及在我們的地盤辦公室部署太陽能光伏板，以及有關低碳建築材料及智慧節能物聯網應用的研發。相關資本開支對本集團於本年度的財務狀況而言並不重大。

於本年度，本集團尚未制定正式的氣候相關轉型計劃，亦未設定量化的氣候相關目標，亦未進行情境分析。本集團計劃將情境分析納入未來氣候相關風險與機遇的評估之中。本集團並未應用內部碳定價機制，亦未將其薪酬政策與氣候相關考慮因素掛鉤。我們將在未來數年探索採納該等措施，以及制定量化的氣候相關目標。



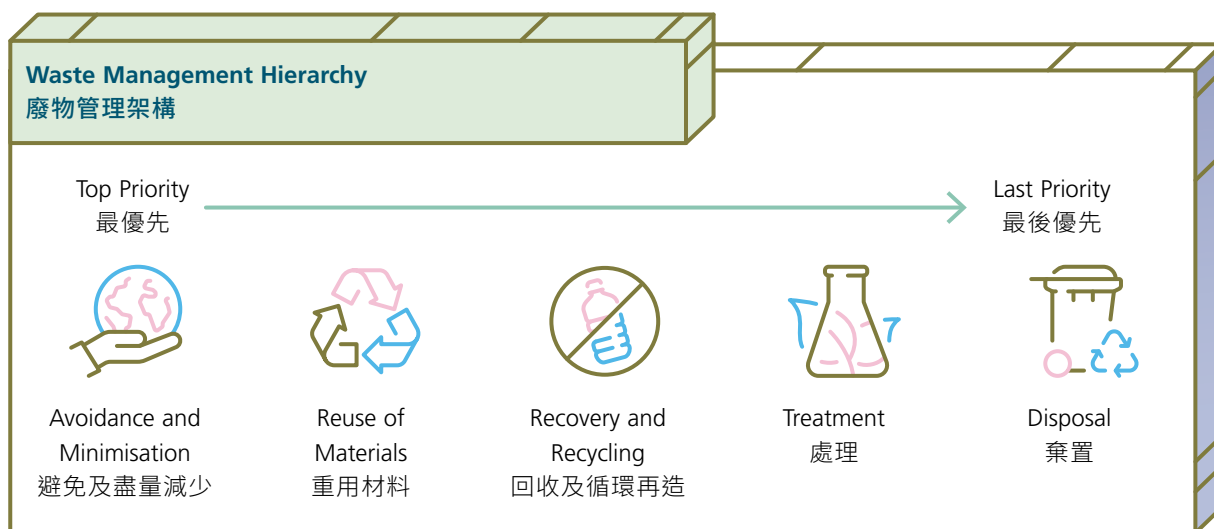

With the continuation of our environmental protection measures, in view of the current business environment and nature and period of construction project, the Group targets to achieve a 5% drop in emissions and resources used per HK\$ million revenue for every five financial years commencing from the financial year of 2021.

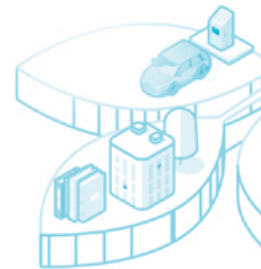

"The Producer Responsibility Scheme on Waste Electrical and Electronic Equipment" covers air-conditioners, refrigerators, washing machines, television, computers, printers, scanners and monitors, our suppliers must be registered with Environmental Protection Department ("EPD") before distributing the above listed equipment. Our supplier must fulfill other statutory obligations such as the periodic submission of returns to the EPD, payment of recycling levies and providing recycling labels when distributing regulated electrical equipment.

The Mercury Control Ordinance aims to fully implement the Minamata Convention on Mercury in Hong Kong, with a view to protect human health and the environment from anthropogenic emissions of mercury and mercury compounds. The Company has strictly complied with the relevant ordinance when dealing with the pollutant. In addition, infrequent hazardous waste from demolition of old structures or equipment (e.g. asbestos), which accounted for less than 0.001% of the total waste generated has been separated and treated in accordance with local regulations.

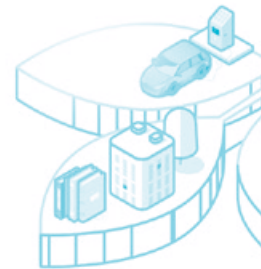

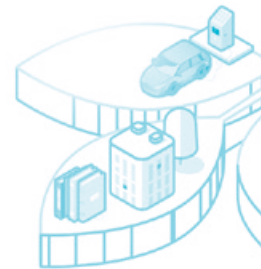

Digitisation of Environmental Data

In our civil engineering and building construction projects, environmental data digitisation has become increasingly popular. This trend allows us to minimise human error raised from data processing and provide instant feedback for our staff to response timely on the project's emission and waste figures. Meanwhile, the digitised environmental data can be made public, which can increase transparency in emission and waste generation. We therefore developed a carbon emission platform and implemented in projects, this platform would be connected with IoT sensors on site and allows us to consolidate the related real time carbon emission, moreover, based on the data we collected and we can review and make improvement on the carbon emission performance from time to time.

We also understand the importance of creating a culture of innovation and collaboration in the construction industry. We have successfully collaborated with government, institutions and other stakeholders to explore the innovative environmental approaches such as:

- Collaboration with EPD for the CEasy System for Electronic Chit Ticket System Pilot Scheme
- Collaboration with Lingnan University for Smart Intelligent GeoAI Mosquito Killer Device
- Collaboration with Hong Kong Construction Association for "ESG Recognition Scheme" and "Carbon Smart Scheme"

Environmental Performance

The Group has established a comprehensive group-wide carbon audit system which extended the scope of carbon audit to monitor emission data of different business units under the Group. The Group has developed policy of controlling greenhouse gas emission, and managing our fuel and electricity usage through deployment of high efficiency equipment for better use of resources.

The Group supports low carbon construction and is a signatory member of "Low Carbon Charter" of Business Environmental Council. We support greater use of electric plant and equipment and low carbon alternative fuels (e.g. biodiesel) where electrification is not possible. We use B5 biodiesel, renewable energy system (e.g. solar power) and mass battery energy storage to reduce carbon emission from sites.

環境數據數碼化

在我們的土木工程及樓宇建築項目中，環境數據數碼化愈趨普及。此趨勢使我們能夠減少因數據處理造成的人為錯誤，並向員工提供即時反饋以便及時應對項目排放及廢物數據。同時，數碼化的環境數據可供公眾查閱，增加排放及廢物產生的透明度。因此，我們開發了一個碳排放平台，供各個項目採用，此平台將與現場的物聯網感應器連接，讓我們可以整合相關的即時碳排放數據，亦可以根據我們收集的數據不時檢視及改善碳排放績效。

我們亦理解在建築界締造創新合作文化的重要性。我們成功與政府、機構及其他持份者合作，探索創新的環保方針，例如：

- 與環保署合作推行電子載運入帳票系統先導計劃築好運系統
- 與嶺南大學合作開發智能GeoAI滅蚊裝置
- 與香港建造商會合作推行「可持續發展嘉許計劃」及「碳智能計劃」

環保績效

本集團已設立全面涵蓋集團整體的碳審計系統，並將碳審計範圍擴展至監測本集團不同業務單位的排放數據。本集團已制定控制溫室氣體排放的政策，以及透過安裝高效設備管理燃料使用量及用電量，促進資源運用得宜。

本集團支持低碳建築，並簽署加入商界環保協會的《低碳約章》。在不容許電氣化的情況下，我們支持提高發電廠及設備以及低碳替代燃料（如生物柴油）的使用率。我們使用B5生物柴油、可再生能源系統（如太陽能）及大規模的電池儲能，以減少工地產生的碳排放。

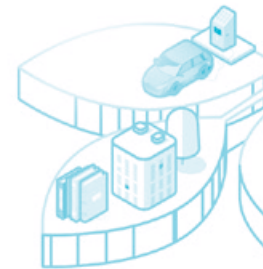

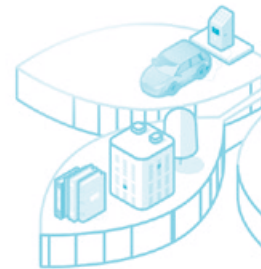

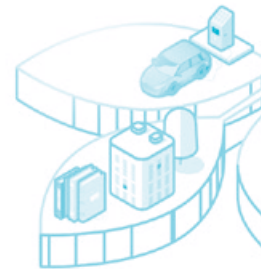

We are committed to solving problems by intelligence and fulfil customer satisfaction by developing and adopting innovation and technology in operation and providing high quality products and services, with complying with internationally recognised standards, endeavoring to be a dynamic and responsible enterprise.

Innovation

We are dedicated to developing innovation technologies for construction. In 2016, we launched our innovation brand “Inno@ChunWo”, with an aim to elevate construction techniques and at the same time attract a younger generation to start their career in innovation and construction.

Our successful research and development outcomes can be categorised into five main area, including “Off-Site Construction”, “Advanced Technology & Materials”, “Robotics and Automation”, “Digital Transformation – Smart Site” and “E-procurement”.

“Off-Site Construction”

Our company has successfully adopted innovative MiC technology, which represents a state-of-the-art construction method that intensively speeds up our projects’ operations while enhancing productivity, safety and sustainability.

創新

“Off-Site Construction” (Continued)

To further enhance our MiC capabilities, we have developed a comprehensive modular system, which includes our patented “Wall Connection Technology” in collaboration with a joint venture partner. Such breakthrough technology has successfully overcome the limitations of traditional construction and MiC technology by reducing wall thickness to meet the market’s demand for larger living spaces. This more cost-effective and utilisable technique not only speeds up the construction process but also enhances the quality of the final product. Our commitment to adopting and enhancing MiC technology demonstrates our dedication to environmental sustainability and social responsibility.

“Advanced Technology & Materials”

We have worked with Nano and Advanced Materials Institute to develop the Rapid Repair Mortar Material (“R²M²”), which can be deployed in buildings to quickly repair areas of concrete spalling. R²M² contains stainless steel fibres which can recover the lost loading capacity of corroded rebar and resist tensile loads for slabs. This technology eliminates the need for rebar lapping and good concrete breaking, surpassing the conventional repair method in terms of cost and time. With this time-saving repair method, we can reduce the volume of concrete breaking, produce less noise, dust and construction waste, and minimise the impact to users of the building and nearby residence.

“Robotics and Automation”

A research project with The Chinese University of Hong Kong on “Hybrid Cable-Driven Serial Robot for Exterior Facade Window Cleaning and Wall Painting” is able to assist the building services industry. Such technology may tackle the issue arisen from the increasing demand and lack of workers, high number of workers approaching retirement, labour intensive and hard work, dangerous and harsh conditions, and increase quality and lower costs. Besides, following the development of cable robot, we are able to prevent accidents by automating or remotely controlling risky exterior facade works.

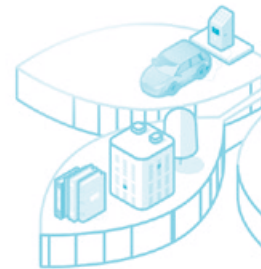
為了進一步提高我們的組裝合成建築法能力，我們已開發全面的模塊式系統，其中包括我們與一位合作夥伴合作的專利「牆壁連接技術」。此項突破性技術成功克服傳統建築及組裝合成建築法技術的局限性，通過減少牆壁厚度來滿足市場對更大生活空間的需求。該技術更具成本效益及可利用性，不僅加快施工進度，亦可提高製成品的品質。我們致力於採用及加強組裝合成建築法技術，展現我們在實踐環境可持續性及社會責任的奉獻及努力。

「先進技術及材料」

我們與納米及先進材料研發院合作開發快速修補砂漿材料（「R²M²」），該材料可運用於建築物上，以快速修復混凝土剝落的區域。R²M²含有不銹鋼纖維，可恢復鏽蝕鋼筋失去的承載力，並為板材抵禦拉伸載荷。此項技術消除了鋼筋搭接及良好的混凝土破損的需要，在成本及時間上超越了傳統的修復方法。通過該節省時間的修復方法，我們可以減少混凝土的破損量，減少產生噪音、灰塵及建築廢料，並將對建築物的用戶及附近住宅的影響降至最低。

「建造機械化」

我們與香港中文大學合作的研究項目「用於外牆窗戶清洗及牆面粉刷的混合電纜驅動的串聯機器人」，有助協助建築服務行業。該技術可有助解決工人需求的不斷增加及短缺、大量工人即將退休、勞動密集及艱苦的工作、危險及惡劣環境問題，以及可提高品質及降低成本。此外，隨著電纜機器人的發展，我們能夠通過自動化或遠端控制有風險的外牆工程以防止事故發生。

“Digital Transformation – Smart Site”

We are actively researching smart site and related hardware and systems to reduce environment and health impacts, several examples are as follows:

- Environmental Monitoring System: Internet of Things sensors to detect surrounding environment and automate deployment of countermeasure systems to reduce impacts to nearby residents and workers
- Auto detecting the site working environment e.g. temperature, humidity, dust and noise level
- Automatically switch on/off the sprinklers and cooling fan when the figures are above/below the limit
- Confined Space Monitoring System
- Check status of worker, harmful gas monitoring, temperature monitoring and real-time alert system

“E-procurement” & Project Document Management

Mattex Asia Development Limited, a subsidiary of the Company, has launched an online construction material procurement and project document management platform called “eMat”. It has been adopted by multiple construction projects to digitally transform their submission documents and material procurement procedures throughout their projects. The platform included different modules brings together developers, consultants, main contractors, sub-contractors and suppliers for all-rounded material management. It fully utilises cloud data processing mode as well as mobile application, enabling users to centrally manage different stages of material, from getting material approval by clients, obtaining all purchase requests from projects, confirming orders with suppliers, arranging delivery, recording goods receipt and reconciling invoice.

Through the utilisation of our Submission Management Module, contractor team can centrally store relevant content to a submission on our scalable cloud solution. Readied submission documents are transmitted to its target audience in digital form, along with its electronic Document Management System integration, has eliminated the need for projects to deliver these documents via paper-based mediums, while improving the efficiency and transparency amongst project participants.

我們正在積極研究智能工地及相關硬件及系統，以減少對環境及健康的影響，例子如下：

- 當數值高於／低於限值時，自動打開／關閉噴水器及冷卻風扇
- 密閉空間監控系統
- 檢查工人的狀態、有害氣體監測、溫度監測及實時警報系統

「電子採購」及項目文件管理

本公司之附屬公司材迅亞洲發展集團有限公司推出了名為「eMat」的在線建築材料採購和項目文件管理平台。eMat已被多個工程項目採用，以數碼化各項目的物料審批文件和物料採購流程。該平台內包含了不同模組連繫著發展商、顧問、總承建商、分判商及供應商以進行全方位的物料管理。平台充分利用雲端數據處理模式和手機應用程式，使各用家能集中管理物料的各個階段，從客戶審批物料、獲取項目所有採購申請、與供應商確認訂單、安排發貨、記錄收貨，以至核對發票。

通過利用我們的物料審批管理模組，承建商團隊可以在我們的可擴展雲端解決方案上集中儲存與提交相關內容。完整的審批文件可以數碼形式傳送至其目標受眾，再加上電子文件管理系統的配合，項目之間不再需要通過紙質媒介傳閱這些文件，同時亦提高了項目參與者之間的效率和透明度。

To help identify green products during the material procurement process, our Transaction Management Module has provided key features for suppliers to identify which one of their products being green certified, and the official certification can be uploaded and published to the platform, to allow it to be shortlisted when purchasers seek for eco-friendly materials.

Supply Chain Management

We recognise that supply chain management is essential to operational efficiency and therefore work closely with suppliers and contractors to effectively and efficiently meet our clients' needs, while emphasising responsible operating practices.

The Group is stringent in selecting qualified suppliers, ensuring that their entire production process is in line with our standards and specifications. Not only do we require our new suppliers to submit all relevant documents for review, we also run background checks to evaluate their reliability. We conduct regular inspections and evaluations to review the standards of our suppliers and cease cooperation with unqualified suppliers. We are committed to developing and maintaining effective and mutually fruitful working relationships throughout our entire supply chain.

The Group also puts forward new requirements on the products and services provided by suppliers are up to the international standard in terms of quality and environmental protection, motivating the suppliers to formulate appropriate environmental policies and promoting energy-saving emission reduction and low-carbon production. Regular meetings between the Group and suppliers would be held for communicating and sharing the experience of environmental protection.

During the Year, the transacted suppliers engaged by the Group in Hong Kong, the PRC and overseas are 564, 20 and 2 respectively.

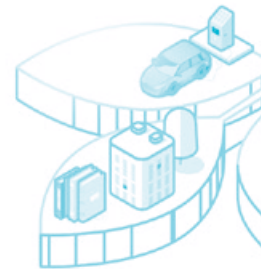

Product/Service Responsibility

We understand that good quality products and services are keys to success and enhance our competitive edge. Based on this belief, the Group has established the Quality Management System embedded with risk-based thinking, life-cycle perspective and mitigations. Such system is implemented by reliable business teams, ensuring the quality of our products and services as well as efficiently handling of all queries from our clients. The heads of individual divisions discuss any particular incident related to our products and services with the relevant division managers, project managers, supporting departments and committees. They share their views regarding various aspects of good standards and statutory compliance. Corresponding improvement plans are set out and implemented across all levels. The senior management also regularly conducts reviews with business units and takes necessary precautionary measures whenever applicable.

We maintain reliable electronic and hard copy recording systems at various stages, including material delivery notes, origin certificates, method statements, traceability records, inspection and testing reports, etc., to facilitate any needs for a recall. Recall procedures are traced through our recording system to obtain relevant information to make decisions on any further action that may be necessary.

The Group implements stringent quality control measures including detailed operational flows and procedures, project management and staff training to ensure that we deliver high quality services to our clients. In recognition of our quality assurance, our various subsidiaries have been accredited with ISO 9001 quality management system standard and ISO 10002 customer management system standard to sustain our business position. Through the ISO 9001 quality management system and ISO 10002 customer management system, the internal and external factors are determined to support the Group's strategic direction.

Applicable laws and regulations governing property development and assets leasing are being complied with, and practices are being conformed to those promulgated by Lands Department, Buildings Department and Planning Department. In property development projects, from design to after-sales care, health and safety considerations are taken into account and that the Group is committed to the delivery of high-quality products and services to the satisfaction of customers.

To address regulatory requirements in the context of property sales, in addition to internal staff members, external legal advisors and professional consultancy firms are appointed to advise on the compliance of relevant laws and regulations, particularly the Residential Properties (First-hand Sales) Ordinance which regulates the provisions of sales brochures, promotional advertisements, price lists, show flats, viewing of properties, sales arrangements, execution of agreements, register of transactions and the like, as well as observance and performance of the conditions set out in the Land Grant and/or the pre-sale consent under the Lands Department Consent Scheme.

Our security and facility management divisions, City Services Group, also adopt control measures in respect of routine operations and comply with the relevant laws and regulations, especially the license requirements under the Property Management Services Ordinance (Cap. 626) and Security and Guarding Services Ordinance (Cap. 460), in order to ensure efficiency, quality assurance and uniformity of performance. During the Year, the divisions received several awards in the aspects of property safety management and security services, which affirms our efforts in maintaining occupational safety and health and our professionalism in the industries.

In the view of the feedback from customers, we treat it seriously and view it as means to consistently improve the quality of our products and services we offer. The Group has standard procedures in place to deal with the client's feedback. Upon receiving any feedback, the Group, subject to the situation, will take action and keep track of its settlement, ensuring every feedback being handled properly. During the Year, the Group was not aware of any cases of complaints or products recall related to safety and health reasons.

Intellectual Property Rights

The Group is committed to ensuring the intellectual property rights throughout its course of operation. We primarily rely on the intellectual property laws in Hong Kong, confidentiality agreements and internal policies to protect all intellectual property related to the Group and operations. The employee handbook stipulates the code and provision that require our employees to comply.

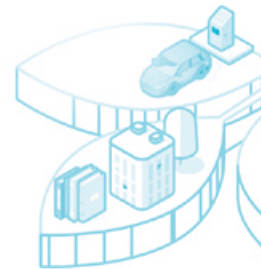
針對有關物業銷售的監管規定，除內部員工外，我們委聘外部法律顧問及專業顧問公司以就遵守有關法例及法規提供意見，特別是一手住宅物業銷售條例（該條例規管售樓說明書、宣傳廣告、價單、示範單位、參觀物業、銷售安排、簽立合約、成交紀錄冊等事項），以及遵守及履行批地檔及／或地政總署預售樓花同意方案下預售同意書所載條件。

我們的保安及設施管理分部城市服務集團亦就日常營運採取監控措施，並遵守有關法律及法規，尤其是第626章《物業管理服務條例》及第460章《保安及護衛服務條例》下的牌照要求，以確保高效、優質及貫徹的表現。於本年度，該等分部於物業安全管理及保安服務方面獲得多個獎項，肯定了我們於維護職業安全及健康方面的努力以及我們於行業中的專業精神。

我們認真看待客戶的意見，並視之為持續改善所提供產品及服務質素的方式。本集團已制定標準化流程處理客戶的意見。當接獲任何意見時，本集團會因應情況採取行動及跟進有關事件的處理情況，確保每個意見均得到妥善處理。於本年度，本集團並不知悉任何涉及安全及健康理由的投訴個案或產品召回。

Intellectual Property Manager Scheme

City Services Group has enrolled in the Intellectual Property Manager Scheme organised by the Intellectual Property Department to enhance our intellectual property manpower capacity and grasp the opportunities brought by intellectual property trading. By enrolling in the Intellectual Property Manager Scheme, we have taken a proactive step towards enhancing our intellectual property management capabilities. We have appointed a dedicated in-house intellectual property manager who has completed the training course and is responsible for overseeing our intellectual property assets.

Data Protection and Privacy Policies

Our privacy protection policy strictly prohibits all employees from revealing any confidential information, including customer data. To ensure the security and prevent any misuse or abuse, access to consumer data, project-related information, and other sensitive data is controlled through access rights. The Group consistently adheres to the Personal Data (Privacy) Ordinance and regularly reviews our personnel and business practices to ensure compliance.

In 2020, the Information Security Policy was introduced to govern the Company's information, comprising a collection of regulations focused on securing the Company's information and data.

Anti-corruption

The Group places great importance on honesty, integrity, and fair play as they greatly contribute to the value of our assets and business. It is crucial for all employees to uphold these values and ensure that the Group's reputation remains untarnished by dishonesty, disloyalty, or corruption. To prevent any violation of the Prevention of Bribery Ordinance, we have implemented various policies and guidelines.

Employees must refuse any gifts that could compromise their objectivity in conducting the Group's business, lead them to act against the Group's interests, or result in allegations of impropriety. If an employee wishes to accept a gift exceeding the limit stated in our Employee Handbook, they must obtain written permission from the managing director of their subsidiary or the Group. Any employee who violates the code of conduct outlined in the Employee Handbook will face disciplinary action, including termination.

知識產權管理人員計劃

城市服務集團參與了由知識產權署舉辦的知識產權管理人員計劃，以提升知識產權人員的能力及把握知識產權買賣帶來的機遇。參與知識產權管理人員計劃後，我們已採取積極步驟提升知識產權管理能力。我們已委派一名已完成培訓課程的專責內部知識產權管理人員，負責監督我們的知識產權資產。

資料保護及私隱政策

我們的私隱保護政策嚴禁所有僱員披露任何保密資料，包括客戶資料。為確保資料安全及防止任何濫用或不當使用，我們通過取覽權限控制對客戶資料、項目資料及其他敏感資料的取覽。本集團始終遵守個人資料（私隱）條例，並定期檢討人事及業務常規以確保合規。

於2020年，我們引入了資訊安全政策來規管本公司之資料，其中包括一系列針對保護本公司資訊和資料的規定。

反貪污

本集團高度重視誠實、廉潔及公平競爭，因為它們對我們的資產及業務的價值貢獻尤深。所有僱員必須維護這些價值觀以確保本集團的聲譽不會因欺詐、不忠或貪污而受損。為了避免任何違反防止賄賂條例的事件，我們已經實施多項政策及指引。

員工必須拒絕任何可能會影響僱員處理本集團業務的客觀性、誘使其行事損害本集團的利益或引致不正當行為的指控的饋贈。如僱員有意接受金額超過僱員手冊所列上限的饋贈，須向特定附屬公司或本集團的董事總經理尋求書面許可。任何僱員如違反僱員手冊內的操守準則，均須接受紀律處分，包括終止僱用。

Anti-corruption *(Continued)*

To ensure that our staff fully understands the importance of anti-corruption measures, we provide continuous education through internal memos during seasonal festivals. These memos serve as reminders for our staff to integrate anti-corruption practices into their daily operations, equipping them with the knowledge and awareness needed to identify and prevent potential corruption risks. We also send periodic written reminders to our business partners and suppliers regarding our policy of not accepting any advantages.

The Group actively encourages employees to report any illegal, irregular, unethical, or inappropriate acts or behaviours that may harm the Group's interests. We ensure that there are adequate protections in place for whistleblowers, and all reports received are promptly and impartially investigated by the management team at the appropriate level. We have implemented a whistleblowing policy that outlines the guidelines for reporting any irregularities discovered in the workplace.

During the year, the Group did not find any significant corruption risks and was not involved in any confirmed corruption cases or corruption-related litigations. Moving forward, the Group will continue to prioritise anti-corruption measures and integrity, enhance oversight on anti-corruption efforts, and broaden external supervision to ensure the Company's healthy growth.

Conflict of Interests

All employees should avoid any situation which may lead to an actual or potential conflict of interests and should make a declaration in writing to the head of the subsidiary or the Group when such a situation arises. Failure to do so may give rise to allegations of favoritism, abuse of authority or even corruption.

The Company has been making continued efforts to incorporate the key elements of sound corporate governance into its management structure and internal control procedures. The Company is committed to maintaining a high standard of corporate governance, upholding a high standard of ethics, transparency, responsibility and integrity in all aspects of business, and ensuring that affairs are conducted in accordance with applicable laws and regulations.

CORPORATE GOVERNANCE PRACTICES

The Company has complied with all the code provisions of the CG Code throughout the Year. The Board had duly performed its duties relating to the corporate governance functions and was not aware of any code provisions of the CG Code being violated during the Year.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code as its code of conduct regarding securities transactions by the Directors. All Directors have confirmed, after a specific enquiry made by the Company, that they have fully complied with the required standard set out in the Model Code throughout the Year.

BOARD OF DIRECTORS

The Board is responsible for the management of the Company on behalf of the Shareholders. Key responsibilities include formulation of the Group's overall strategies, setting of management targets and supervision of management performance. To enable independent advice accessible by the Board, a Director has a material conflict of interest in relation to a transaction or proposal to be considered by the Board, such Director is required to declare such interest and abstain from voting, but is still able to express his/her opinion. The matter is considered at a Board meeting and voted on by the Directors who have no material interest in that transaction. Each Director may seek independent professional advice as considered necessary to fulfil his/her responsibilities and in exercising independent judgment when making decisions in furtherance of his/her Directors' duties at the Company's expense. Independent professional advice shall include legal advice and advice of accountants and other professional financial advisers on matters of law, accounting and other regulatory matters. Any advice obtained may be made available to other members of the Board. Each Board Committee should report to the Board on its decisions and recommendations. The Board has reviewed and satisfied with the implementation and effectiveness for the Year of the abovementioned mechanism.

The Board is responsible for the Group's internal control and conducts review on the effectiveness of the internal control of the Group, including financial, operational and compliance controls and risk management functions.

Role of the Board

The Board acknowledges its overall responsibility in ensuring and reviewing the effectiveness of the systems of internal controls, risk management and legal and regulatory compliance of the Group in order to safeguard the interests of Shareholders and the assets of the Group.

Internal Controls and Risk Management Framework

The Board has put in place policies and procedures, including policies for delegation of authority clearly defining the limits of authorities designated to specified positions within the Group. Such policies and procedures set out the framework for the risk management and internal control systems for adoption throughout the Group. To ensure that the systems in place are adequate and address the existing weaknesses in implementation, the Executive Directors, with the assistance of the executive board of different business divisions, review the existing policies and practices and issue directives from time to time to highlight the specific issues and concerns in order to achieve ongoing improvement on the governance practices within the Group. The Executive Directors also approve operational and financial reports, business plans and budgets provided by management of each business division at regular meetings.

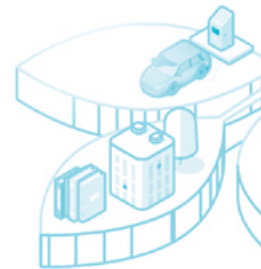

Executive Directors and senior management of the Group are appointed to the boards of all operating subsidiaries and associated companies of material importance in order to monitor the operation of these companies. They attend board meetings and participate in significant decision-making process on reviewing and approving financial budgets, establishing business plans and controlling performance targets with associated risks identified. The management teams of different business divisions are accountable for the performance of their respective divisions on a day-to-day basis. The Executive Directors review the financial and operational reports from division management regularly to monitor the performance and assess the significant risk exposure of the subsidiaries.

The Group's Finance Department reports to the Board in respect of overseeing the financial reporting and control systems for all subsidiaries and associated companies of the Company. The business segments compile annual budgets for review by the Group's finance function and the consolidated annual budgets are presented to the Executive Directors for approval. The Executive Directors also hold regular meetings with the management team of business divisions to review the cashflow position of the Group, consider material ad-hoc projects which require additional operating or capital expenditure, and make decisions on significant investment and lending activities. Payment approval is subject to control of the limits of authorities clearly setting out the authority with reference to the specified positions of the relevant personnel.

Legal and Regulatory Compliance

The Contracts and Legal Department is responsible for preparing, reviewing and endorsing all material contracts entered into by Group companies in order to safeguard the interests of the Group against legal risks. It also oversees the regulatory compliance matters of all Group companies in the environment of their business operations.

Besides, the Company Secretarial Department is in charge of statutory documentation of Group companies and overseeing compliance matters in relation to the Listing Rules and the relevant corporate laws and regulations of different jurisdictions.

External legal advisors are engaged to advise the Group on important legal matters and compliance issues when necessary.

Audit Committee and Internal Audit Function

The Company has established an internal audit function. The internal audit function conducts internal audit on different business divisions and functions within the Group on an ongoing basis to assess the effectiveness and identify weaknesses in the existing internal control, legal and regulatory compliance and risk management systems of the Group. In the event that defects are identified, the internal audit function engages in discussions with the management and recommends suggestions for improvement.

Delegated by the Board, the Audit Committee reviews the internal audit report prepared by the internal audit function twice every year. Reviews have been conducted on the Group's internal control and risk management systems during the Year and the Board and the Audit Committee are satisfied that the Group's risk management and internal control systems are effective and adequate.

Whilst these policies and procedures are designed to manage the risks that could adversely impact the ability of the Group to achieve its business objectives, they do not eliminate such risks and can only provide reasonable but not absolute assurance against material misstatement, loss or non-compliance.

Handling of Inside Information

The Group has adopted a policy in relation to handling of inside information in compliance with the SFO. Employees should preserve the confidentiality of any inside information according to the manner specified in the policy and the "Code of Employee Conduct and Business Ethics" contained in the Staff Handbook. The Group has also adopted the pre-clearance procedures on dealing in the Company's securities and notified Directors and relevant employees of restrictions on dealing in the Company's securities during blackout periods to prevent possible mishandling of inside information within the Group.

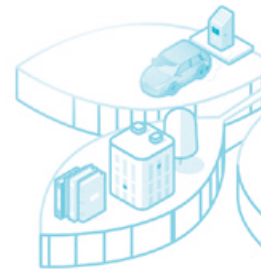

SHAREHOLDERS' RIGHTS

Procedures for Requisitioning a Special General Meeting

Pursuant to the Bye-laws, Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company have rights to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition, which must be signed by the requisitionist(s). The requisition must be deposited at the registered office of the Company at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda (the "Registered Office") for the attention of the Company Secretary. To ensure that the requisition is received by the Company at the earliest opportunity, a copy of the signed requisition should also be deposited at the head office of the Company in Hong Kong at 27/F, Tower A, 83 King Lam Street, Cheung Sha Wan, Kowloon, Hong Kong (the "Head Office") for the attention of the Company Secretary.

Procedures for Putting Forward Proposals at General Meetings

Pursuant to the Companies Act 1981 of Bermuda (the "Companies Act"), Shareholders holding at the date of deposit of the requisition not less than one-twentieth of the total voting right at general meetings of the Company or not less than one hundred Shareholders may provide a written requisition to the Company stating the resolution intended to be proceeded at the general meeting. The requisition must be deposited at the Registered Office for the attention of the Company Secretary. To ensure that the requisition is received by the Company at the earliest opportunity, a copy of the signed requisition should also be deposited at the Head Office for the attention of the Company Secretary.

As regards proposing a person for election as a director of the Company by Shareholders, Shareholders may refer to the procedures available on the Company's website.

Shareholders can also refer to the detailed requirements and procedures as set forth in the relevant sections of the Companies Act and the Bye-laws when making any requisitions or proposals for transaction at the general meetings of the Company.

INVESTOR RELATIONS

The Group uses several formal channels to ensure fair disclosure and comprehensive and transparent reporting of its performance and activities. The Company's annual and interim reports and circulars are printed and sent to all Shareholders. Moreover, announcements, circulars, publications and press releases of the Company are published on the Company's website. 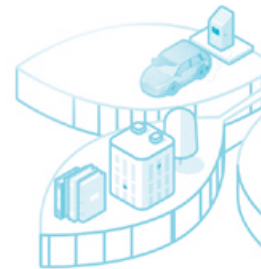

Subject to the Bye-laws and the statutory requirements, the Company shall maintain a sustainable and steady profit distribution policy. Under the Dividend Policy, the Board targets to pay dividends to the Shareholders in an aggregate annual amount of approximately 30% of the annual consolidated net profit attributable to the Shareholders.

The Board has the sole discretion to recommend/not to recommend final dividend to the Shareholders for approval and to declare/not to declare any other dividend, including but not limited to interim dividend and/or special dividends, after taking into consideration the factors as stated above.

The Group is committed to upholding high standards of business integrity, honesty and transparency in all business dealings. 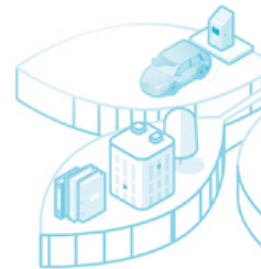

The Board hereby presents the annual report and the audited consolidated financial statements of the Group for the Year.

PRINCIPAL ACTIVITIES

The Company is an investment holding company. Its subsidiaries are principally engaged in civil engineering, electrical and mechanical engineering, foundation and building construction work, property development and assets leasing, professional services (including provision of security, tunnel management, property management and other facility management services), non-franchised bus services and manufacturing of PET radiopharmaceuticals.

RESULTS AND APPROPRIATIONS

The results of the Group for the Year are set out in the consolidated statement of profit or loss and other comprehensive income on pages 166 and 167.

FINANCIAL SUMMARY

A financial summary of the Group for the last five financial years is set out on page 318.

FINAL DIVIDEND

The Board has approved and adopted a Dividend Policy. Depending on the financial conditions of the Group and the conditions and factors as set out in the Dividend Policy, dividends may be proposed and/or declared by the Board during a financial year and any final dividend for a financial year will be subject to the Shareholders' approval. Details of the Dividend Policy have been disclosed in the Corporate Governance Report of this annual report.

The Board has recommended the payment of a final dividend of HK1.27 cents per share for the Year (the "Final Dividend") (2024/25: Nil), amounting to approximately HK\$23.46 million (2024/25: Nil), to the Shareholders whose names appear on the register of members of the Company on 31 August 2026. The proposed Final Dividend will be paid on 14 September 2026 subject to approval by the Shareholders at the forthcoming annual general meeting (the "AGM"). Together with the interim dividend of HK0.83 cent per share paid in January 2026, the proposed Final Dividend will result in a full-year dividend of HK2.10 cents per share for the Year (2024/25: Nil).

ARRANGEMENT TO PURCHASE SHARES OR DEBENTURES

To enable the employees to have a stake in the investment in the Group, the Group in December 2020 had separately entered into the sale and purchase agreement (the "Subsidiary SPA") with two directors (one of which is Ir Dr. Pang Yat Bond, Derrick, the Executive Director and Chief Executive Officer of the Company) and certain employees of a subsidiary (the "Relevant Subsidiary") (collectively, the "Relevant Staff") for disposal of certain shares by 5 equal tranches over vesting period of 4 to 8 years (the "Relevant Interest") of the Relevant Subsidiary to the Relevant Staff. Upon the fulfillment of certain performance conditions under the Subsidiary SPA, Ir Dr. Pang Yat Bond, Derrick shall acquire a total of 3.5% equity interest in the Relevant Subsidiary at a total consideration of approximately HK\$1.7 million (the "Stake Investment").

As of 31 March 2026, the Relevant Subsidiary did not fulfill the performance condition for the first, second and third vesting periods ended 31 March 2024, 31 March 2025 and 31 March 2026, respectively, therefore all three tranches of Relevant Interest were lapsed.

Other than the Share Option Scheme, the Share Award Scheme and the Stake Investment disclosed above, at no time during the Year and at the end of the Year was the Company or any of its holding companies, subsidiaries or fellow subsidiaries a party to any arrangements to enable the Directors to acquire benefits by means of acquisition of shares in, or debentures of, the Company or any other body corporate.

CONTINUING DISCLOSURE REQUIREMENTS UNDER RULE 13.21 OF CHAPTER 13 OF THE LISTING RULES

On 28 November 2025, the Group, as borrower, entered into a facility agreement (the "Facility Agreement") for a 3-year term loan and revolving credit facilities with a greenshoe option of up to HK\$1.8 billion (the "Facility") with a syndicate of major commercial banks in Hong Kong, as the lenders (the "Lenders"). Pursuant to the terms of the Facility Agreement, the final maturity date is 36 months from the date of the Facility Agreement.

It will be an event of default under the Facility Agreement (unless waived by the Lenders) if (a) Mr. Pang Yat Ting, Dominic, Madam Li Wai Hang, Christina, Ir Dr. Pang Yat Bond, Derrick and GT Winners Limited collectively maintain less than 51% direct or indirect beneficial ownership interest in the Company; or (b) Mr. Pang Yat Ting, Dominic ceases to be the Chairman of the Board; or (c) Ir Dr. Pang Yat Bond, Derrick ceases to be the Chief Executive Officer of the Company; or (d) Mr. Pang Yat Ting, Dominic and Ir Dr. Pang Yat Bond, Derrick cease to jointly have management control of the Company, throughout the life of the Facility.

Upon occurrence of aforesaid event of default, the Lenders may declare that all or part of the loans, together with accrued interest, and all other amounts accrued or outstanding under the Facility Agreement be immediately due and payable. Further details of the Facility were set out in the Company's announcement dated 28 November 2025.

As at the date of this report, Mr. Pang Yat Ting, Dominic, Madam Li Wai Hang, Christina, Ir Dr. Pang Yat Bond, Derrick and GT Winners Limited collectively own approximately 55.93% of the issued share capital of the Company and there is no change in the Company's management control since the date of the Facility Agreement.

於2025年11月28日，本集團（作為借款人）（「借款人」）與一個由多間香港大型商業銀行組成之銀團（作為貸款人）（「貸款人」）訂立一份融資協議（「融資協議」），內容有關一項附有綠鞋機制之3年期定期貸款及循環信貸融資，總額最多為1,800,000,000港元（「融資」）。根據融資協議之條款，最後到期日為融資協議日期起計36個月。

根據融資協議之條款，如（除非獲貸款人豁免）發生下列任何情況，即構成融資協議項下之違約事件：(a)彭一庭先生、李蕙嫻女士、彭一邦博士工程師及GT Winners Limited共同直接或間接持有本公司之實益權益少於51%；或(b)彭一庭先生不再擔任董事局主席；或(c)彭一邦博士工程師不再擔任本公司行政總裁；或(d)彭一庭先生及彭一邦博士工程師不再共同擁有本公司之管理控制權，而上述情況於融資年期內持續存在。

倘發生上述違約事件，貸款人有權宣佈全部或部分貸款連同應計利息以及融資協議項下所有其他應計或尚未償還款項即時到期並須予支付。有關該融資之進一步詳情已載於本公司日期為2025年11月28日之公告。

於本報告日期，彭一庭先生、李蕙嫻女士、彭一邦博士工程師及GT Winners Limited合共持有本公司已發行股本約55.93%，且自訂立融資協議日期以來，本公司之管理控制權並無變動。

PROFIT TARGETS IN RELATION TO THE ACQUISITION

On 21 February 2024, the Group completed the acquisition of a controlling stake in Modern Living. Pursuant to the sale and purchase agreement dated 26 January 2024, the consideration for the acquisition comprises an initial consideration and deferred consideration. The deferred consideration will be payable in stages if Modern Living achieves an audited net profit after tax of not less than HK\$15,000,000 for each of the financial years ending 31 December 2024, 31 December 2025 and 31 December 2026 (the "Profit Target(s)"). Details of the Profit Targets and the terms of the acquisition are set out in the Company's announcements dated 31 January 2024 and 21 February 2024. The Profit Targets for the years ended 31 December 2024 and 31 December 2025 have been met.

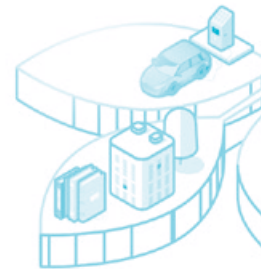

PROFIT GUARANTEE IN RELATION TO THE ACQUISITION

On 20 December 2024, the Group completed the acquisition of a 51% equity interest in Manbond Supply Chain (HK) Company Limited ("Manbond"). Pursuant to the sale and purchase agreement dated 2 December 2024, the consideration for the acquisition was satisfied by the allotment and issue of consideration shares by the Company. The vendor has guaranteed to the Group that the actual net profit after taxation generated by Manbond for the guarantee period from 1 January 2025 to 31 December 2027 shall not be less than RMB45,000,000 in aggregate, and the actual net profit after taxation for each financial year shall not be less than RMB10,000,000 (the "Profit Guarantee"). If the Profit Guarantee cannot be achieved, the Group is entitled to terminate the sale and purchase agreement, and repurchase the consideration shares at nil consideration, and in return, transfer the shares of Manbond back to the vendor at nil consideration. Details of the Profit Guarantee and the terms of the acquisition are set out in the Company's announcements dated 3 December 2024, 13 December 2024 and 20 December 2024. The Profit Guarantee for the year ended 31 December 2025 has been achieved.

DIRECTORS' INTERESTS IN COMPETING BUSINESSES

Mr. Wu William Wai Leung, the INED, is an independent non-executive director of JY Grandmark Holdings Limited, which had certain subsidiaries engaged in the property development business. The Board is of the view that Mr. Wu as an independent non-executive director of JY Grandmark Holdings Limited, is not involved in its daily operation and therefore it does not compete with the business of the Group.

Mr. Ho Gilbert Chi Hang, the INED, is an executive director of CTFs, which had certain subsidiaries engaged in the construction business. The Board is of the view that the construction business of the Company is similar to but in different scale and nature with that of the Group and therefore it does not compete with the business of the Group.

Each of the Directors is aware of his/her fiduciary duties as Director and will act in the interests of the Company and the Shareholders as a whole and avoids any conflict of interests between his/her duties as a Director and his/her personal interests.

Save as disclosed above, none of the Directors were interested in any business which competes or was likely to compete, either directly or indirectly, with the Group's business.

本集團於2024年12月20日完成收購萬邦供應鏈(香港)有限公司(「萬邦」)51%股權。根據於2024年12月2日訂立的買賣協議,該收購的代價以本公司配發及發行代價股份方式支付。賣方已向本集團保證萬邦於2025年1月1日至2027年12月31日之保證期內產生之實際除稅後淨溢利合共將不少於人民幣45,000,000元,及於保證期內每一財政年度之實際除稅後淨溢利將不少於人民幣10,000,000元(「溢利保證」)。倘無法達成溢利保證,本集團有權終止買賣協議,及無償購回代價股份,並將萬邦股份無償重新轉讓予賣方。有關溢利保證及收購條款的詳情載於本公司於2024年12月3日、2024年12月13日及2024年12月20日刊發的公告。截至2025年12月31日止年度的溢利保證已達成。

董事於競爭業務中之權益

獨立非執行董事胡偉亮先生為景業名邦集團控股有限公司之獨立非執行董事,而景業名邦集團控股有限公司若干附屬公司從事物業發展業務。董事局認為胡先生作為景業名邦集團控股有限公司之獨立非執行董事,並無參與其日常營運,故因此與本集團的業務不構成競爭。

獨立非執行董事何智恒先生為周大福創建之執行董事,其若干附屬公司從事建築業務。董事局認為該公司之建築業務與本集團相似但規模及性質不同,並因此與本集團的業務不構成競爭。

各董事均知悉其作為董事的誠信責任,並將以本公司及股東整體利益為依歸行事及避免作為董事之職責與其個人利益產生任何利益衝突。

除上文所披露者外,概無董事於與本集團業務直接或間接構成或可能構成競爭的任何業務中擁有權益。

MAJOR CUSTOMERS AND SUPPLIERS

For the Year, the aggregate amount of turnover attributable to the Group's five largest customers accounted for approximately 82% of the Group's total turnover and the turnover attributable to the Group's largest customer accounted for approximately 76% of the Group's total turnover. The aggregate amount of purchases attributable to the Group's five largest suppliers accounted for less than 30% of the Group's total purchases.

The Group's five largest customers include governmental authorities and statutory organisations, infrastructure and property developers and property owners. The credit terms granted to these customers are in line with those granted to other customers as well as industry practices. The Group's management has considered the credit quality of these major customers and is of the view that none of the relevant trade receivables is considered doubtful. In determining the credit terms, the Group takes into account various factors, including the background, financial strength and track records of credit settlement of the counterparties, in order to mitigate credit risks. In view of the financial strength and high credit rating the major customers, the Directors consider that the Group's exposure to concentration of credit risk is limited.

None of the Directors, their associates or any Shareholders (which to the knowledge of the Directors own more than 5% of the Company's issued Shares (excluding treasury shares)) had any interest in any of the Group's five largest customers or suppliers.

DONATIONS

During the Year, the Group made charitable and other donations totalling approximately HK\$2.3 million.

EVENTS AFTER THE REPORTING PERIOD

Details of the events of the Group after the reporting period are set out in Note 49 to the financial statements.

AUDITOR

The consolidated financial statements for the Year were audited by EY, the auditor of the Company, which will retire at the conclusion of the AGM and, being eligible, offer themselves for re-appointment. A resolution will be proposed to the Shareholders at the AGM to re-appoint EY as the auditor of the Company and to authorise the Board to fix their remuneration.

There was no change in the auditor of the Company in the preceding three years.

OPINION

We have audited the consolidated financial statements of Asia Allied Infrastructure Holdings Limited (the "Company") and its subsidiaries (the "Group") set out on pages 166 to 317, which comprise the consolidated statement of financial position as at 31 March 2026, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2026, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with HKFRS Accounting Standards as issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

We have fulfilled the responsibilities described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report, including in relation to these matters. Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the consolidated financial statements. The results of our audit procedures, including the procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying consolidated financial statements.

Recognition of revenue and contract assets for construction contracts

The Group's revenue from the provision of construction work amounted to approximately HK\$8.36 billion for the year ended 31 March 2026 and contract assets from construction work as at 31 March 2026 amounted to approximately HK\$3.80 billion.

Contract revenue is recognised over time, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced.

The recognition of revenue relies on management's estimate of the final outcome of each contract, which involves the exercise of significant management judgement, particularly in determining the value of contract variations, claims and liquidated damages, in estimating the amount of expected losses and assessing the ability of the Group to deliver services according to the agreed timetable.

關鍵審核事項

關鍵審核事項為根據我們的專業判斷認為對本期間的綜合財務報表審核中最重要的事項。這些事項是在對綜合財務報表整體進行審計並形成意見的背景下來進行處理的，我們不對這些事項提供單獨的意見。我們對下述每一事項在審計中是如何應對的描述也以此為背景。

我們已履行本報告核數師就審核綜合財務報表須承擔的責任一節所述的責任，包括與此等事項相關之責任。據此，我們的審核工作包括執行為應對綜合財務報表進行重大錯誤陳述風險評估而設計的程序。審核程序（包括為處理下列事項而進行的程序）的結果為我們就隨附綜合財務報表發表審核意見提供了基礎。

建築合約的收益及合約資產之確認

截至2026年3月31日止年度，貴集團提供建築工程的收益約為8,360,000,000港元，而於2026年3月31日的建築工程之合約資產約為3,800,000,000港元。

因為貴集團的履約創造或增加了客戶所控制的資產，合約收益隨時間推移就資產被創造或增加而確認。

收益的確認依賴管理層對各合約最終結果的估計，有關估計涉及行使重大管理判斷，尤其是決定合約所修改、索償及延期賠償之價值、估計預期虧損金額及評估貴集團根據協定時間表交付服務的能力。

Recognition of revenue and contract assets for construction contracts (Continued)

In addition, the Group regularly assesses the possible outcome of construction contracts based on the latest facts and circumstances relating to the construction work, and past experience in conducting similar construction work. When there is a change in the expectation as to when the outcome of construction contracts can be estimated reliably, the Group will adjust the amounts of contract revenue and contract assets accordingly. Such change constitutes a change in an accounting estimate and involves significant management estimation and judgement regarding the outcome of a contract. The effect of any change in an accounting estimate is recognised prospectively by including it in profit or loss in the current year and future periods, if appropriate.

Given that the estimation of construction revenue involves significant management judgement and estimation, we considered this a key audit matter.

Related disclosures are included in notes 3.3, 4, 6 and 23(a) to the consolidated financial statements.

How our audit addressed the key audit matter

As part of our audit procedures, we understood, evaluated and tested the internal controls of the Group in respect of recognition of revenue and contract assets for construction work. We examined the surveys of work for amounts of contract revenue recognised and revenue cutoff. We selected material construction contracts, read their financial budgets and interviewed the Group's quantity surveyors regarding the preparation and approval processes of financial budgets of construction contracts and variation orders and the progress of work certification by independent surveyors on a sampling basis. In addition, we read the correspondence between the Group and independent surveyors. We also assessed the adequacy of the related disclosures in the notes to the consolidated financial statements.

此外，貴集團根據有關建築工程之最近期事實及情況，以及開展類似建築工程之過往經驗，定期評估建築合約之可能結果。當預測到建築合約之結果會出現變動及能夠可靠估計時，貴集團將相應調整合約收益及合約資產。該變動構成會計估計之變動，並涉及管理層對合約結果的重大估計及判斷。於本年度及未來期間，會計估計之任何變動的影響會預期確認並計入損益（如適用）。

鑒於建築收益的估計涉及重大的管理層判斷及估計，我們認為此項為關鍵審核事項。

相關披露載於綜合財務報表附註3.3、4、6及23(a)。

於審核中處理關鍵審核事項的方法

作為審核程序的一部分，我們了解、評估及測試貴集團關於就建築工程的收益及合約資產之確認的內部控制。我們檢查就已確認合約收益及截止收益的測量工作。我們挑選了重大建築合約，閱讀其財務預算，並就建築合約及變更訂單的財務預算編製及審批流程以及獨立測量師的工程進度證書事宜抽樣採訪貴集團的工料測量師。此外，我們閱讀了貴集團與獨立測量師的通信。我們亦已評估綜合財務報表附註所載相關披露的充足性。

1. CORPORATE AND GROUP INFORMATION

Asia Allied Infrastructure Holdings Limited is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda, and the principal place of business of the Company is located at 27/F, Tower A, 83 King Lam Street, Cheung Sha Wan, Kowloon, Hong Kong.

During the year, the Company and its subsidiaries (collectively, the “Group”), joint operations, joint ventures and associates were involved in the following principal activities:

- provision of construction and consultancy services in areas of civil engineering, electrical and mechanical engineering, foundation and building construction mainly in Hong Kong;
- development and sale of properties and leasing of assets in Hong Kong, mainland (“Mainland China”) of the People’s Republic of China (the “PRC”) and the United Arab Emirates (the “UAE”);
- provision of security, tunnel management, property management and other facility management services in Hong Kong;
- provision of non-franchised bus services in Hong Kong; and
- production and sale of positron emission tomography (“PET”) radiopharmaceuticals for medical use in Hong Kong.

Particulars of the Company’s principal subsidiaries, joint operations, joint ventures and associates are set out in notes 45, 46, 47 and 48 to the financial statements, respectively.

At 31 March 2026, in the opinion of the directors of the Company (the “Directors”), the immediate holding company and the ultimate holding company of the Company is GT Winners Limited (“GT Winners”), which is a company incorporated in the British Virgin Islands (the “BVI”) with limited liability.

1. 公司及集團資料

亞洲聯合基建控股有限公司於百慕達註冊成立為一間受豁免之有限公司，其股份在香港聯合交易所有限公司（「聯交所」）主板上市。本公司之註冊辦事處位於Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda，而本公司之主要營業地點位於香港九龍長沙灣瓊林街83號A座27樓。

於本年度內，本公司及其附屬公司（統稱「本集團」）、合營業務、合營公司及聯營公司涉及下列主要業務：

- 主要在香港提供就土木工程、機電工程、地基及樓宇建築方面之工程及諮詢服務；
- 在香港、中華人民共和國（「中國」）內地（「中國內地」）及阿拉伯聯合酋長國（「阿聯酋」）進行發展及出售物業以及資產租賃；
- 在香港提供保安、隧道管理、物業管理及其他設施管理服務；
- 在香港提供非專營巴士服務；及
- 在香港生產及銷售正電子發射斷層掃描（「正電子掃描」）放射性藥物以作醫療用途。

本公司之主要附屬公司、合營業務、合營公司及聯營公司詳情分別載於財務報表附註45、46、47及48。

於2026年3月31日，本公司董事（「董事」）認為本公司之直接控股公司及最終控股公司為GT Winners Limited（「GT Winners」），其為於英屬處女群島（「英屬處女群島」）註冊成立之有限公司。

2. BASIS OF PREPARATION

These financial statements have been prepared in accordance with HKFRS Accounting Standards (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) as issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention except for investment in an insurance contract, financial assets at fair value through profit or loss and contingent consideration payable for the acquisition of subsidiaries which have been measured at fair value, as further explained in note 3.3 to the financial statements. These financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand ("HK\$'000") except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 March 2026. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e. existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control.

2. 編製基準

此等財務報表乃根據香港會計師公會（「香港會計師公會」）頒佈之香港財務報告準則會計準則（包括所有香港財務報告準則、香港會計準則（「香港會計準則」）及詮釋）及香港公司條例之披露規定而編製。財務報表乃按歷史成本基準編製，惟於一項保險合約之投資、按公平值計入損益之金融資產及收購附屬公司之應付或然代價按公平值計量（更多詳情載於財務報表附註3.3）除外。此等財務報表以港元呈列，除非另有說明，所有數值均四捨五入至最接近千位（「千港元」）。

綜合基準

綜合財務報表包括本公司及其附屬公司截至2026年3月31日止年度之財務報表。附屬公司為一間由本公司直接或間接控制之實體（包括結構性實體）。當本集團對參與投資對象業務的多項回報承擔風險或享有權利以及能透過對投資對象的權力（即本集團獲賦予現有權力以主導投資對象相關活動的既存權利）影響該等回報時，即取得控制權。

一般情況下，可推定多數投票權形成控制權。

When the Company has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

Profit or loss and each component of other comprehensive income are attributed to the shareholders of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises the related assets (including goodwill), liabilities, any non-controlling interest and the exchange fluctuation reserve; and recognises the fair value of any investment retained and any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

附屬公司的財務報表乃就本公司之相同報告期編製。附屬公司之業績乃由本集團獲取控制權之日開始作綜合計算，並繼續綜合入賬直至失去有關控制權之日為止。倘出現任何不相符之會計政策，即會作出調整加以修正。

損益及其他全面收益各組成部分乃歸屬於本公司股東及非控股權益，即使此舉引致非控股權益出現虧絀結餘。有關本集團成員公司間交易資產及負債、權益、收入、開支及現金流量均於綜合賬目時全數抵銷。

倘有事實及情況顯示上文所述三個控制因素中有一個或以上出現變動，則本集團將重新評估是否仍控制投資對象。附屬公司之擁有權權益變動（並無喪失控制權）作為權益交易入賬。

倘本集團失去對附屬公司之控制權，則取消確認相關資產（包括商譽）、負債、任何非控股權益及外匯波動儲備；及確認所保留任何投資之公平值及損益中任何因此產生之盈餘或虧絀。先前於其他全面收益內確認之本集團應佔部分重新分類至損益或保留溢利（如適用），所依據之基準與倘本集團直接出售相關資產或負債所需依據者相同。

3.1 CHANGES IN ACCOUNTING POLICIES AND DISCLOSURES

The Group has adopted amendments to HKAS 21 *Lack of Exchangeability* for the first time for the current year's financial statements. The Group has not early adopted any other standard or amendment that has been issued but is not yet effective.

Amendments to HKAS 21 specify how an entity shall assess whether a currency is exchangeable into another currency and how it shall estimate a spot exchange rate at a measurement date when exchangeability is lacking. The amendments require disclosures of information that enable users of financial statements to understand the impact of a currency not being exchangeable. As the currencies that the Group had transacted in and the functional currencies of overseas subsidiaries, branches, joint ventures and associates for translation into the Group's presentation currency were exchangeable, the amendments did not have any impact on the Group's financial statements.

In addition, the HKICPA has issued amendments to Illustrative Examples on HKFRS 7, HKFRS 18, HKAS 1, HKAS 8, HKAS 36 and HKAS 37 *Disclosures about Uncertainties in the Financial Statements*, which added illustrative examples in the corresponding HKFRS Accounting Standards. These examples reflect existing requirements in the corresponding HKFRS Accounting Standards to report the effects of uncertainties in the financial statements using climate-related examples. Therefore, the amendments do not have an effective date or transitional provisions. The Group has considered the guidance in these illustrative examples and the amendments did not have any impact on the Group's financial statements.

Save as disclosed above, the accounting policies used in preparing the consolidated financial statements are consistent with those of the annual consolidated financial statements for the year ended 31 March 2025.

3.1 會計政策變動及披露

香港會計準則第21號之修訂訂明實體應如何評估某種貨幣是否可兌換為另一種貨幣，以及在缺乏可兌換性的情況下，實體應如何估算於計量日期的即期匯率。該等修訂要求披露資料以讓財務報表使用者了解貨幣不可兌換的影響。由於本集團交易的貨幣及境外附屬公司、分公司、合營公司及聯營公司換算為本集團呈列貨幣的功能貨幣均可兌換，故該等修訂對本集團之財務報表並無任何影響。

此外，香港會計師公會已發佈香港財務報告準則第7號、香港財務報告準則第18號、香港會計準則第1號、香港會計準則第8號、香港會計準則第36號及香港會計準則第37號財務報表中的不確定性披露的範例之修訂，其在相應的香港財務報告準則會計準則中增添了範例。該等範例反映相應香港財務報告準則會計準則中的現有規定，即運用氣候相關範例報告財務報表中不確定性的影響。因此，該等修訂並無生效日期或過渡性條文。本集團已考慮該等範例中的指引，且該等修訂對本集團的財務報表並無產生任何影響。

除上文披露者外，編製綜合財務報表所採用的會計政策與截至2025年3月31日止年度的年度綜合財務報表所採用者一致。

Further information about those applicable HKFRS Accounting Standards that are expected to be applicable to the Group is described below:

- (a) HKFRS 18 replaces HKAS 1 *Presentation of Financial Statements*. While a number of sections have been brought forward from HKAS 1 with limited changes, HKFRS 18 introduces new requirements for presentation within the statement of profit or loss, including specified totals and subtotals. Entities are required to classify all income and expenses within the statement of profit or loss into one of the five categories: operating, investing, financing, income taxes and discontinued operations and to present two new defined subtotals. It also requires disclosures about management-defined performance measures in a single note and introduces enhanced requirements on the grouping (aggregation and disaggregation) and the location of information in both the primary financial statements and the notes. Some requirements previously included in HKAS 1 are moved to HKAS 8 *Accounting Policies, Changes in Accounting Estimates and Errors*, which is renamed as HKAS 8 *Basis of Preparation of Financial Statements*. As a consequence of the issuance of HKFRS 18, limited, but widely applicable, amendments are made to HKAS 7 *Statement of Cash Flows*, HKAS 33 *Earnings per Share* and HKAS 34 *Interim Financial Reporting*. In addition, there are minor consequential amendments to other HKFRS Accounting Standards. HKFRS 18 and the consequential amendments to other HKFRS Accounting Standards are effective for annual periods beginning on or after 1 January 2027 with earlier application permitted. Retrospective application is required. The Group is currently analysing the new requirements and assessing the impact of HKFRS 18 on the presentation and disclosure of the Group's financial statements.

- (b) HKFRS 19 allows eligible entities to elect to apply reduced disclosure requirements while still applying the recognition, measurement and presentation requirements in other HKFRS Accounting Standards. To be eligible, at the end of the reporting period, an entity must be a subsidiary as defined in HKFRS 10 *Consolidated Financial Statements*, cannot have public accountability and must have a parent (ultimate or intermediate) that prepares consolidated financial statements available for public use which comply with HKFRS Accounting Standards or IFRS Accounting Standards. HKFRS 19 was amended in April 2025 to include IFRS Accounting Standards in the eligibility criteria for applying the standard. The standard was further amended in October 2025 to (i) remove disclosure objectives from HKFRS 19; (ii) reduce the disclosure requirements relating to supplier finance arrangements and a specific class of financial liabilities; and (iii) replace disclosure requirements relating to management-defined performance measures with a cross-reference to HKFRS 18 for entities that use these measures. Earlier application is permitted. As the Company is a listed company, it is not eligible to elect to apply HKFRS 19 and its amendments. Some of the Company's subsidiaries are considering the application of HKFRS 19 and its amendments in their specified financial statements.

- (d) Amendments to HKFRS 9 and HKFRS 7 *Contracts Referencing Nature-dependent Electricity* clarify the application of the “own-use” requirements for in-scope contracts and amend the designation requirements for a hedged item in a cash flow hedging relationship for in-scope contracts. The amendments also include additional disclosures that enable users of financial statements to understand the effects these contracts have on an entity’s financial performance and future cash flows. The amendments relating to the own-use exception shall be applied retrospectively. Prior periods are not required to be restated and can only be restated without the use of hindsight. The amendments relating to the hedge accounting shall be applied prospectively to new hedging relationships designated on or after the date of the initial application. Earlier application is permitted. The amendments to HKFRS 9 and HKFRS 7 shall be applied at the same time. Investments in joint ventures and associates

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

The Group's investments in joint ventures and associates are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

The Group's share of the post-acquisition results and other comprehensive income of joint ventures and associates is included in the consolidated profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the joint ventures or associates, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint ventures or associates are eliminated to the extent of the Group's investments in the joint ventures or associates, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of joint ventures or associates is included as part of the Group's investments in joint ventures or associates.

If an investment in a joint venture becomes an investment in an associate or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of joint control over the joint venture or significant influence over the associate, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the joint ventures or associates upon loss of joint control or significant influence and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

合營公司指一種合營安排，對該安排擁有共同控制權之訂約方據此對合營公司之資產淨值擁有權利。共同控制指按照合約協定對一項安排所應佔之控制權，共同控制僅在有關活動要求享有控制權之訂約方作出一致同意之決定時存在。

聯營公司為本集團擁有一般不少於20%股份投票權之長期權益，並可對其發揮重大影響力之實體。重大影響力為參與投資對象之財務及營運政策決定之權力，而非控制或共同控制該等政策。

本集團於合營公司及聯營公司之投資乃按權益會計法，以本集團應佔之資產淨值減任何減值虧損計算，並於綜合財務狀況表列賬。倘出現任何不相符之會計政策，即會作出調整加以修正。

本集團應佔合營公司及聯營公司於收購後之業績及其他全面收益分別於綜合損益及綜合其他全面收益內列賬。此外，倘直接於合營公司或聯營公司之權益確認變動，本集團會於綜合股東權益變動表確認其應佔之任何變動（如適用）。本集團與其合營公司或聯營公司之交易所產生之未變現收益及虧損會以本集團於合營公司或聯營公司之投資為限抵銷，惟未變現虧損證明所轉讓資產出現減值則除外。收購合營公司或聯營公司所產生之商譽乃計入作為本集團於合營公司或聯營公司之投資之一部分。

倘於合營公司之投資成為於聯營公司之投資或反之亦然，則不會重新計量保留權益。反之，該投資繼續根據權益法入賬。在所有其他情況下，於失去合營公司共同控制權或聯營公司之重大影響力時，本集團會按公平值計量及確認任何保留投資。於失去共同控制權或重大影響力時合營公司或聯營公司之賬面值與保留投資公平值之任何差異及出售所得款項乃在損益內確認。

Interests in joint operations

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the arrangement.

Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control. The Group recognises in relation to its interest in a joint operation:

- its assets, including its share of any assets held jointly;
- its liabilities, including its share of any liabilities incurred jointly;
- its revenue from the sale of its share of the output arising from the joint operation;
- its share of the revenue from the sale of the output by the joint operation; and
- its expenses, including its share of any expenses incurred jointly.

The assets, liabilities, revenues and expenses relating to the Group's interest in a joint operation are accounted for in accordance with the HKFRS Accounting Standards applicable to the particular assets, liabilities, revenues and expenses.

Related parties

A party is considered to be related to the Group if:

- (a) the party is a person or a close member of that person's family and that person
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group;

or

- (b) the party is an entity where any of the following conditions applies:
 - (i) the entity and the Group are members of the same group;
 - (ii) one entity is an associate or joint venture of the other entity (or of a holding company, subsidiary or fellow subsidiary of the other entity);
 - (iii) the entity and the Group are joint ventures of the same third party;
 - (iv) one entity is a joint venture of a third entity and the other entity is an associate of the third entity;

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group and liabilities assumed by the Group to the former owners of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

業務合併及商譽

業務合併乃採用收購法入賬。轉讓代價乃以收購日期的公平值計量，該公平值為本集團轉讓的資產於收購日期的公平值及本集團向被收購方前擁有人承擔的負債。於各業務合併中，本集團選擇是否以公平值或於被收購方可識別淨資產的應佔比例，計量於被收購方的非控股權益。非控股權益的所有其他組成部分均按公平值計量。收購相關成本於產生時列為開支。

當所收購的一組活動及資產包含共同對創造產出的能力作出重大貢獻的一項投入及一項實質性程序時，本集團釐定其已收購一項業務。

當本集團收購一項業務時，會根據合約條款、收購日期之經濟環境及相關條件對所承擔的金融資產及負債進行評估，以作出適當的分類及確認，包括將嵌入式衍生工具與被收購方主合約分開。

如業務合併分階段進行，先前持有的股本權益按其於收購日期的公平值重新計量，所產生的任何損益在損益內確認。

收購方將轉讓的任何或然代價按收購日期的公平值確認。分類為資產或負債的或然代價按公平值計量，其公平值變動於損益內確認。分類為權益的或然代價不重新計量，其後的結算在權益中入賬。

商譽按成本進行首次計量，即已轉讓代價、非控股權益之確認金額及本集團先前所持於被收購方之股本權益公平值總額超出所收購可識別資產淨值及所承擔負債之差額。倘總代價及其他項目之總和低於所收購資產淨值之公平值，於重估後之差額會於損益內確認為議價購買時之收益。

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its investment properties and financial assets at fair value through profit or loss at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

首次確認後，商譽按成本減累計減值虧損計量。商譽每年就減值進行測試，倘有事件或情況變化顯示賬面值可能出現減值跡象，則進行更為頻密之檢討。本集團會於3月31日進行商譽年度減值測試。進行就減值測試而言，業務合併中購入之商譽由收購日期起，被分配到預期將從合併之協同效應中受益之本集團各現金產生單位（或現金產生單位組別），不論本集團之其他資產或負債是否被分配至該等單位或單位組別。

減值按對與商譽有關之現金產生單位（現金產生單位組別）可收回金額進行之評估釐定。倘現金產生單位（現金產生單位組別）之可收回金額少於其賬面值，則確認減值虧損。就商譽確認之減值虧損不會於後續期間撥回。

當商譽被分配至現金產生單位（或現金產生單位組別）而出售該單位之某部分業務，則於釐定出售業務之收益或虧損時，與出售業務相關之商譽將包括在該業務之賬面值內。在此情況下出售之商譽將以出售業務和保留之現金產生單位部分相對價值為基礎作計量。

公平值計量

本集團於各報告期末按公平值計量投資物業及按公平值計入損益之金融資產。公平值為市場參與者於計量日期在有序交易中出售資產將會收取或轉讓負債將會支付之價格。公平值計量乃根據假設出售資產或轉讓負債之交易在資產或負債之主要市場或（在無主要市場之情況下）在資產或負債之最具優勢市場進行而作出。主要或最具優勢市場必須為本集團可進入之市場。資產或負債之公平值乃按假設市場參與者於資產或負債定價時會以最佳經濟利益行事計量。

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost less accumulated depreciation and any accumulated impairment losses.

The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation of buildings are calculated on the straight-line basis to write off their costs over the shorter of the lease terms and their useful lives of 25 years.

Depreciation of other property, plant and equipment is calculated on the reducing balance basis to write off the cost of each item of other property, plant and equipment to its estimated residual value over its estimated useful life. The estimated depreciation rates per annum of different categories of other property, plant and equipment are as follows:

Buildings	Over the shorter of the lease terms and useful life of 25 years
Plant and machinery	15% to 25%
Furniture, fixtures and equipment	15%
Motor vehicles	10% to 25%

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation methods are reviewed, and adjusted if appropriate, at least at each financial year end.

物業、機器及設備乃按其成本值扣去累計折舊及任何累計減值虧損後列賬。

一項物業、機器及設備之成本包括其購入價以及令該資產達至其生產狀況及位置以作其擬定用途時任何直接有關之應佔成本。物業、機器及設備項目運作後產生之開支，例如維修及保養支出等，一般將於其產生期間內在損益中扣除。在確認條件獲達成之情況下，主要檢查之支出乃計入資產賬面值之成本賬項內作為替代。倘物業、機器及設備之主要部分須不時更換，則本集團確認該等部分為具有特定可使用年期之獨立資產，並作出相應折舊。

樓宇之折舊按直線法計算，以於租期及其可使用年期25年中的較短者為準撇銷其成本。

其他物業、機器及設備之折舊乃按遞減餘額基準於估計餘下可使用年期撇銷各個其他物業、機器及設備項目之成本值至其估計剩餘價值。其他物業、機器及設備不同類別之年度估計折舊率如下：

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the period the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Investment properties

Investment properties are interests in land and buildings (including right-of-use-assets) held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including the direct costs of construction, capitalised borrowing costs on related borrowed funds during the period of construction and transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in profit or loss in the period in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in profit or loss in the period of the retirement or disposal.

For a transfer from investment properties to owner-occupied properties, the deemed cost of a property for subsequent accounting is its fair value at the date of change in use.

一項物業、機器及設備包括任何重大部分之首次確認於出售時或當預期其使用或出售再無未來經濟利益時取消確認。於資產取消確認之期間於損益內確認之出售或廢棄所得任何之收益或虧損為有關資產之出售所得淨額與賬面值間之差額。

投資物業

投資物業指持有以賺取租金收入及／或作資本增值用途之土地及樓宇權益（包括使用權資產）。有關物業首次按成本（包括直接建築成本、於建設期間相關借款資金之資本化借款成本以及交易成本）計量。於首次確認後，投資物業按反映報告期末市況之公平值列賬。

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on the straight-line basis over the lease terms and is included in revenue or other income in profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

本集團作為出租人

本集團作為出租人時，其於租賃開始時（或於租賃修訂時）將其各項租賃分類為經營租賃或融資租賃。

本集團並無轉讓資產擁有權所附之絕大部分風險及回報之租賃分類為經營租賃。倘合約包含租賃及非租賃部分，本集團根據相對獨立售價將合約代價分配至各部分。租金收入於租期內按直線法入賬並根據其經營性質於損益內列為收益或其他收入。於磋商及安排經營租賃時產生之初步直接成本乃計入租賃資產之賬面值，並於租期內按相同方法確認為租金收入。或然租金乃於賺取期間內確認為收益。

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any accumulated impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received.

Right-of-use assets in respect of leasehold land are depreciated on the straight-line basis over the shorter of the lease terms and their useful lives of 50 years. Other right-of-use assets are depreciated on the reducing balance basis over the following deprecation periods, which are the shorter of the lease terms and the estimated useful lives of the assets:

If ownership of the leased asset is transferred to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

When the right-of-use assets relate to interests in leasehold land held as inventories, they are subsequently measured at the lower of cost and net realisable value in accordance with the Group's policy for "Land held for property development, properties under development and properties held for sale".

When a right-of-use asset meets the definition of investment property, it is included in investment properties. The corresponding right-of-use asset is initially measured at cost, and subsequently measured at fair value, in accordance with the Group's policy for "Investment properties".

The Group's right-of-use assets are separately presented on the face of the consolidated statement of financial position.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses the interest rate implicit in the lease or, where that rate cannot be readily determined, the Group uses its incremental borrowing rate at the lease commencement date. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g. a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group's lease liabilities are separately presented on the face of the consolidated statement of financial position.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of plant and machinery and office equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that are considered to be of low value. Lease payments on short-term leases and leases of low-value assets are recognised as an expense on the straight-line basis over the lease term.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

Patent

Purchased patent is stated at cost less any impairment losses and is amortised on the straight-line basis over its estimated useful lives of 7 years.

(c) 短期租賃及低價值資產租賃

本集團就其機器及設備以及辦公室設備之短期租賃(即由開始日期起計租期為12個月或以下且不包含購買選擇權之該等租賃)應用短期租賃確認豁免。其亦就被認為具有低價值之辦公室設備租賃應用低價值資產租賃確認豁免。短期租賃及低價值資產租賃之租賃付款在租期內按直線法確認為開支。

無形資產(商譽除外)

單獨收購之無形資產於首次確認時按成本計量。於業務合併中收購之無形資產成本指於收購日期之公平值。無形資產之可使用年期被評估為有限或無限。具有有限年期之無形資產其後於可使用經濟年期內攤銷，且於有跡象表明該無形資產可能出現減值時進行減值評估。具有有限可使用年期之無形資產之攤銷期及攤銷方法最少於各財政年度結束時檢討。

具無限可使用年期之無形資產每年個別地或按現金產生單位級別進行減值測試。該等無形資產不予攤銷。具無限年期之無形資產之可使用年期每年進行檢討，以釐定無限年期之評估是否繼續有理據支持。如否，則將可使用年期之評估由無限至有限之變動按前瞻性基準入賬。

專利

購買的專利按成本減任何減值虧損呈列，並按直線法於其估計可使用年限7年內攤銷。

Land held for property development, properties under development and properties held for sale

Land held for property development and properties under development are intended to be held for sale after completion of the property development. They are classified as current assets unless the construction period of the relevant property development project is expected to complete beyond the normal operating cycle. On completion, the properties are transferred to properties held for sale.

Land held for property development, properties under development and properties held for sale are stated at the lower of cost and net realisable value. Cost includes prepaid land lease payments, cost of land/land use rights together with any other direct costs attributable to the development of the properties, and borrowing costs capitalised during the development period. Net realisable value is determined by reference to estimated selling price based on prevailing market conditions less (i) anticipated cost to completion of the development in respect of properties under development; and (ii) estimated costs to be incurred in marketing and selling the properties.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for non-financial asset is required (other than investment properties, land held for property development, properties under development, properties held for sale, deferred tax assets and contract assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g. a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

持作物業發展之土地、發展中物業及持作銷售物業

持作物業發展之土地及發展中物業擬於完成物業發展後持作銷售。彼等分類為流動資產，除非相關物業發展項目之建築期間預期於一般營運週期以後完成。完成時，物業轉撥至持作銷售物業。

持作物業發展之土地、發展中物業及持作銷售物業按成本及可變現淨值之較低者列賬。成本包括土地租賃預付款項及土地／土地使用權成本，連同任何其他物業發展應佔直接成本及於發展期間資本化之借款成本。可變現淨值乃參考基於現行市況之估計售價釐定，當中扣減：(i)完成開發有關發展中物業之預期成本；及(ii)營銷及銷售物業產生之估計成本。

非金融資產減值

倘有跡象顯示出現減值，或需要就非金融資產（投資物業、持作物業發展之土地、發展中物業、持作銷售物業、遞延稅項資產及合約資產除外）進行年度減值測試，則會估計資產之可收回數額。資產之可收回數額乃資產或現金產生單位之使用價值及其公平值（以較高者為準）減出售成本，並就個別資產而釐定，除非有關資產並無產生很大程度上獨立於其他資產或資產組別所產生之現金流入，在此情況下，可收回數額則就資產所屬之現金產生單位而釐定。對現金產生單位進行減值測試時，企業資產（如總部樓宇）賬面值的一部分如果能夠按合理和一貫的基準分配至現金產生單位組別（甚或其最小組別），則分配至個別現金產生單位。

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of a non-financial asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior periods. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, or fair value through profit or loss, as appropriate.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 *Revenue from Contracts with Customers* in accordance with the policies set out for "Revenue recognition" below.

於各報告期末，會就有否跡象顯示先前已確認之減值虧損可能不再存在或可能減少而作出評估。倘出現該跡象，則估計可收回數額。就非金融資產（商譽除外）先前已確認之減值虧損僅於釐定該資產之可收回數額所使用之估計出現變動時方予撥回，惟在假設於過往期間並無就該資產確認減值虧損，高出於此情況下所釐定之賬面值之數額（扣除任何折舊／攤銷）則不予撥回。減值虧損之撥回乃於產生期間計入損益。

投資及其他金融資產

首次確認及計量

金融資產於首次確認時分類，其後於適當時按攤銷成本或公平值計入損益（如適用）。

金融資產於首次確認時之分類視乎金融資產之合約現金流量特徵以及本集團管理該等金融資產之業務模式而定。除貿易應收款項不包含重大融資成分或本集團已應用不調整重大融資成分影響之可行的權宜方法外，本集團初步按公平值另加交易成本（倘金融資產不按公平值計入損益）計量金融資產。並無重大融資成分或本集團已應用可行的權宜方法之貿易應收款項，乃根據下文「收益確認」所載政策按香港財務報告準則第15號來自客戶合約之收益所釐定之交易價格計量。

Initial recognition and measurement (Continued)

In order for a financial asset (debt instrument) to be classified and measured at amortised cost, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets (debt instruments) with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets (debt instruments) refers to how it manages its financial assets (debt instruments) in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets (debt instruments), or both. Financial assets (debt instruments) classified and measured at amortised cost are held within a business model with the objective to hold financial assets (debt instruments) in order to collect contractual cash flows, while financial assets (debt instruments) classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets (debt instruments) which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

A derivative embedded within a hybrid contract containing a financial asset host is not accounted for separately. The financial asset host together with the embedded derivative is required to be classified in its entirety as a financial asset at fair value through profit or loss.

Purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset.

為使金融資產(債務工具)按攤銷成本進行分類及計量,其需要產生純粹為支付本金及未償還本金之利息(「純粹支付本金及利息」)之現金流量。就現金流量並非純粹支付本金及利息之金融資產(債務工具)而言,不論其業務模式如何,均按公平值計入損益分類及計量。

本集團管理金融資產(債務工具)之業務模式指其管理金融資產(債務工具)以產生現金流量之方法。業務模式可確定現金流量是否來自收集合約現金流量、出售金融資產(債務工具)或兩者兼而有之。按攤銷成本分類及計量之金融資產(債務工具)按旨在收取合約現金流量而持有金融資產(債務工具)之業務模式持有,而按公平值計入其他全面收益分類及計量之金融資產(債務工具)按旨在收取合約現金流量及出售而持有之業務模式持有。並非按上述業務模式持有之金融資產(債務工具)按公平值計入損益分類及計量。

嵌入混合合約(包含金融資產主體)的衍生工具不作單獨列賬。金融資產主體連同嵌入式衍生工具須整體分類為按公平值計入損益之金融資產。

購買或銷售乃指須按照市場一般規定或慣例於一定期間內交付資產之購買或銷售金融資產,該等購買或銷售於交易日期確認,交易日期即本集團購買或銷售資產當日。

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

(a) *Financial assets at amortised cost (debt instruments)*

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

(b) *Financial assets at fair value through profit or loss*

Financial assets at fair value through profit or loss are carried in the consolidated statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes debt instruments with cash flows that are not SPPI and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on the equity investments are also recognised as other income in profit or loss when the right of payment has been established.

Impairment

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

金融資產之其後計量視乎彼等以下之分類而定：

(a) *按攤銷成本計量之金融資產 (債務工具)*

按攤銷成本計量之金融資產其後採用實際利率法計量，並可能會出現減值。當資產被取消確認、修改或出現減值時，收益及虧損乃於損益內確認。

(b) *按公平值計入損益之金融資產*

按公平值計入損益之金融資產於綜合財務狀況表以公平值列值，並於損益內確認公平值淨額變動。

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

一般方法

預期信貸虧損分兩個階段確認。就首次確認以來信貸風險並無大幅增加的信貸風險而言，會為未來12個月可能發生的違約事件所產生的信貸虧損（12個月預期信貸虧損）作出預期信貸虧損撥備。就首次確認以來信貸風險大幅增加的信貸風險而言，須就預期於風險的餘下年期產生的信貸虧損作出虧損撥備，而不論違約的時間（全期預期信貸虧損）。

於各報告日期，本集團會評估自首次確認以來金融工具的信貸風險是否已大幅增加。在進行評估時，本集團會將於報告日期金融工具發生的違約風險與於首次確認日期金融工具發生的違約風險進行比較，並考慮無須花費過多成本或精力即可獲得的合理及可支持的資料（包括過往資料及前瞻性資料）。

本集團認為，當合約付款逾期超過30天，則信貸風險大幅增加。

當合約付款逾期90天時，本集團認為金融資產違約。然而，在若干情況下，當內部或外部資料表明本集團在計及本集團所持有的任何信貸提升措施之前不大可能完全收到未償還合約款項時，本集團亦可能認為金融資產違約。倘並無合理預期可收回合約現金流量，金融資產將被撇賬。

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

Stage 1 — Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 — Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Stage 3 — Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e. removed from the consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset, or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a “pass-through” arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the assets. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred assets to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Financial liabilities

Initial recognition and measurement

Financial liabilities are all classified, at initial recognition, as financial liabilities at amortised cost, which are recognised initially at fair value and net of directly attributable transaction costs.

Subsequent measurement

After initial recognition, financial liabilities at amortised cost are subsequently measured at amortised cost, using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included as finance costs in profit or loss.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Investments and other financial assets – Impairment"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

首次確認後，按攤銷成本計量之金融負債其後採用實際利率法按攤銷成本計量；倘若貼現之影響並不重大，則按成本列賬。收益及虧損於負債取消確認時及透過實際利率攤銷過程在損益內確認。

攤銷成本計及收購之任何折讓或溢價後計算，並包括屬實際利率組成部分之費用或成本。實際利率攤銷計入損益中之融資成本內。

取消確認

一項金融負債於負債項下之責任獲解除或取消或屆滿時取消確認。

當一項現有金融負債獲同一貸款人以大致不相同條款之另一負債所取代，或一項現有負債之條款經大幅修訂，該項交換或修訂應被視為原負債之取消確認及一項新負債之確認，而有關賬面值間之差額乃於損益內確認。

財務擔保合約

本集團作出的財務擔保合約即要求發行人作出特定付款以償付持有人因特定債務人未能根據債務工具的條款償還到期款項而招致損失的合約。財務擔保合約首次按其公平值確認為一項負債，並就作出該擔保直接產生的交易成本作出調整。於首次確認後，本集團按如下的較高者計量財務擔保合約：(i)根據「投資及其他金融資產－減值」所載政策釐定之預期信貸虧損撥備；及(ii)首次確認金額減(如適用)已確認累計收入金額。

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the consolidated statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Shares held under a share award scheme

Own equity instruments which are reacquired from the market and held by the Company or the Group (treasury shares) under the share award scheme of the Company are recognised directly in equity at cost. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Group's own equity instruments.

Upon exercise of share awards, the related costs of the vested awarded shares repurchased from the market and shares acquired from reinvesting dividends received on the awarded shares are credited to the shares held under the share award scheme account, with a corresponding decrease in the share-based compensation reserve for the awarded shares.

For vesting of forfeited or unallocated shares regranted, the related costs of the forfeited or unallocated shares regranted are credited to the shares held under the share award scheme account, and the related fair value of the shares regranted are debited to the share-based compensation reserve. The difference between the cost and the fair value of the shares regranted is credited to the share premium account if the fair value is higher than the cost or debited against retained profits if the fair value is less than the cost.

Cash and cash equivalents

Cash and cash equivalent in the statement of financial position comprise cash on hand and at bank, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value, and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

倘目前存在可執行之法律權力抵銷已確認金額，且計劃以淨額基準結算或同時變現資產及償付負債，方會抵銷金融資產及金融負債並在綜合財務狀況表內呈報有關淨額。

根據股份獎勵計劃持有的股份

由本公司或本集團根據本公司股份獎勵計劃在市場上重新購入及持有的自身股本工具（庫存股份）乃按成本直接於權益中扣除。並無購回、出售、發行或註銷本集團自身股本工具的收益或虧損於損益內確認。

行使股份獎勵後，從市場上購回的已歸屬獎勵股份及就獎勵股份所收取股息的再投資中收購的股份的相關成本，記入根據股份獎勵計劃賬目下持有的股份，而股份報酬儲備已就獎勵股份相應減少。

就重新授出的已沒收或未分配股份的歸屬而言，重新授出的已沒收或未分配股份的相關成本記入根據股份獎勵計劃賬目下持有的股份，而重新授出股份的相關公平值於股份報酬儲備內扣除。倘重新授出股份的公平值高於成本，則其成本與公平值的差額記入股份溢價賬，而倘公平值低於成本，兩者之差額於保留溢利中扣除。

現金及與現金等值項目

財務狀況表內的現金及與現金等值項目包括手持及銀行現金，以及可隨時轉換為可知數額現金、價值改變風險不大的短期高流動性存款，該等存款一般於三個月內到期，乃為應付短期現金承擔而持有。

就綜合現金流量表而言，現金及與現金等值項目包括手持及銀行現金，以及上文所界定的短期存款，減須按要求償還並構成本集團現金管理組成部分的銀行透支。

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included as finance costs in profit or loss.

A contingent liability recognised in a business combination is initially measured at its fair value. Subsequently, it is measured at the higher of (i) the amount that would be recognised in accordance with the general policy for provisions above; and (ii) the amount initially recognised less, when appropriate, the amount of income recognised in accordance with the policy for revenue recognition.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes, except that deferred tax is not recognised for the Pillar Two income taxes.

撥備

倘貼現之影響屬重大時,所確認之撥備金額為預期須支付有關責任之未來支出於報告期末之現值。因時間流逝而導致貼現值增加之金額,乃計入損益表內融資成本中。

於業務合併中,或然負債首次按公平值計量。其後,其按以下較高者計量:(i)根據上述普遍撥備政策應予確認之金額;及(ii)已首次確認之金額減(如適用)根據收益確認政策確認之收入金額。

所得稅

所得稅包括即期稅項及遞延稅項。與在損益以外確認項目有關之所得稅乃在損益以外確認,即在其他全面收益或直接在股本中確認。

即期稅項資產及負債乃根據於報告期末前已頒佈或實際已頒佈之稅率(及稅務法例),並經考慮本集團經營業務所在國家之現行詮釋及慣例後,按預期可向稅務機關收回或支付予稅務機關之數額計算。

遞延稅項就於報告期末資產及負債之稅項基準及其於財務申報中之賬面值之所有暫時性差額以負債法作出撥備,惟不就支柱二所得稅確認遞延稅項。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries, joint operations, joint ventures and associates, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

Revenue from contracts with customers (Continued)

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

(a) Construction work

Revenue from construction work is recognised over time, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced.

Revenue from construction work is recognised by reference to the progress towards complete satisfactory of that performance obligation. The progress towards complete satisfactory of the performance obligation is measured based on methods that best depicts the Group's performance in satisfying the performance obligation either direct measurements of the value of services delivered or the Group's efforts or inputs to the satisfaction of the performance obligation relative to the total expected efforts or inputs.

Claims to customers are amounts that the Group seeks to collect from the customers as reimbursement of costs and margins for scope of works not included in the original construction contract. Claims are accounted for as variable consideration and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved. The Group uses the most likely amount method to estimate the amounts of claims because this method best predicts the amount of variable consideration to which the Group will be entitled.

當合約包含融資部分，其在將貨品或服務轉移至客戶方面為客戶提供重大融資利益超過一年時，收益會按以本集團與客戶於合約開始時進行的個別融資交易所反映貼現率貼現的應收款項現值計量。當合約包含融資部分，為本集團提供重大財務利益超過一年時，會根據該合約確認的收益包括按實際利率法計算合約負債產生的利息開支。就客戶付款與承諾貨品或服務轉移之間的時間間隔期限為一年或以內之合約而言，交易價格不會根據香港財務報告準則第15號所提供之可行的權宜方法就重大融資部分之影響作出調整。

(a) 建築工程

由於本集團之履約行為會創造或增加了客戶在資產創造或增加了所控制之資產，故建築工程之收益隨時間而確認。

建築工程之收益乃參照完成該履約責任的進度而確認。完成履約責任的進度乃基於最能描述本集團履行履約責任之情況的方法而計量，即直接計量所提供之服務的價值或本集團為履行履約責任所做的努力或投入。

向客戶提出之索償乃本集團尋求向客戶收取之金額，作為原建築合約以外工程範圍之成本及利潤之補償款項。索償乃作為可變代價列賬並受到約束，直至與可變代價相關之不明朗因素其後得以解決，已確認累計收益很可能不會發生重大收益撥回為止。本集團使用最可能金額法估計索償金額，乃由於此方法最能預測本集團將有權獲得之可變代價金額。

- (b) *Rendering of construction-related consultancy services*
Revenue from the rendering of construction-related consultancy services is recognised over time upon the completion of performance obligations.
- (c) *Sale of goods*
Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer.
- (d) *Rendering of security, tunnel management, property management and other facility management services*
Revenue from the rendering of services is recognised over the scheduled period on the straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

Revenue from other sources

- (a) *Rental income*
Rental income is recognised on the straight-line basis over the lease terms.
- (b) *Interest income*
Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.
- (c) *Dividend income*
Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.
- (d) *Guarantee income*
Guarantee income is recognised on the straight-line basis over the guarantee period.

Contract assets

If the Group performs by transferring goods or services to a customer before being unconditionally entitled to the consideration under the contract terms, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets. They are reclassified to trade receivables when the right to the consideration becomes unconditional.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e. transfers control of the related goods or services to the customer).

Contract costs

Costs to fulfil a contract

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify;
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future; and
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

倘本集團通過於有權無條件根據合約條款收取代價前將貨品或服務轉移至客戶來履約，則會就所賺取之有條件代價確認合約資產。合約資產須進行減值評估，其詳情載於金融資產減值之會計政策。該等合約資產會於代價成為無條件時重新分類為貿易應收款項。

合約負債

於本集團轉讓相關貨品或服務前收到客戶付款或付款到期（以較早者為準）時則確認合約負債。合約負債於本集團履行合約（即向客戶轉移相關貨品或服務之控制權）時確認為收益。

合約成本

履行合約之成本

除作為存貨、物業、機器及設備及無形資產撥充資本之成本外，倘符合以下所有條件，則履行與客戶訂立之合約所產生之成本會作為一項資產撥充資本：

Costs to obtain a contract

Incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with customer that it would not have incurred if the contract had not been obtained. Incremental costs of obtaining a contract are capitalised when incurred if the costs relate to revenue which will be recognised in a future reporting period and the costs are expected to be recovered. The incremental costs of obtaining a contract are charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other costs of obtaining a contract are expensed when incurred.

Share-based payments

Share award scheme

The Group operates a share award scheme for the purposes of providing incentives for employees to achieve performance goals and aligning the interests of employees directly with those of the shareholders of the Company through ownership of shares of the Company.

The amount to be expensed as share-based compensation expenses is determined by reference to the fair value of the share awards granted, taking into account all non-vesting conditions associated with the grants. The total expense is recognised over the relevant vesting periods (or on the grant date if the shares vest immediately), with a corresponding credit to the share-based compensation reserve under equity.

For those share awards which are amortised over the vesting periods, the Group revises its estimates of the number of awarded shares that are expected to ultimately vest based on the vesting conditions at the end of each reporting period. Any resulting adjustment to the cumulative fair value recognised in prior years is recognised in profit or loss in the current year, with a corresponding adjustment to the share-based compensation reserve.

獲得合約的成本增加部分是本集團與客戶訂立合約所產生的成本，倘未能獲得合約，則不會產生該等成本。倘成本與收益相關（將於未來報告期確認）且預計可收回成本，則以獲得合約的成本增長部分於產生時予以撥充資本。獲得合約的成本增加部分按系統基準計入損益內，其符合向客戶轉移與資產相關之貨品或服務。獲得合約的其他成本於產生時計入費用。

以股份為基礎付款

股份獎勵計劃

本集團實行股份獎勵計劃，以向僱員提供達到表現目標的激勵及令僱員利益透過擁有本公司股份直接與本公司股東利益一致的目標。

作為以股份為基礎支付的酬金開支所支銷的金額乃經參考所授出股份獎勵的公平值並計及所有與授出相關的非授予條件而釐定。總開支於有關歸屬期內（或倘股份即時歸屬，則於授出當日）確認，並相應記入權益項下之股份報酬儲備。

就於歸屬期攤銷的股份獎勵而言，本集團於各報告期末修訂其預期最終會根據歸屬條件歸屬的獎勵股份數目的估計數目。因而對過往年度確認的累計公平值的任何調整於本年度損益中確認，並對股份報酬儲備作出相應調整。

Share option scheme

The Company operates a share option scheme. Employees (including directors of the Company) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial option pricing model, further details of which are given in note 35 to the financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

購股權計劃

本公司執行購股權計劃。本集團之僱員(包括本公司董事)以股份為基礎付款方式獲取報酬,而僱員提供之服務則作為股本工具之代價(「股本結算交易」)。

授予僱員之股本結算交易之成本,乃參考授予該股份日期之公平值計算。公平值乃由外部估值師使用二項式購股權定價模式釐定,進一步詳情於財務報表附註35披露。

就股本結算交易之成本,連同相應之股本增加,乃按業績表現及／或服務之條件獲履行之期間在僱員福利開支內確認入賬。就股本結算交易於各報告期末確認直至生效日期為止之累計開支,反映生效期之屆滿及本集團就最終將予生效之股本工具數目作出之最佳估計予以確認。在某一期間之損益扣除或計入之數額,為該期間之期初及期末確認之累計開支之變動。

釐定獎勵獲授當日之公平值時,並不計及服務及非市場績效條件,惟在有可能符合條件的情況下,則評估為本集團對最終將會賦予股本工具數目最佳估計之一部分,市場績效條件反映於獎勵獲授當日之公平值。獎勵之任何其他附帶條件(但不帶有服務要求)視作非賦予條件。非賦予條件反映於獎勵之公平值,除非同時具服務及／或績效條件,否則獎勵即時開銷。

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

Upon exercise of share options, the resulting shares issued are recorded by the Company as additional share capital at the nominal value of the shares, and the excess of the exercise price per share over the nominal value of the shares is recorded by the Company in the share premium account. In addition, at the time when the share options are exercised, the amount previously recognised in the share-based compensation reserve will be transferred to the share premium account.

Share options which are cancelled prior to their exercise date or lapse are deleted from the register of outstanding options. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in the share-based compensation reserve will be transferred to retained profits as a movement in reserves.

The dilutive effect of outstanding share options is reflected as additional share dilution in the computation of earnings per share.

由於非市場績效及／或服務條件未達成而最終並無生效之獎勵不會確認為開支。倘獎勵包括一項市場或非歸屬條件，則有關交易視作歸屬，而無論有關市場或非歸屬條件是否已達成，惟所有其他績效及／或服務條件已達成。

倘股本結算獎勵之條款經修訂，所確認之開支須最少達到猶如條款未經修訂之水平（如已達到獎勵之原本條款）。此外，倘按修訂日期計算，任何修訂將使以股份為基礎付款之公平值總額增加，或對僱員帶來其他利益，則應就修訂確認開支。

倘股本結算獎勵被註銷，應被視為已於註銷日期生效，並即時確認獎勵之任何尚未確認開支。此包括於本集團或僱員控制範圍內非生效條件未獲達成之任何獎勵。然而，倘一新獎勵替代已註銷之獎勵，且於授予日期指定為替代獎勵，則如前段所述，已註銷及新獎勵均應被視為原獎勵之修訂。

Other share-based payment transactions

Certain employees of the Group received remuneration in the form of a share-based payment provided by the Group, whereby the employees agreed to render services for a three-year period to the Group in exchange for acquiring a certain percentage of equity interest in a subsidiary of the Group at a below-market price (the "equity-settled transaction").

The cost of the equity-settled transaction is measured at the fair value of the equity interest of the subsidiary acquired less the consideration paid and payable by the employee. The cost of the equity-settled transaction is recognised as an employee benefit expense, together with a corresponding increase in equity of the subsidiary, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for the equity-settled transaction at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired. The charge to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Other employee benefits

Defined contribution plans

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme in Hong Kong (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

Defined benefit plans

Long service payment

The Group's statutory obligation to pay long service payment is a defined benefit plan. The cost of providing benefits relating to long service payment is determined using the projected unit credit actuarial valuation method. The liability recognised in the consolidated statement of financial position in respect of long service payment is the net obligation, representing the present value of the future long service payment benefits reduced by entitlements from accrued benefits arising from MPF contributions made by the Group.

本集團若干僱員通過本集團提供之以股份為基礎付款之方式收取薪酬，據此，該等僱員同意向本集團提供為期三年的服務，以按低於市場之價格取得本集團一間附屬公司若干百分比之股權（「股本結算交易」）。

股本結算交易之成本按所取得之附屬公司股權之公平值減僱員支付及應付之代價計量。就股本結算交易之成本，連同附屬公司股本之相應增加，乃按績效及／或服務之條件獲履行之期間確認為僱員福利開支。就股本結算交易於各報告期末確認直至歸屬日期為止之累計支出，反映歸屬期屆滿之程度。在某一期間之損益扣除之數額為該期間之期初及期末確認之累計開支之變動。

其他僱員福利

定額供款計劃

本集團根據香港強制性公積金計劃條例於香港執行定額供款強制公積金退休計劃（「強積金計劃」）予合資格參與強積金計劃之僱員。供款乃按參與計劃之僱員獲得之基本薪金之某百分比而作出，並根據強積金計劃之規則於應付時於損益中扣除。強積金計劃之資產與本集團之資產乃分開保存，由獨立管理基金持有。本集團所作之僱主供款於向強積金計劃供款時悉數歸予僱員。

定額福利計劃

長期服務金

本集團支付長期服務金的法定責任為一項定額福利計劃。提供長期服務金相關福利時，成本以預期單位福利精算估值法釐定。綜合財務狀況表內就長期服務金確認的負債為責任淨額，即未來長期服務金福利的現值減去本集團所作強積金供款產生之累計福利權益。

Remeasurements, comprising actuarial gains and losses, and investment returns associated with the MPF employer contributions and other experience adjustments (excluding amounts included in net interest on the net defined benefit liability), are debited or credited to equity in other comprehensive income in the period in which they occur. Remeasurements are not reclassified to profit or loss in subsequent periods.

Past service costs are recognised in profit or loss at the earlier of:

- the date of the plan amendment or curtailment; and
- the date that the Group recognises restructuring-related costs

Net interest is calculated by applying the discount rate to the net defined benefit liability. The Group recognises the following changes in the net defined benefit obligations under “cost of sales” and “administrative expenses” in the consolidated statement of profit or loss by function:

- service costs comprising current service costs, past-service costs, gains and losses on curtailments and non-routine settlements
- net interest expense or income

Borrowing costs

Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e. assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale.

Borrowing costs directly attributable to the activity of a construction contract are included as part of the contract costs.

All other borrowing costs are expensed in the period in which they are incurred.

Dividends

Final dividends are recognised as a liability when they have been approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

These financial statements are presented in Hong Kong dollar, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to the statement of profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on a change in fair value of the item (i.e. translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

股息

末期股息於已獲股東在股東大會上批准時確認為負債。建議末期股息於財務報表附註披露。

由於本公司組織章程大綱及章程細則授予董事派付中期股息的權力，因此同時建議及宣派中期股息。因此，中期股息於建議及宣派時即時確認為負債。

外幣

此等財務報表乃以本公司的功能貨幣港元列報。本集團內每個實體均自行決定其功能貨幣，而每個實體的財務報表所包含的項目均採用該功能貨幣計量。本集團旗下實體所記錄的外幣交易最初以交易當日的各功能貨幣匯率記錄。以外幣計算的貨幣資產及負債按報告期末的功能貨幣匯率換算。貨幣項目結算或換算產生的差額於損益內確認。

結算或換算貨幣項目的差額於損益表確認，惟特定作本集團海外業務投資淨額對沖部分的貨幣項目則除外。此等項目於其他全面收入內確認入賬，直至出售投資淨額為止，此時，累計金額會重新分類至損益表。因該等貨幣項目的匯兌差額錄得的稅項開支及抵免亦於其他全面收入內入賬。

以外幣歷史成本計量的非貨幣項目採用首次交易日期的匯率換算。以外幣公平值計量的非貨幣項目按計量公平值當日的匯率換算。換算按公平值計量的非貨幣項目交易所產生的收益或虧損與確認該項目公平值變動的盈虧的處理方法一致（即於其他全面收益或損益內確認公平值盈虧的項目的換算差額，亦分別於其他全面收益或損益內確認）。

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain subsidiaries, joint venture and associates established in the PRC and overseas are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their profits or losses are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transactions. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in profit or loss.

Any goodwill arising on the acquisition of a foreign operation is treated as an assets of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of certain subsidiaries established in the PRC and overseas are translated into Hong Kong dollars at the exchange rates prevailing at the dates of the cash flows. Frequently recurring cash flows of these subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

於釐定首次確認與預付代價相關之非貨幣資產或非貨幣負債於取消確認時的有關資產、開支或收入之匯率時，首次交易日期為本集團首次確認因預付代價產生之非貨幣資產或非貨幣負債之日期。倘存在多筆預付款項或預收款項，則本集團會釐定每筆預付款項或預收款項之交易日期。

若干於中國及海外成立的附屬公司、合營公司及聯營公司的功能貨幣為港元以外的貨幣。於報告期末，該等實體的資產與負債按報告期末的現行匯率換算為港元，而損益則按近似於交易日期現行匯率換算為港元。所產生的匯兌差額於其他全面收益內確認，並累計計入外匯波動儲備，但倘差額源自非控股權益，則不在此限。於出售海外業務時，與該特定海外業務有關的儲備累計金額於損益確認。

收購海外業務產生的任何商譽被視為海外業務的資產及按收市匯率換算。

就綜合現金流量表而言，若干於中國及海外成立的附屬公司的現金流量乃按現金流量當日的匯率換算為港元。年內該等海外附屬公司頻繁產生的現金流量乃按本年度的加權平均匯率換算為港元。

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

The major judgements, estimates and assumptions that have the most significant effect on the amounts recognised in the financial statements and have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities in the future are set out below:

Construction contracts

Revenue is recognised over the period of the contract by reference to the progress towards completion of that performance obligation. The progress is determined based on direct measurements of the value of services delivered or surveys on the performance or work completed to date or latest available financial budgets of the construction contract with reference to the overall performance of the construction contract, and management's best estimates and judgements. In developing the financial budget of a construction contract, construction revenue is estimated in accordance with the terms set out in the relevant contract. Because of the nature of the construction industry, management will make adjustments, where appropriate, to the amounts of construction revenue based on regular review of contract work progress, costs to complete the contracts, the financial impact of contract variations, claims, potential liquidated damages, and estimated construction revenue.

The Group regularly assesses the possible outcome of construction contracts based on latest facts and circumstances occurred in the construction contracts, and past experience in conducting similar construction work. When there is a change in the expected outcome of construction contracts, the Group will adjust the amounts of contract revenue to be recognised in profit or loss prospectively.

4. 關鍵會計判斷及估計

管理層編製本集團之財務報表時，須作出會影響收益、支出、資產及負債之呈報金額及其隨同披露，以及或然負債披露之判斷、估計及假設。有關假設及估計之不確定因素可導致管理層須就未來受影響之資產或負債賬面值作出重大調整。

對財務報表所確認金額具有極重大影響及導致資產及負債賬面值於未來出現重大調整之重大風險之主要判斷、估計及假設載列如下：

建築合約

收益乃參照完成該履約責任的完成進度於合約期內確認。進度乃基於對所提供服務之價值的直接計量或對迄今為止所完成的履約或工程的測量或參考建築合約之整體表現而獲得的建築合約之最近可得財政預算，以及管理層之最佳估計及判斷而釐定。在得出建築合約之財政預算時，估計建築收益乃根據相關合約所載之條款釐定。由於建築行業之性質使然，管理層將根據定期檢討合約工程進度、完成合約的成本、合約修改、索償、潛在延期賠償之財務影響及估計建築收益對建築收益之金額作出調整（如適用）。

本集團根據建築合約發生之最近期事實及情況以及開展類似建築工程之經驗定期評估建築合約之可能結果。當預測到建築合約之結果會出現變動時，本集團將調整預期於損益內確認之合約收益。

Determining the method to estimate variable consideration and assessing the constraint for construction work

The Group seeks to collect claims from customers as reimbursement of costs and margins for scope of works not included in the original construction contract, which give rise to variable consideration. The Group has determined that the most likely amount method is the appropriate method to use in estimating the variable consideration for claims in construction work, given there is a wide range of possible outcomes which are subject to negotiations with third parties.

Before including any amount of variable consideration in the transaction price, the Group considers whether the amount of variable consideration is constrained by considering its historical experience, current negotiations with customers and the current economic conditions.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the recoverable amount of the cash-generating unit (or group of cash-generating units) to which the goodwill is allocated. Estimating the recoverable amount requires the Group to make an estimate of the expected future cash flows from the cash-generating unit (or group of cash-generating units) and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill carried as an asset in the consolidated statement of financial position as at 31 March 2026 was HK\$218,682,000 (2025: HK\$216,452,000), details of which are set out in note 17 to the financial statements.

4. 關鍵會計判斷及估計 (續)

釐定估算可變代價及評估建築工程限制之方法

本集團會尋求向客戶收取索償款項，作為原建築合約以外工程範圍之成本及利潤之補償款項，因而會產生可變代價。鑑於存在多種需要與第三方磋商之可能結果，故本集團釐定預期價值法乃用於估算建築服務索償可變代價之適當方法。

於將任何數額之可變代價納入交易價格之前，本集團會計及其過往經驗、與客戶之當前磋商情況及當前經濟狀況，考慮可變代價之金額是否受到限制。

商譽減值

本集團每年至少進行一次評估以釐定商譽是否減值。這要求對獲分配商譽之現金產生單位（或現金產生單位組別）之可收回金額進行估計。本集團須評估其現金產生單位（或現金產生單位組別）預期未來現金流量以估計可收回金額，並選擇合適的貼現率作為計算該等現金流量的現值。於2026年3月31日之綜合財務狀況表內列賬為資產之商譽賬面值為218,682,000港元（2025年：216,452,000港元），有關詳情載於財務報表附註17。

Income tax

At 31 March 2026, deferred tax assets of HK\$17,251,000 (2025: HK\$17,251,000) in relation to unused tax losses have been recognised in the consolidated statement of financial position whereas a deferred tax asset has not been recognised in respect of tax losses of HK\$2,036,950,000 (2025: HK\$1,956,907,000) as at 31 March 2026 due to the unpredictability of future profit streams (note 32(a)). The realisability of the deferred tax assets mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future. In cases where the actual future profits generated are less or more than expected, a material reversal or further recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a reversal or recognition takes place.

5. OPERATING SEGMENT INFORMATION

For management purposes, the Group's operating businesses are structured and managed separately according to the nature of their operations and the products and services they provide. Each of the Group's operating segments represents a strategic business unit that offers products and services which are subject to risks and returns that are different from those of the other operating segments.

所得稅

於2026年3月31日，綜合財務狀況表中已確認與未使用稅項虧損有關之遞延稅項資產17,251,000港元（2025年：17,251,000港元），而於2026年3月31日，由於未能預測未來溢利之來源，故並無就2,036,950,000港元（2025年：1,956,907,000港元）之稅項虧損確認為遞延稅項資產（附註32(a)）。變現遞延稅項資產主要視乎日後有否足夠的未來溢利或應課稅暫時性差額而定。倘實際產生之未來溢利少於或多於預期，則可能引致對遞延稅項資產作重大撥回或進一步確認，並於撥回或確認發生期間於損益內確認。

5. 經營分部資料

就管理目的而言，本集團的經營業務乃按其營運性質及所提供產品和服務分開組織及管理。本集團旗下各經營分部均為提供產品和服務的策略業務單位，各產品和服務所承受風險及回報有別於其他經營分部。

The chief operating decision maker of the Group has been identified as the executive directors of the Company and certain senior management (collectively referred to as the “CODM”). For the purpose of performance assessment and resource allocation by the CODM, the Group’s business activities are categorised under the following five reportable operating segments:

- Construction services — provision of construction and consultancy services in areas of civil engineering, electrical and mechanical engineering, foundation and building construction mainly in Hong Kong
- Property development and assets leasing — development and sale of properties, and leasing of assets in Hong Kong, Mainland China and the UAE
- Professional services — provision of security, tunnel management, property management and other facility management services in Hong Kong
- Non-franchised bus services — provision of non-franchised bus services in Hong Kong
- Medical technology and healthcare — production and sale of PET radiopharmaceuticals for medical use in Hong Kong

Segment revenue and results

Segment results represent the profit or loss generated from each segment, net of administrative expenses directly attributable to each segment without allocation of corporate expenses, interest income, non-lease-related finance costs and interest on unallocated lease liabilities. This is the measure reported to the CODM for the purposes of resource allocation and performance assessment.

Note: During the year ended 31 March 2021, the Group has entered into agreements with two directors (one of which is an executive director of the Company) and six employees of a subsidiary (the "Relevant Subsidiary"). Pursuant to the agreements, subject to the fulfillment of certain performance conditions, the directors and employees shall acquire a total of 16.25% equity interest (i.e. 162,500 shares) (the "Relevant Interest") in the Relevant Subsidiary from the Group at a total consideration of HK\$7,865,000 in 5 equal tranches over vesting periods of 4 to 8 years.

The fair value of the Relevant Interest of the Relevant Subsidiary as at the grant date was assessed to be HK\$30,623,000, and therefore the difference between its fair value and the consideration received/receivable, which amounted to HK\$22,758,000, shall be amortised as equity-settled share-based payment expense in profit or loss over the vesting period of 4 to 8 years.

During the year, the amount of the Relevant Subsidiary Interest recognised in profit or loss amounted to HK\$1,357,000 (2025: HK\$2,548,000). There were 2.8% equity interest (i.e. 28,000 shares) of the Relevant Subsidiary amounted to HK\$3,446,000 lapsed during the year ended 31 March 2025.

As at 31 March 2026, the Relevant Subsidiary did not fulfill the performance condition for the 3rd vesting period ended 31 March 2026. Therefore, 1.6% equity interest (i.e. 16,000 shares) (2025: 1.6% equity interest (i.e. 16,000 shares)) of the Relevant Subsidiary was lapsed, and there are amounting HK\$2,758,000 (2025: HK\$2,667,000) equity-settled share-based payment expenses which have been recognised in previous year is being credited to the profit or loss during the year.

As at 31 March 2026, there were 3.2% equity interest (i.e. 32,000 shares) (2025: 4.8% equity shares, i.e. 48,000 shares) available to acquire.

Fair value measurement disclosure

The fair value of the aforementioned equity interest of the subsidiary (an unlisted equity investment) was determined with reference to a valuation performed by Jones Lang LaSalle Corporate Appraisal and Advisory Limited, an independent professionally qualified valuer registered in Hong Kong, using a market-based valuation technique, based on assumptions that are not supported by observable market prices or rates.

The fair value of the aforementioned equity interest of the subsidiary as at the grant date has been determined with reference to a value in use calculation using cash flow projections, which were based on a financial forecast approved by senior management covering a five-year period. A growth rate of 2% is used for the perpetual period and the discount rate of 14.6% applied to the cash flow projections is pre-tax and reflects specific risks relating to the construction material e-procurement business. A marketability discount of 25% is applied to the corresponding equity value of the unlisted equity investment to measure the fair value.

Unless otherwise early terminated by the resolution of the Board, the Share Award Scheme is valid and effective for a period of 10 years from the Adoption Date.

The Share Award Scheme is operated through a trustee which is independent of the Group. The shares to be awarded under the Share Award Scheme will be acquired by the trustee from the open market after the notification and instruction by the Company. The trustee shall not hold more than 10% of the total number of issued Shares of the Company.

All share awards granted on 2 August 2017 were vested on 2 August 2018 and there were no share awards outstanding under the Share Award Scheme as at 31 March 2026 and 2025.

35. SHARE OPTION SCHEME

Pursuant to an ordinary resolution passed on 3 September 2012, the Company has adopted a share option scheme (the “Share Option Scheme”) for the primary purpose of providing eligible personnel with the opportunity to acquire proprietary interests in the Company, which will encourage the grantees of such options to work towards enhancing the value of the Company and its shares for the benefit of the Company and its shareholders as a whole. The Board will set out in the offer the terms on which the option is to be granted. The overall limit on the number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and other share option schemes of the Company (if any) must not exceed 30% of the ordinary shares in issue from time to time (the “Share Option Scheme Limit”). No options will be granted under the Share Option Scheme at any time if such grant will result in the Share Option Scheme Limit being exceeded.

The total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and all other share option schemes of the Company (if any) shall not exceed 10% of the ordinary shares in issue as at the date of approval of the Share Option Scheme (the “Share Option Scheme Mandate Limit”), subject to the refreshment of the Share Option Scheme Mandate Limit. Options which have lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company shall not be counted for the purpose of calculating the Share Option Scheme Mandate Limit.

The total number of shares issued and to be issued upon exercise of the options granted to any eligible personnel (including both exercised and outstanding options) in any 12-month period must not exceed 1% of the shares in issue without prior approval from the shareholders. An offer of the options shall be deemed to have been accepted by way of consideration of HK\$1 payable by the eligible personnel within 30 days from the date of offer.

38. BUSINESS COMBINATIONS

The Group had the following business combinations during the year ended 31 March 2025:

On 2 December 2024, an indirect wholly-owned subsidiary of the Company (the "Purchaser") and Yan Trade (BVI) Holding Limited (the "Vendor"), an independent third party of the Group, entered into a sale and purchase agreement, pursuant to which the Vendor conditionally agreed to sell, and the Purchaser conditionally agreed to purchase, 51% of the total issued share capital of Manbond Supply Chain (HK) Company Limited ("Manbond HK"). The consideration shall be settled by allotment and issuance of 95,007,857 consideration shares of the Company to Yan's Family (BVI) Holdings Limited (the "Designated Entity"), at the issue price of HK\$0.50 per share, amounts to HK\$47,503,928.50. Manbond HK and its subsidiaries (the "Manbond Group") is principally engaged in provision of construction material procurement.

Completion of the acquisition took place on 20 December 2024 and 95,007,857 new shares of the Company were allotted and issued to the Designated Entity in accordance with the terms and conditions of the sale and purchase agreement on completion date. Upon completion, the Company indirectly owns 51% of the issued share capital of Manbond HK and Manbond HK has become a non-wholly owned subsidiary of the Company.

Further details of the acquisition are set out in the announcements of the Company dated 2 December 2024, 13 December 2024 and 20 December 2024.

44. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's financial instruments include trade and other receivables, investment in an insurance contract, financial assets at fair value through profit or loss, balances with joint ventures, associates, other partners of joint operations and non-controlling equity holders of subsidiaries, cash and bank balances, trade and bills payables, other payables and bank borrowings. Details of the financial instruments are disclosed in the respective notes to the financial statements. The risks associated with these financial instruments include market risk (currency risk and interest rate risk), credit risk and liquidity risk. Management manages and monitors these exposures to ensure appropriate measures are implemented in a timely and effective manner. The policies on how to mitigate these risks are set out below:

Market risk

(i) Currency risk

Most of the Group's assets and liabilities are denominated in HK\$ or RMB, which are the same as the functional currencies of the relevant group entities. The Group undertakes certain transactions denominated in foreign currencies, and hence exposures to exchange rate fluctuations arise. The Group does not expect any significant exposure to foreign exchange fluctuations and shall use derivative contracts to hedge against its exposure to currency risk only when it is required. The Group manages its foreign currency risk by closely monitoring the movement of the foreign currency rate.

(ii) Fair value and cash flow interest rate risks

The Group has significant bank borrowings and bank deposits with floating interest rates which are exposed to cash flow interest rate risk. During the year, the Group has not hedged its cash flow and fair value interest rate risks. The Directors consider the Group's exposure to cash flow interest rate risk on the bank deposits is insignificant as most deposits bear variable interest rates which have not significantly fluctuated in recent years.

Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate bank borrowings at the end of the reporting period. The analysis is prepared assuming the amount of liability outstanding at the end of the reporting period was outstanding for the whole year. A 100 (2025: 100) basis point increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 100 (2025: 100) basis points higher/lower and all other variables were held constant, the Group's post-tax profit for the year ended 31 March 2026 would have decreased/increased by approximately HK\$19,700,000 (2025: HK\$26,868,000).

Sensitivity analysis on bank deposits is not presented as the Directors consider that the Group's exposure to interest rate fluctuations on bank deposits is insignificant.

Credit risk

The Group's credit risk is primarily attributable to its debtors and amounts due from other partners of joint operations. The Group is exposed to credit concentration risk as a substantial portion of its trade debtors are generated from a limited number of customers.

At the end of the reporting period, three (2025: two) customers of the Group accounted for approximately 47% (2025: 68%) of the Group's trade receivables. In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. To mitigate credit risk arising from guarantees provided to banks in respect of credit facilities utilised by associates, the Group has delegated a team responsible for assessing credit standing and limits to the guarantees to be made. In addition, management considers the credit risk exposure to financial guarantees provided to property purchasers is limited because the facilities are secured by the properties. In this regard, the Directors consider that the Group's credit risk is significantly reduced.

Except for the above, the Group does not have any significant concentration of credit risk, with exposure spreading over a number of counterparties and customers.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

With respect to credit risk arising from amounts due from joint ventures, associates and other partners of joint operations, the Group's exposure to credit risk arising from default of the counterparty is limited as the counterparty has sufficient net assets to repay its debts and/or a good history of repayment.

本集團之信貸風險主要來自其應收賬項以及合營業務其他夥伴所欠款項。本集團面對信貸集中風險，因為其大部分貿易應收賬項源自少量的客戶。

於報告期末，本集團三名（2025年：兩名）客戶佔本集團之貿易應收款項約47%（2025年：68%）。為減低信貸風險，本集團之管理層已授權一個小組，負責釐定信貸額、批授信貸及執行其他監控程序，以確保採取跟進行動收回逾期債務。為減輕就動用聯營公司信貸融資提供財務擔保而引起的信貸風險，本集團已委派一組人員負責評估信貸狀況及所作擔保之限制。此外，管理層認為，由於融資以物業作為抵押，因此提供予物業買方的財務擔保信貸風險有限。就此而言，董事認為，本集團之信貸風險已大幅減少。

除上文所述者外，本集團並無任何重大集中之信貸風險，該等風險乃分散至多名交易對手及客戶。

由於交易對手為獲國際信貸評級機構評級為高信貸評級之銀行，故流動資金之信貸風險有限。

就合營公司、聯營公司及合營業務其他夥伴所之應收款項產生之信貸風險而言，本集團來自交易對手方違約的信貸風險有限，因為交易對手有足夠的淨資產償還其債務及／或具備良好之還款記錄。

Liquidity risk

In the management of liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. Management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

The Group relies on bank borrowings and equity financing as significant sources of liquidity. Details of which are set out in notes 31 and 33 to the financial statements.

The following tables detail the Group's remaining contractual maturity for its non-derivative financial liabilities based on the agreed repayment terms. The tables have been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders or issue new shares. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 March 2026 and 2025.

Depending on the market conditions and funding arrangements, if at any time, repurchase of the Company's shares will lead to an enhancement of the net asset value per share and/or earnings per share of the Group, the Directors will authorise such transactions.

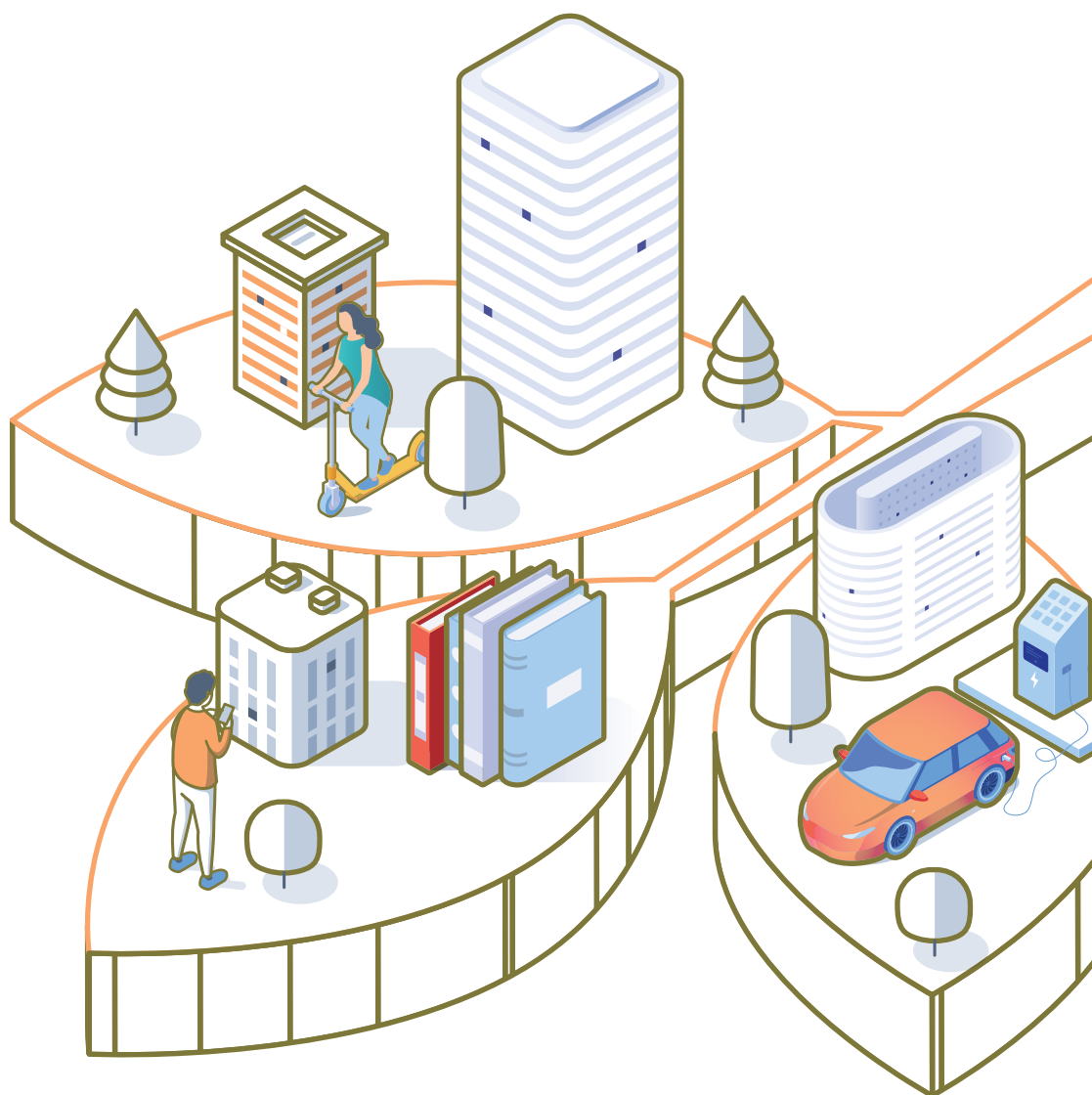
